1. Children under the age of eighteen (18) who I bring to this event must be accompanied by and closely supervised by me during this event;
2. My dog must be licensed and properly immunized to participate in this activity and I am required to provide proof of such license and immunization in order to participate.
3. Despite the efforts of the City of Great Falls to ensure owners have complied, there is a risk that not all dogs present at this event are licensed and vaccinated for rabies as required, which could result in injury to a person or a dog;
4. Puppies under six (6) months, sick dogs, or female dogs in heat are prohibited from participating in this event;
5. I am responsible for my dogs' actions and behavior at all times and must supervise my dog at all times;
6. Despite my best efforts of any dog owner/handler, a dog, including my own, may act in an unpredictable manner;
7. During this event, dogs will be unleashed and loose. Unleashing my dog and being physically present at the above activity involves risks of injury to me, any individual accompanying me, other persons, my dog(s) and other dog(s), including but not limited to, risks resulting from aggressive dogs, unpredictable behavior and lack of proper training;
8. Dogs, even well-behaved ones, can act excited at an event such as this and may not act predictably, causing them to run into, knock down, or bite humans, other dogs and possibly children, or engaging in other activity which can cause injury to myself or other;
9. I accept the risk to myself, my dog, and others, of allowing my dog(s) to interact with people, other dogs, City employees and vehicles in the performance of their duties, and utilize park/pool facilities;
10. I must pay close attention to my dog and properly pick up and dispose of my dog's waste before leaving the park/pool facility;
11. If my dog becomes aggressive, unruly, or plays too roughly, I must leash my dog, leave the park until such time that the dog is under control I and has settled down; if upon returning, my dog repeats the offending behavior, I may be required to remove them from the activity and will not be refunded the admission fee;
12. I will indemnify, defend and hold harmless, the City of Great Falls, Montana, its agents, employees, officers, servants, volunteers and any associates, from and against any and all actions, in law or in equity, from claims for damages, demands, or judgements to any person or property which may result now or in the future from my and/or my dogs' participation in this event. I understand that this waiver includes any claims based on negligence, action or inaction of any of the parties;
13. I expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of State of Montana, and that if any portion thereof is held invalid, it is agrees that the balance shall, notwithstanding, continue in full legal force and effect.
14. I have voluntarily applied to participate and utilize, with my dog(s), the City of Great Falls' facilities for this event.
