Agenda topics:

- Race Montana presented by Ron Ray
 - Mr. Ray presented a request for funding for the upcoming Race Montana Triathlon to take place in Great Falls on August 5, 2012. The Race Montana group did a good job of putting together an "information sheet" that all participants must complete upon picking up there race package, which will assist them with future events.
 - o A motion was made to grant the event \$250, the motion died for lack of a second
 - Discussion: Suggest Race Montana contact the TBID earlier than two weeks prior to the
 event so that funding could be used to market the event to bring in over-night guests, and
 suggested a different date other than during the State Fair.
- > FY-13 Canadian Campaign presented by Wendt
 - Proposals for a 2013 spring and a 2012 fall media campaign were submitted. The campaigns include radio, Internet Banner Ads and Social Media. The campaigns are in partnership with the GF CVB. The campaigns are based on the success of previous Canadian campaigns that the GF CVB and the TBID partnerships developed.
 - A motion was made to fund the 2013 spring and the 2012 fall campaigns for a total of \$20,000 (\$10,000 each) as proposed in the media plan. The motion was seconded. The motion carried with unanimous consent.
 - Discussion: Request additional information from Wendt regarding the success of the above campaigns and the past campaigns.
- Meetings and Convention Plan (Draft) Wendt Communications

 Per a request of Ms. Venetz, Wendt submitted a media plan for meeting and convention publications. This plan was presented to begin a dialogue for any future plans that may develop.

NEA Way Finding Grant

- The City of Great Falls received word that their request for Our Town Funding (Way-finding) had been reviewed but unfortunately was not selected to receive a grant. The money set aside (\$500) will be returned to the general fund
