 - Some form of stewardship underneath the county
 - Who is going to pay for it if it goes to referendum?
 - PR issues does the community want to get behind it who will pay for PR?
 - Before going to bond it is suggested that a much for DEFINDED DESIGN is completed, so the cost is as accurate as possible. Who will pay for this

- Inflation rate used on project like this are usually assumed at 3%. But the latest on building costs is they will be much higher than assumed 6 months ago. Should estimate 6%
- Operational Expenses in the study reflect additional staff members and include salary and benefits
 - FT/ PT and specific events
- Ice is a concern needs to be fully evaluated
- Dirt events 4 Seasons and the Billings Metra both have considerable problems with the ventilation systems when they host dirt events
- The existing sewer system is not adequate to include another structure such as the proposed center –
- County Business plan
 - Will require a whole new plan and strategy
 - Very strong suggestion of a management company
- Work on a steering committee that the county may endorse
