4. MINUTES FOR BOARD MEETING, July 22, 2015 MEETING

- We started a new training session for three fixed route drivers.
- We have a piece of legislation in Congress to tie onto the new highway bill that we are hoping gets passed for small urban. The bill would allocate \$1.25 million to every state for small urbans. For Montana there are only three small urbans, so it would greatly help us.

a. Approve the FY 2016 Budget.

9. NEW BUSINESS

a. Resolution No. 128 – FY 2016 Regular & Permissive Medical Mill Levies.

Per Montana State Statutes, the mill levies must be set within 45 days of receipt of Certification of Taxable Valuation from the Montana Department of Revenue. On August 4, 2015 Great Falls Transit District received the 2015 Certified Taxable valuation, \$84,717,013.

Carl Donovan, Board Chair, asked for a motion to approve Resolution No.128 setting the regular and permissive medical Mill levies for fiscal year 2016 at 19.61 mills.

<u>1.72 mills</u>	Permissive Medical Levy
17.89 mills	Great Falls Transit District

Laurel Gebo moved/Ann Marie Meade seconded. Motion approved.

b. FY 2016 Budget. Great Falls Transit District sets a budget on a yearly basis,

which runs from July 1^{st} through June 30^{th} .

Carl Donovan, Board Chair, asked for a motion to adopt the FY16 budget as presented. Ann Marie Meade moved/Ken Johnson seconded. Motion approved.

The Board reserves the right to amend the budget as revenue and expenses are subject to change.

10. PUBLIC COMMENTS

Shyla Patera commended the Board for passing the FY16 budget and the Mill Levies. Shyla then asked management about the new software for Paratransit. Said it is hard to get through to dispatch to schedule rides and is hoping this gets easier as the dispatchers get use to the new programs.

Jim Helgeson, general manager, explained that once the whole system is in place, it should Stream line the system and make things easier. Brad Livingston said this was his first meeting and wanted to compliment the Board on the professionalism of the Board. He did not realize we were only one of three transit districts in the state. What are the other two cities?

Jim Helgeson, general manager, explain how the different transit systems are broke down and there are actually 38 systems in Montana. There are three small urban transit systems, which are Great Falls, Billings and Missoula
