I am a Great Falls resident and taxpayer. I'm writing for a second time in support of the Great Falls LGBTQ+ Center in their efforts to pass a Non-Discrimination Ordinance.

I disagree strongly with the city attorney's evaluation of the issue; I recommend reading the Great Falls LGBTQ+ Center's response in order to understand that standing protections are not enough to protect our citizens (their statement is in the postscript if you'd like to take a look).

I disagree just as strongly with the rhetoric that was offered by opponents of the NDO during the public comments section of the city commission meeting on July 7, 2020. I am saddened that community members would contextualize a housing/resources issue as a sociocultural issue predicated on a particular religion. For those who wish to protect "religious liberty" in this context, I have grave issues with any religion that demands that its practitioners deny housing to an individual (or a family) on the basis of identity. I have even graver issues with a government that protects such a "religious liberty". Liberty to deny resources to human beings isn't worth the name "liberty" at all.

I retain hope that those with power will use that power to guarantee fair housing for all.

P.S. The following statement was copied and pasted from the official Facebook page of the Great Falls LGBTQ+ Center, issued at 8:50 PM MST on Monday, July 27th.

"Thank you for joining us today. We believe it is vital to address the disappointing and misleading statement from the City Attorney. Several statements in the findings require clarification.

Firstly, the claim that explicit protections already exist in housing and accommodations at the state level is false. The only explicit protections in housing are at the federal level and only under HUD's equal access rule. Per HUD's website, "Housing providers that receive HUD funding or have HUD-insured loans are subject to the Rules." Therefore this law provides very limited protection and only applies to entities that receive HUD loans or funding. This does not provide protection for the LGBTQ+ community in any other housing or rental settings. Again, there are no existing black-letter protections at the state level.

The Executive Order by Governor Bullock provides protection for state employees and contracted employees, and does not apply to any other employers in the state. Rather than making the NDO

unnecessary, the Governor's Executive Order shows alignment with the need to protect the LGBTQ+ community in Montana. We are saddened to see an attempt to use this Order to dismiss the needs of the LGBTQ+ community in Great Falls.

The Bostock decision only applies to Title VII employment protections. The city attorney is using this ruling as a cop-out. The city attorney is implying that if LGBTQ people seek relief through the courts and use the Bostock decision as precedent, they would win. The possibility of winning future litigation and creating good case law in and of itself does not create a legal protection. Human Rights Act Claims and Title VII claims can take years to litigate. Providing an easier and expedited course of action via an NDO would help all parties.

There are no explicit federal or state level protections for LGBTQ people in accessing public accommodations. None of the federal laws that bar discrimination in public accommodations include LGBTQ people. Such explicit protections would exist in the federal Civil Rights Act of 1964 or through the state Montana Human Rights Act. Review of each would show no explicit protection in public accommodations for LGBTQ people.

Why wait for the protections started in Bostock and Obergefell to make their way to Montana through litigation when the GF city commission can create protections for LGBTQ residents right now?

Further, as we have explained to the City Commission, the proposed draft is meant to provide an example of language that is already being successfully utilized in other cities across Montana. We recognize and anticipated that collaboration and revision would be required to create an ordinance that meets the needs of the Great Falls LGBTQ+ community.

As we stated during our previous public comment to the commission, if you do not experience a problem personally, you tend to underestimate its prevalence and severity. To assert that the Non-Discrimination Ordinance is "unnecessary" does not accurately reflect the legal state of LGBTQ+ protections in Montana. As a public servant, lay people rely on perceived legal expertise. We find the argument against the NDO to be misleading. It fails to acknowledge the paucity of State-level protections for LGBTQ+ people in both housing and public accommodation.

We believe it is vital to the continued growth and prosperity of our city to advance equal rights for all. We are happy to continue this very necessary conversation with the City Commission. We urge the Commission to set a date for the work session and we await their invitation.
