I am submitting in writing, as I have another meeting this evening, in favor of these two resolutions.

For Agenda Item #11 Resolution # 10428 – the Great Falls Area Chamber of Commerce was also a partner in contributing \$1,000 toward the Wayfinding project (July 2020), but were inadvertently omitted being included as a contributor in the application (Section/Question #8 – fourth paragraph).

Both as a contributor and a supporter of this project, we ask the City Commission to vote in favor of this application.

As I have lived in many communities and many states all over the country – a city with Wayfinding signing is a tremendous asset to visitors, but more importantly speaks to the caring nature of the city, and it highlights many of the options available to visitors and our citizens. A city with a Wayfinding program sets itself apart from other communities that don't have a Wayfinding signing program.

For Agenda Item #12, Resolution # 10429 – we are again asking the City Commission to vote in favor of using TIF funds for the Wayfinding signage project directing people to the West Bank Urban Renewal District, which is rapidly becoming a destination due to its development and growth.

Thank you for your consideration of both of these requests and the Great Falls Area Chamber of Commerce representing over 680 members of our business community strongly supports both resolutions.
