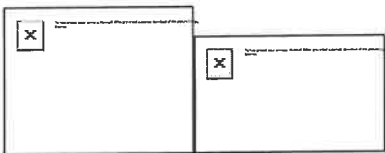
Good morning Mayor and Commissioners,

Several years ago the citizens of Great Falls voted for a bond issue to upgrade the city's parks including the Rivers edge Trail. At the time there was much needed maintenance and other improvements for the parks including the River's edge Trail. Centene Stadium is a property owned by the city, but utilized by a private, for-profit, business, The Great Falls Voyagers. To divert funds to a for-profit enterprise to the detriment of the Park facilities for which they were intended is wrong. Centene stadium is utilized only in the summer and by a relatively small segment of our population, whereas our parks are utilized year-round by most of our citizens.
