1. <u>CITY-COUNTY HEALTH DEPARTMENT'S 2012 ANNUAL REPORT</u>

Cascade City-County Health Department Health Officer Alicia Thompson reviewed highlights in the 2012 Annual Report and provided copies of other miscellaneous documentation. The 2012 Annual Report is posted on the website at www.cchdmt.org. The divisions of the City-County Health Department (CCHD) are Prevention Services, Family Health Services, Environmental Health Services, and Administrative Services. Ms. Thompson pointed out that the Community Health Care Center is located at the CCHD, but is a separate entity and not a part of the CCHD responsibilities.
