JOURNAL OF COMMISSION WORK SESSION December 6, 2016

City Commission Work Session Civic Center, Gibson Room 212 Mayor Kelly presiding

CALL TO ORDER: 5:30 p.m.

CITY COMMISSION MEMBERS PRESENT: Bob Kelly, Bill Bronson, Bob Jones, Tracy Houck and Fred Burow.

STAFF PRESENT: City Manager; Assistant City Attorney; Director of Fiscal Services; Police Chief; Fire Chief; Assistant Fire Chief; Fire Emergency Manager; Fire Training Officer; Fire Marshal; and, the Deputy City Clerk.

1. PUBLIC COMMENT

Richard Liebert, 289 Boston Coulee Road, with regard to Calumet's tax abatement request, Mr. Liebert provided and discussed an article from *KRTV* News. Mr. Liebert noted that the abatement would have public safety impacts. He further commented that the abatement would also impact the County, creating a tax shifting burden for the rest of the population.

Ron Gessaman, 1006 36th Avenue NE, noted that the free Lending Libraries were not mentioned at the November 15th Work Session. Mr. Gessaman encouraged that the free Lending Libraries expand to other Neighborhood Council parks.

2. <u>COUNCIL OF COUNCILS REPORT AND UPDATE FROM NEIGHBORHOOD</u> COUNCIL #4

Official Delegate for Council of Councils Sandra Guynn reported that at the last Council of Councils meeting there was a presentation with regard to the updates of the Code Enforcement Ordinance. She further noted that there was an update with regard to the Holman property. Official Delegate Guynn commented that representatives from the Building Active Communities Initiative were introduced. She further mentioned that Meadow Gold's donations were generous with regard to the Council's ice cream socials. She further announced that Mitch Tropila and Jean Price discussed their campaigns at the last Council of Councils meeting.

With regard to Neighborhood Council 4, Chairperson Guynn commented that NC 4 is one of the largest in the City. She reported that traffic near the bypass by Walmart was the only complaint. Chairperson Guynn commented that NC 4 has educational speakers each month. She gave an update with regard to the meetings over the past year.

Commissioner Burow commended Chairperson Guynn on her report.

Chairperson Guynn introduced fellow council members: Harold Wheeler, Curtis Finnicum, Dan

Payne, and Rudolf Tankink.

3. <u>FIRE DEPARTMENT UPDATES AND EMERGENCY RESPONSE NEEDS</u>

Fire Chief Steve Hester, Assistant Fire Chief Ron Scott, Fire Training Officer Shane Klippenes, and Fire Marshal Dirk Johnson reviewed and discussed the attached PowerPoint presentation.

Commissioner Burrow received clarification with regard to paramedics being allowed to administer pain medication.

With regard to the PowerPoint, Manager Doyon received clarification as to the main contributor for calls with response times of over nine minutes.

Manager Doyon inquired as to the Great Falls Emergency Service having paramedics on staff. Training Officer Klippenes responded that when running an ambulance there is one Emergency Medical Technician (EMT) and a Paramedic.

Fire Marshal Dirk Johnson indicated that he would like to see Safety Inspection Certificates (SIC's) become a full time position. He further noted that there would not be an impact to the City.

Fire Marshal Johnson reported that the position now is a rotational position. Commissioner Jones inquired as to the need of having a rotational position if SIC's becomes a full time position. Fire Marshal Johnson responded that would be ideal, however there would be a cost to the City. Commissioner Jones commented that would be an educational resource.

Manager Doyon commended Fire Marshal Johnson with regard to taking an aggressive stance to the Code Enforcement.

4. EMERGENCY MANAGEMENT UPDATE

Emergency Manager Nordel commented that interaction with the County has to be inseparable. He encouraged that the City and County work together with regard to practicing Disaster and Emergency exercises and drills.

Emergency Manager Nordel reported that the Disaster & Emergency Services objective is to train and organize in order to become successful when a disaster happens. He commented that the community needs to understand how to respond to emergency situations.

Mayor Kelly commented that it's reassuring to have the level of professionalism that is involved with the public safety. Mayor Kelly expressed appreciation with regard to the effort being made to interact with the County for the betterment of the community.

Commissioner Burow concurred with Mayor Kelly with regard to interacting with the County.

Chief Hester expressed appreciation to the Commission for its support with regard to Emergency Services improving its preparation for disasters.

Commissioner Houck received clarification with regard to charging a fee for emergency response calls. She further received clarification with regard to ownership of the Fire Training Center. In Response to Commissioner Houck's inquiry with regard to Local 8, Chief Hester commented that it's the 8th Union in the Nation.

Commissioner Jones commended Chief Hester with regard to its use of grants. With regard to the skid unit that was identified as a need in the Stuckey fire, Commissioner Jones inquired as to a backup plan if the grant doesn't come through. Chief Hester responded that he is working on a Cooperative Agreement with Department of Natural Resources and Conservation (DNRC). Commissioner Jones expressed support with regard to obtaining the skid unit.

5. <u>DISCUSSION OF POTENTIAL UPCOMING WORK SESSION TOPICS</u>

City Manager Greg Doyon announced that the next work session will include the Annual Audit Review. With regard to the Great Falls Fire Rescue equipment needs, a planning session in preparation for next year's budget will be scheduled in January. Manager Doyon further commented that at some point the Fire Department may have to ask the public to support its other needs.


