Suggested Motion:

1. Commissioner moves:

"I move that the City Commission vacate the public hearing on Resolution 9874 scheduled for February 16, 2010, and reschedule the public hearing for March 16, 2010, on Resolution 9874 Establishing Water, Sewer and Storm Drain Utility Service Rates effective April 1, 2010 to allow for individual customer Notice Requirements as set forth in MCA 69-7-111."

Staff Recommendation: Staff recommends the City Commission set a public hearing for March 16, 2010, on Resolution 9874 to establish water, sewer, and storm drain utility service rates effective April 1, 2010.

Background: Each year, staff reviews and analyzes the financing needs of the water, sewer, and storm drain funds. The review ensures the City has adequate funding necessary to finance the day to day operations, and provide for any capital improvements, emergency main breaks, or replacements. These funds also provide the financing to run the Water and Wastewater Treatment Plants effectively. Adjustments in utility rates are also necessary to provide adequate revenue to finance the capital improvements program, and meet debt service coverage requirements and to maintain appropriate reserves. Staff recommended 5% increases in the water utility rates and 5% in the sanitary sewer utility rates and no increase in storm drain utility rates.

On January 19, 2010, after a work session presentation by City staff, the Commission amended the recommended sanitary sewer utility increase of 5% to 7.5%. At this time, staff is aware of DEQ/EPA permit required capital improvements that will be necessary within the next two to

five years. The exact costs and time frame are unknown. In the effort to meet these future needs, the City Commission prefers to begin aligning rates with a moderate 7.5% increase in service rates rather than one large increase in the near future.

The January 29, February 5, and February 12, 2010, Tribune Notices described the change in Sewer Rate from the Staff proposed 5% to the Commission proposed 7.5%. However, the individual notices to each utility customer did not reflect the percentage change. Therefore, in order to meet the requirements of MCA 69-7-111, additional notice will be mailed to assure proper notification of intent to each utility customer.

With the proposed rates beginning April 1, 2010 the average residential utility bill will increase approximately 5% or \$2.30. Staff has found moderate annual increases to service rates are more effective in meeting revenue needs as opposed to sporadic large increases.

These water and sewer rate changes include water and sewer connection and tapping fees, which do not have any impact upon monthly water and sewer bills. They are one time charges for the initial connection to the existing service lines.

Concurrences: Public Works and Fiscal Services staff collaborates on past accomplishments and future estimates throughout the recommendation process. The proposal is then presented to the City Manager for review prior to forwarding to the City Commission for deliberation.

Fiscal Impact: Comparisons of current versus proposed rate structures are attached. With the proposed rates beginning April 1, 2010, the average residential utility bill will increase approximately 5%, or \$2.30 per month. This is derived from water utility service rate increases of 5%, sanitary sewer rate increase of 7.5%, and a 0% increase in the storm drain utility service rate.

RESOLUTION 9874 ESTABLISHING WATER, SEWER, AND STORM DRAIN SERVICE RATES

A RESOLUTION TO ESTABLISH WATER, SEWER, AND STORM DRAIN SERVICE RATES IN ACCORDANCE WITH 13.02.040 OCCGF, EFFECTIVE APRIL 1, 2010

WHEREAS:

The City Commission of the City of Great Falls, met and conducted the hearing in the regular session on Tuesday, March 16, 2010 at the Civic Center, Great Falls, Montana, at 7:00 p.m. and did consider the cost of operation, equipment, facilities, debt service, and capital improvements for the Water, Sewer, and Storm Drain systems;

13.02.040 OCCGF states: "All rates or fees for use of the utility systems or for permits, licenses, connections or inspections shall be defined by resolution and approved by the City Commission. . ."

Suggested Motion:

"I move that the City Commission approve the Cascade County Inter-Local Agreement for Fire Protection and Emergency Medical Services, for October 1, 2009 to September 30, 2012 and that the City Manager be authorized to execute the same."

2. Mayor calls for a second, discussion, inquiries from the public, and calls the vote.

Staff Recommendation:

Staff recommends that the City Commission approve the Inter-Local Agreement with Cascade County for Fire Protection and Emergency Medical Services, for October 1, 2009 to September 30, 2012 as approved and signed by the Cascade County Commissioners.

Background:

Great Falls Fire Rescue has been providing contracted fire and EMS services for the County fire districts for over 30 years. During this time GFFR has provided prompt, efficient emergency service to these districts enhancing the quality of life to these areas of the county. State statue MCA 7-33-2107 and 7-33-2125 provides for these districts to contract with the City of Great Falls for fire and other emergency services. This contract includes fire suppression, emergency medical response, inspection services and fire investigation. There are currently 16 separate and distinct areas that comprise our response areas. The combined total of these service areas is 3.5 square miles, with an estimated resident population of 4,000. The typical resource response to structure fires in these service areas include 2 Engines Companies, 1 Ladder Company, 1 Chief Officer and 1-2,200 gallon Water Tender. The Water Tender was purchased new in 2001 specifically for fire district response; its cost was \$127,000. In 2008, we responded to 126 calls for service in these fire districts.

SYNOPSIS:

This Fire District Contract with Cas cade County has been approved by the County Commissioners for the period of October 1, 2009 thru Se ptember 30, 2012. The contract provides for the proceeds from the Rural Fire C ontrol Special District Levy for e mergency fire and medical services, computed from the maximum allowed by 15-10-420, MCA be paid to the City. This m ill was 87.73 m ills in FY 08/ 09 for a total of \$177,313.00 in collected revenue. MCA 15-10-420 provides for slight annual infla tion increases which I would approxim ate at \$2,000 per year during this contract term . Payments shall be in two equal installments due on or before December 15 and June 15.

<u>Citizen Participation:</u> Citizens comment is encouraged during the County and City Commission public approval process.

<u>Workload Impacts:</u> Great Falls Fire Rescue has provided fire and medical emergency services to these areas for over 30 years. Based on their proximity to the city limits and the low frequency of calls, I'm comfortably continuing to provide service without degrading service within the city.

<u>Purpose:</u> Approval of this agreement will enable the property owners and residents of these areas to receive emergency services from a professional fire protection organization.

<u>Project Work Scope:</u> Fire Protection and Emergency Medical Services, October 1, 2009 to September 30, 2012 pursuant to criteria outline in the Inter-Local Agreement.

<u>Evaluation and Selection Process:</u> Cascade County is allowed to contract for these services under MCA 7-33-2107 and 7-33-2125.

<u>Concurrences:</u> Cascade County Commission, Acting City Attorney, City Clerk, and Fiscal Services.

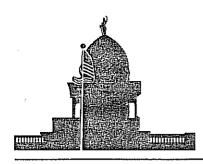
<u>Fiscal Impact:</u> It is projected the City would receive approximately \$175,000 per year in revenue. Based on many variables, it would be hard to calculate the exact cost of providing these services. However, I can estimate the city's costs for service does not exceed revenue collected.

<u>Alternatives:</u> The City Commission could choose to decline to provide Fire and EMS services under the terms of this agreement. Responsibility for fire protection would return to Cascade County who would make assignment for fire protection to one of the existing volunteer fire departments. This alternative if selected would likely place considerable hardship and risk on many of the residences currently covered under this agreement.

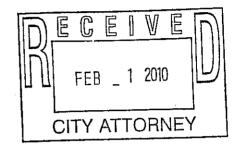

RETURN TO COMMISSION INTERLOCAL AGREEMENT

Between *Cascade County* and the *City of Great Falls* For Emergency Fire and Medical Services

WHEREAS, the Montana Interlocal Cooperation Act, codified at Mont. Code Ann. § 7-11-101, *et seq. (2009), (hereinafter the "Act"), permits local government units to make the most efficient use of their powers by enabling them to cooperate with other local governmental units on a basis of mutual advantage, and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities; and*

WHEREAS, the Act provides that one or more public agencies may contract with any one or more other public agencies to perform any administrative service, activity, or undertaking which such public agencies are otherwise authorized by law to perform; and

WHEREAS, the County of Cascade ("Cascade") and the City of Great Falls ("City") constitute public agencies pursuant to § 7-11-103, MCA; and

WHEREAS, the City has a fire department which is permanently organized equipped, and staffed for continuous operations; and

WHEREAS, the City fire department's operational capacity is adequate to provide normal services to both the City and adjacent areas; and

WHEREAS, the County has created and may additionally create, fire districts in accordance with §§ 7-33-2101 through 7-33-2104, MCA; and

WHEREAS, the descriptions and boundaries of the fire districts are contained in the records of the City-County Planning Department. For the purposes of this agreement the term "Fire Districts" shall mean the established Fire Districts numbered as follows:

WHEREAS, § 7-33-2104, MCA, provides that whenever the board of county commissioners shall have established a fire district in any unincorporated territory, town or village said commissioners.

- (1) may contract with a city, or private fire company to furnish fire protection for property within said district; or,
- (2) shall appoint five qualified trustees to govern and manage the affairs of the fire district; and

WHEREAS, the County has chosen to directly contract fire services for such fire districts, rather than create a board of trustees' and

WHEREAS, § 7-33-2109, MCA, provides that at the time of the annual levy of taxes, the board of county commissioners may levy a special tax upon all property within such district for the purpose of paying to a city, town, or private fire service the consideration provided for in any contract with the council of such city, town, private fire service for the purpose of furnishing fire protection service to property within such district;

NOW THEREFORE, pursuant to the Montana Code Interlocal Cooperation Act, codified at Mont. Code Ann. §7-11-101 *et seq*, (2009), and in consideration of the mutual covenants and agreements contained herein, the receipt and sufficiency of which are hereby acknowledge, the undersigned parties hereby agree as follows.

1. <u>Purpose and Scope of the Agreement.</u>

Pursuant to §§ 7-11-105(3) and 7-11-105(8), MCA, the purpose and scope of this agreement is for the City of Great Falls to provide emergency fire and medical services for the Fire District areas enumerated hereinabove, provided that in the event that calls for service exceed available resources, the City reserves the authority to prioritize its response. Time is of the essence.

2. Duties and Responsibilities.

The City shall provide the following services to Cascade County's Fire District areas as enumerated hereinabove:

- a. Emergency Medical Response
- b. Fire Inspection of Business Buildings when requested by business owners
- c. Origin and Cause Investigation, when required
- d. Fire Suppression for all property including but not limited to buildings and structures, crops and personal property.

The City and County may extend this contract to additional Fire District(s) by mutual agreement, executed through written contract addendum(s). Such addendum(s) shall specify the new Fire District(s) and additional compensation, if any, to be paid by the County for such service.

3, Duration and Termination.

Pursuant to §§ 7-11-105(1) and 7-11-105(5), MCA, as from time to time amended, this agreement, upon execution by the duly authorized representative of the City of Great Falls, and the County of Cascade, shall commence retroactive to October 1, 2009 and shall continue in full force and effect through September 30, 2012.

Either party hereto may cancel the said contract on September 30th of any year by giving sixty (60) days written notice to the other party.

4. Contract Sum.

Pursuant to §7-11-105(4), MCA County shall pay the City proceeds from the Rural Fire Control Special District Levy for emergency fire and medical services. The levy shall be computed at the maximum allowed by § 15-10-420, MCA, floating mill authorization. This mill was **84.59 mills** in FY 2009/10. The County shall provide the number of such mills levied in each subsequent year of this agreement by September 30. Payments shall be in two equal installments due on or before December 15 and June 15 of each year this agreement is in effect.

5. Separate Legal Entity.

Pursuant to § 7-11-105(2), MCA, nothing in this agreement shall be construed to create an agency, partnership, joint venture or employee relationship; between the parties. The parties by virtue of this agreement shall have no right, power, or authority, except as expressly provided for by law, to act or create any obligation, express or implied, on behalf of the other party. Further, pursuant to § 7-11-105(6), MCA, there shall be no administrator or joint board responsible for administering the terms of this interlocal agreement.

6. Ownership of Assets.

Pursuant to §7-11-105(7), MCA, and at all times relevant to this agreement, all equipment and other property used by the City of Great Falls to execute this agreement shall remain the exclusive property of the City of Great Falls,

7. Hold Harmless and Indemnification.

The City shall protect, defend, indemnify, and hold harmless the County from and against any and all manner and form of liability, damages, claims, claims for damages, demands, causes of action, or expenses, including interest or attorney fees, of any nature or description resulting from or arising out of or in connection with the City's intentional or negligent acts and omissions in the performance and provision of emergency fire, medical, and other specified services, including but not limited to the City's response to and return from the scenes of emergency incidents, pursuant to and in accordance with the terms of this agreement. Nothing herein shall be construed as an agreement by the City to release, indemnify or hold harmless Cascade County, its official agents, or employees from liability for damage or injury to persons or property caused by the negligence, carelessness, or international acts of Cascade County, its officials, agents, or employees are acting under the direction or control of the City.

8. Notice.

All notices required to be provided shall be given in writing, addressed to the respective parties' authorized representatives as designated herein, and delivered personally or by U.S. mail. For purposes of the Contract written notice shall be deemed to have been duly served: (1) in the case of personal delivery, on the date indicated upon a written receipt issued by the recipient; (2) in the case of unregistered and uncertified U.S. mail, three business days following the listed date of the notice or the date of the postmark, whichever is later; and (3) in the case of registered or certified mail, the date indicated on the return receipt.

9. Authorized Representatives.

The City of Great Falls and Cascade County shall each designate a representative authorized to receive all Contract communications and notices and who shall be authorized and responsible to take all action necessary for the execution and administration of this Agreement Except as otherwise designated in writing by the respective parties, the authorized representatives of the parties are:

10. Amendment.

This interlocal agreement may not be amended except by written agreement of the undersigned parties in conformance with the requirements of the Montana Interlocal Cooperation Act, codified at Title 7, Chapter 11, Part 1, MCA.

11. Attorney fees, Costs, and Venue

In any judicial action to enforce or interpret the terms of this interlocal agreement, each party shall be responsible for its own costs of suit and attorney fees. Venue for any judicial actions shall be in the District Court in and for the Eighth Judicial District, Cascade County, Montana.

12. Severability.

If any term of this agreement should hereafter be declared or become void or unenforceable by operations of law, all other terms of this agreement shall continue to be effective unless the void or unenforceable term materially affects the ability of the governing body to carry out the essential purpose set forth in Section 1 of the Agreement.

13. <u>Merger.</u>

This interlocal agreement constitutes the entire agreement of the undersigned parties with respect to the matters addressed herein and supersedes any and all previous agreements or representations, if any, between the parties.

14. Assignment.

The parties mutually agree that there will be no assignment, transfer or subcontracting of the contract or any interest therein, unless agreed to by the parties in writing as provided for the Section 10 of this Agreement.

15. Binding on Successors

This Agreement shall be binding on Cascade County and the City of Great Falls and all of their successors and assigns, including any successor in interest.

16. <u>Time is of the Essence</u>

Time is of the essence in the performance of all parties' obligations and duties under this Agreement

Pursuant to § 7-11-104, MCA the undersigned parties, hereby authorize, approve, and execute the terms of this interlocal agreement.

Suggested Motion:

1. Commissioner moves:

"I move that the Commission (approve/deny) the acceptance of trail easements from Zara Renander and Hugh Gwin for the extension of River's Edge Trail."

2. Mayor calls for a second, discussion, inquiries from the public, and calls the vote.

Staff Recommendation: That the Commission concur in staff's recommendation to accept trail easements from Zara Renander and Hugh Gwin for the extension of River's Edge Trail.

Background: The River's Edge Trail is an award-winning system of urban and rural trails, extending more than 31 miles along the Missouri River in and around the City of Great Falls. In addition to the 18 miles of urban paved trail, the system also includes more than 23 miles of rural gravel and dirt trails.

For more than 15 years, the City of Great Falls has been committed to development and expansion of the Trail system, both urban and rural. The expansion of urban, paved trails continues with development of the Bay Drive Trail segments as well as neighborhood connections like the 38th Street trail and the Warden Park connector trail. Rural trails have extended downriver, in cooperation with our trail partners such as the Montana Department of Fish, Wildlife and Parks and PP&L Montana.

In 1996, the City of Great Falls purchased 300 acres of land along the south shore of the Missouri River in the interests of native land conservation, open space protection and extension of the Trail system. However, the Trail has not been able to expand past that parcel. In December of 2009, Zara Renander, the owner of the land immediately downstream from the City's land, provided a 1.89 mile trail easement along the Missouri River through the a generous donation by Recreational Trails, Inc. (RTI).

This second Renander easement and the adjoining Gwin easement would tie into the recently purchased easement and continue the trail downstream, terminating in an overlook of scenic Box Elder Creek. The easements would also provide a return loop segment closer to the Missouri River (see attached Location Map). The approximately 2.45 miles of new trail would extend the River's Edge Trail's "single-track" dirt trail system, providing trails for the more advanced mountain bicyclist as well as the hiker looking for

a more challenging outing. The views from this proposed trail segment are spectacular, especially at the terminus at Box Elder Creek, and could be a valuable contribution to recreational tourism in Great Falls.

Although RTI has offered to pay for the acquisition of the easements through a contribution by a generous donor, it is not equipped to manage and own property. The City of Great Falls is the logical easement holder, because of its interest in the Trail as well as the proximity of the trail to the City-owned property and to the recently acquired easement immediately upriver.

Management of the trail easements would be through a partnership with the Montana Department of Fish, Wildlife and Parks, City of Great Falls, Recreational Trails, Inc. and the Great Falls Bicycle Club.

Concurrences: The Trails Working Group, Recreational Trails, Inc., the Planning and Community Development Department and the Great Falls Bicycle Club support City acceptance of the trail easements.

The City Attorney's Office has reviewed the easements and concurs in the language and conditions. The City Risk Specialist has considered the impact of trail easements and has determined there would be no negative impact or additional cost to the City's insurance requirements or rates, or related liability.

Fiscal Impact: There would be no fiscal impact to the City, other than staff time to process the easement. Recreational Trails, Inc., through a generous donation by long-time trail supporters and users Zander and Anders Blewitt of the Hoyt & Blewitt law firm, has agreed to provide \$50,000 to River's Edge Trail for the purchase should the City accept the easements.

Alternatives: The Commission could alternatively deny acceptance of the easements.

EASEMENT AGREEMENT AND GRANT OF EASEMENT

THIS AGREEMENT IS SUBJECT TO ARBITRATION PURSUANT TO THE MONTANA UNIFORM ARBITRATION ACTION

THIS INDENTURE is made the _____ day of ______, 2010 by and between **ZARA RENANDER** of No. 2201, 1920 South First Street, Minneapolis, Minnesota 55454 ("Transferor"), **THE CITY OF GREAT FALLS, MONTANA** of No. 2 Park Drive S., P.O. Box 5021, Great Falls, Montana 59403 ("Transferee").

WHEREAS, **Transferor** owns the following real property lying and being in Cascade County, Montana, more particularly described as follows:

Township 21 North, Range 5 East, P.M.M. Section 20 Government Lots 6 & 7 Section 21 Government Lots 5 & 6

(the "Burdened Land");

WHEREAS, **Transferee** owns and/or operates a system of trails for use by the public in and around the City of Great Falls known as the River's Edge Trail System which runs to the Burdened Land;

WHEREAS, **Transferor** has agreed to grant Transferee an easement which will extend the River's Edge Trail System through the Burdened Land according the terms and conditions stated herein.

NOW, THEREFORE, the parties agree as follows:

1. **Grant of Easement**. Transferor transfers and conveys unto **Transferee** a perpetual nonexclusive easement and right-of-way on, over and across the Burdened Land for the purpose of constructing, maintaining, repairing, using and replacing an unpaved path or trail for non-motorized use (hereinafter referred to as the "Trail") within the Corridor, as defined below, (hereinafter referred to as the "Easement Area"), together with monuments, informational and directional signs, for use by the general public, subject to the conditions and limitations set forth herein.

2. **Scope of Easement.** Subject to the restrictions and limitations set forth in paragraph 3 below, use of the Trail shall be limited to pedestrian and non-motorized vehicle traffic and shall exclude any and all motorized/mechanized wheeled/track recreational vehicles of any kind, except wheelchairs (including motorized chairs and mobility scooters), emergency and maintenance vehicles which shall be permitted. Traffic shall be limited to an existing trail not to exceed ten (10) feet in width which is generally depicted on Exhibit "A". The Corridor is an area 25 feet on either side of the center line of the Trail. The Corridor and/or Trail location may be altered from time to time by mutual consent of the parties or their successors in interest. Transferor reserves the right to cross and/or use the Trail and Corridor for herself and her heirs, successors and assigns.

3. **Other Access.** This Easement shall also include Transferee's right of entrance to and exit from Transferor's adjacent lands on established trails and roads whenever possible for the purpose of allowing Transferee, through either vehicular or pedestrian access, to build, maintain and repair its trail system. Transferee shall be responsible for any damages it causes to roads or other improvements while exercising the rights granted by this paragraph. However, Transferor shall have no obligation to regularly maintain the access roads and trails, nor shall Transferee have obligation to regularly maintain access roads.

The parties agree that during the term of this Easement, Transferee may need to cross Transferor's property (above described as the "Burdened Land") to respond to emergency situations. Before entering the property, Transferee shall attempt to contact Transferor. If Transferor cannot be reached, then Transferor, through this agreement, authorizes Transferee to cross the property, using established roads and trails where possible to handle the emergency situation.

The parties recognize that they have not specifically described the location or the dimensions of the right granted under this paragraph; this is by necessity. Such a refined description would be inappropriate in this situation. The parties intend that Transferee should exercise its rights reasonably and that it choose locations that are least onerous to Transferor.

4. **Mediation/Arbitration**. If a dispute arises out of or relates to this Easement or the breach this Easement, and if the dispute cannot be settled through

negotiation, the parties agree to first to try in good faith to settle the dispute by mediation administered by a mutually agreed mediator before resorting to any other dispute resolution procedure. The Mediation shall terminate upon the written request of either party. If the parties are unable to resolve the dispute through mediation, the parties shall settle by arbitration in accordance with the Montana Uniform Arbitration Act. The parties shall select one arbitrator by mutual agreement. If the parties fail to agree upon an arbitrator within 30 days after service of the initial demand for arbitration, the arbitrator shall be appointed as provided in Montana Code Annotated § 27-5-211. The arbitration hearing shall take place within 60 days after the selected arbitrator's acceptance of the appointment. Judgment upon the arbitration award may be entered in any court having jurisdiction or application may be made to such court for judicial acceptance of the award and an order of enforcement, as the case may be. Arbitration shall be held in the City of Great Falls, County of Cascade, State of Montana, and any question of law shall be decided in accordance with the laws of the State of Montana.

5. **Indemnification**. The Transferee agrees to indemnify, hold harmless, and defend the Transferor and its successors and assigns from and against claims, losses, damages, expenses, fees (including without limitation attorneys fees) or liability arising out of the use by the public of the easement property. Transferee assumes all risk arising out of the use of the easement property by the public. 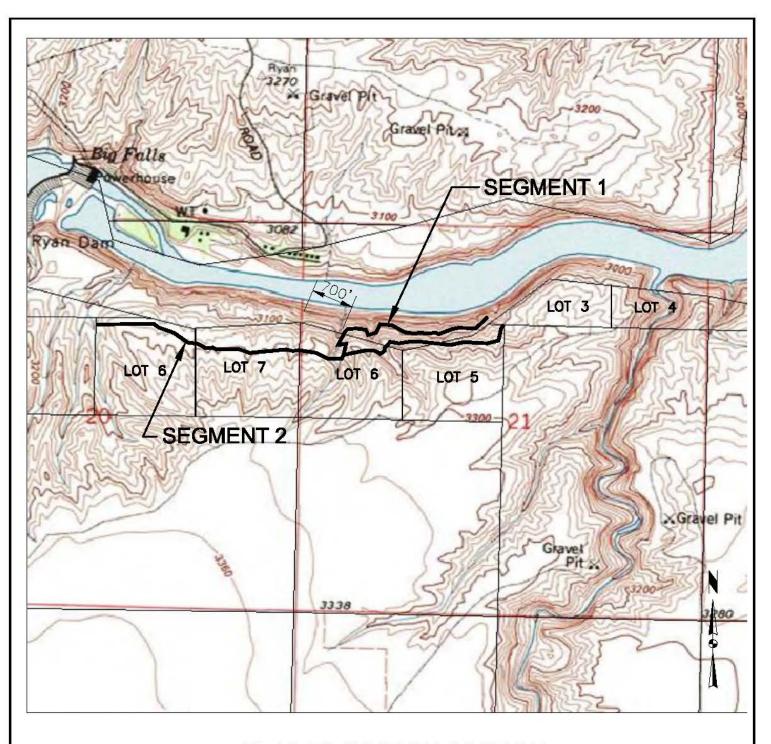

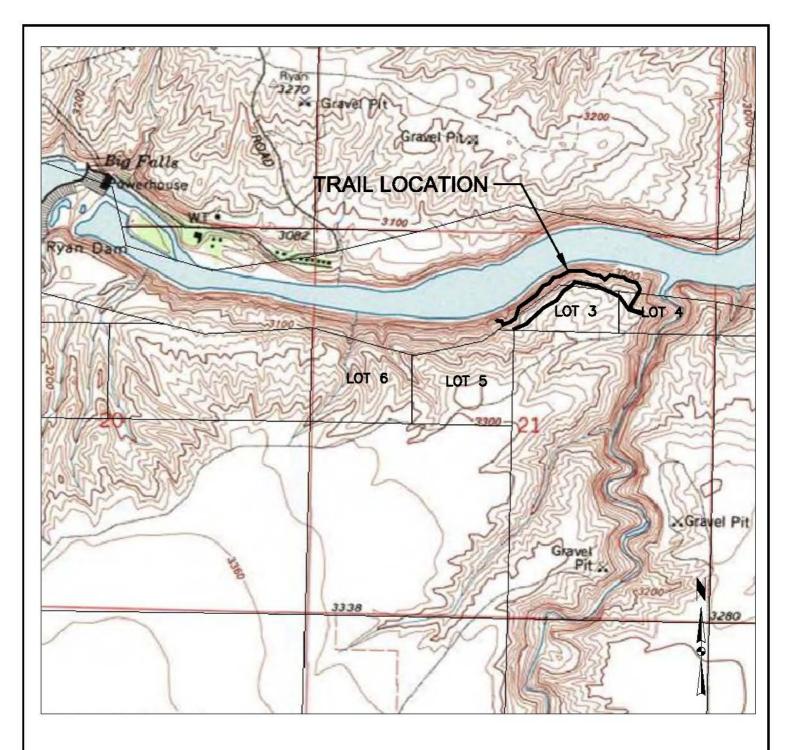

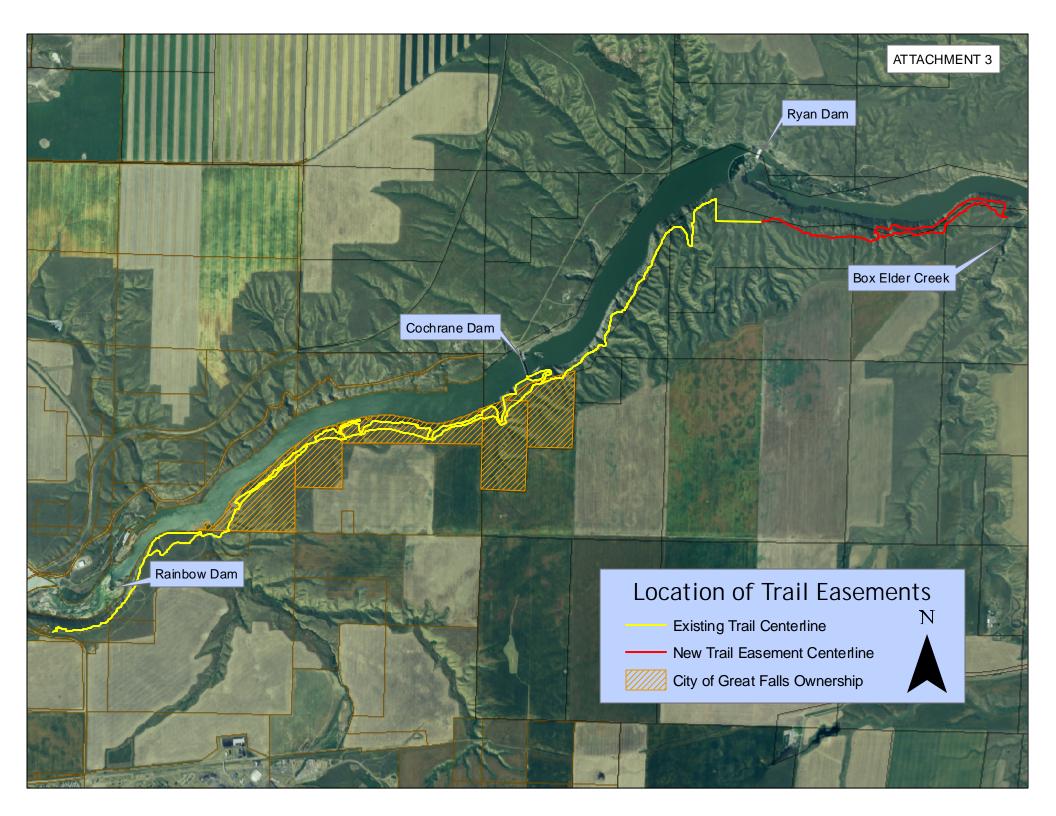

Tim Gregori , General Manager of Southern Montana Electric Generation and Transmission Cooperative, provided a brief update on the project being constructed east of Great Falls. He explained the notice of transfer of assets consolidates the assets from SME to Southern Montana Electric Generation and Transmission Cooperative to continue to develop the electric generation facility. The 2010 budget has been set and the hope is to keep the rates stable and competitive considering power needs to be purchased from the open market from time to time. He noted he was available to answer questions or provide presentations on activities of the project or the services offered to Electric City Power.

Robert's Rules of Order, ECP bylaws.	2E. Ron Gessaman , 1006 36 th Avenue NE, was disappointed that the Mayor used the term "gallery" and not "participants" at the February 1, 2010, joint City Commission and ECP Board meeting. He discussed Robert's Rules of Order and that speakers should not be interrupted. Mr. Gessaman recited portions of the ECP bylaws and noted the ECP Board's duty to elect its officers in January.
PPL Contract.	2F. Travis Kavulla , 725 49 th Street South, inquired if Mr. Gregori would make the PPL/SME supply contract available to the Commission to view publicly. He suggested it would assist the Commission in their upcoming decisions at joint Commission/ECP Board meetings. Mr. Gregori responded that it was a free market contract negotiated between a willing buyer and seller that is not subject to any public regulation as with any wholesale power contracts in the United States since the Energy Policy Act of 1997. Mr. Kavulla finds it outrageous that the contract has not been seen in public as a significant financial obligation to the City occurs as a result of the contract, and that mere representations from SME have had to be trusted about the favorability of that document.
Unsafe sign service trucks and situations.	2G. Dan Dust , owner of Big Sky Sign Service, residing at 1401 5 th Avenue South, commented that he was in favor of the Great Falls Fire Department getting a new truck. He discussed trucks in his industry and situations he witnessed that he felt were unsafe. Mr. Doyon explained that the City is not the agency that oversees trucks that are used by sign companies. Those types of incidents should be reported to OSHA. Mr. Dust indicated that he had contacted OSHA. After further discussion, Mayor Winters asked Commissioner Jones to research Mr. Dust's statements and report back.

PUBLIC HEARINGS

Ord. 3049. Adopted with
technical amendments.3. ORDINANCE 3049, INTERIM ZONING ORDINANCE FOR
MEDICAL MARIJUANA ESTABLISHMENTS.

Planning and Community Development Director Michael Haynes reported that this item relates to the request for a 90-day moratorium on issuing any Safety Inspection Certificates or Home Occupation Licenses for medical marijuana providers to allow staff time to research and recommend regulations for this use. A Safety Inspection Certificate or Home Occupation License is needed to conduct any business in the City of Great Falls. Mr. Hayes made the following points:

- 1. Medical Marijuana was legalized when Initiative 148 was approved by the voters of Montana in November 2004. Staff is asking for the moratorium, not to prohibit the use, but to regulate where and under what conditions providers can operate in the City of Great Falls.
- 2. There is no standard for regulating medical marijuana providers in Montana. He had contact with Planning Directors from cities all around the state regarding their regulations. At either ends of the spectrum are Missoula that has almost no regulations based on deferring to state law and Helena that prohibits the use entirely within city limits based on deference to federal law. Of course, most cities fall somewhere in between and that seems to be a reasonable starting place.
- 3. This moratorium, if approved, would not affect the rights of patients or their right to grow and use their own marijuana. It would place a temporary hold on the City issuing Safety Inspection Certificates or Home Occupation Licenses for medical marijuana providers.
- 4. With regard to the claim that the moratorium would be forcing providers to conduct their business in back alleys, Mr. Haynes reiterated that the City has never knowingly issued a Safety Inspection Certificate or Home Occupation License for a medical marijuana provider. Mr. Haynes expressed "knowingly" because staff relies on applicants to complete license applications honestly and completely. As reported in the *Tribune* after the last City Commission meeting the City received an application for a Safety Inspection Certificate listing the business as "consulting." When staff reviewed the application and noticed the name of the business was "Green Leaf," staff followed up with the applicant. Only then did the applicant admit the business was a medical marijuana provider. The applicant was then advised the City could not issue

the Safety Inspection Certificate.

5. Finally, for those business-owners that have explained how they run legitimate businesses with verifiable qualifying patients, tracking systems and accounting rules, City staff hopes to have the opportunity to visit those operations as part of their research. Regulating this use is not intended to impede legitimate business operations. It is intended to preclude state law being used as cover for criminal activity.

After conducting the public hearing, Mr. Haynes requested that the City Commission adopt Ordinance 3049.

Acting City Attorney Chad Parker encouraged the Commission to refer to the agenda report and references of law, § 76-2-306, MCA, and Title 5 of the City Code. He noted that drafting the language of this proposed ordinance was done in conjunction with advocates of medical marijuana provider groups. One of the advocates, Mr. Jason Christ, represents a large number of the people present tonight and indicated that most of the language was acceptable to the group.

Mayor Winters declared the public hearing open.

Speaking in support of Ordinance 3049 were: **Don Johnson**, owner of Fitness Plus Martial Arts Academy, residing at 124 Riverview 8 West; **Dr. Paul Gorsuch**, local physician; **Greg Beers**, 3418 Falcon Court; **Ben Forsyth**, business owner at 900 9th Street South; and **Roger Curtis**, 1600 2nd Avenue South.

The general comments of the proponents were:

- The location of medical marijuana businesses should not be allowed in close proximity to any other business whose primary function is youth care, education or recreation, nor should it be allowed in residential areas.
- As with any medication, it should be controlled and distributed within the confines of the medical community by licensed professionals.
- Physicians issuing green cards are not managing the patients and none of the typical medical safeguards apply to the Medical Marijuana Act.
- Use of marijuana remains a federal crime.
- Parameters must be set that will allow the community to be a safe, desirable place to live, and to provide a safe environment for those who are using marijuana to alleviate medical symptoms.
- The number of registered users in the state has risen exponentially since 2007.
- Green card holders with criminal intent to benefit financially will 02/02/2010

abuse the Medical Marijuana Act.

• If additional time isn't allowed to carefully consider where the businesses can be located and regulation of its use, there will be significant risk to public health and safety.

Several proponents encouraged the City and County Attorneys to write the Attorney General regarding the harm the Act has caused and to suspend the law until the next legislative session.

Speaking in opposition to Ordinance 3049 were: Jason Christ, Manager of Montana Caregivers Network, Missoula; Carl Jensen, Attorney, 118 17th Avenue NW; Trevor Giger, 1415 8th Avenue North; Pam Birchard, 95 Fisher Road; Tim Spencer, business owner 618 Central Avenue; Derick Deese, Missoula; Carl DeBelly, Attorney, Billings; Joy Spencer, 2720 Rainbow Dam Road; Rick Rosio, President of Montana Pain Management, Missoula; Douglas Adcock, 1110 4th Avenue South; Ken Lindeman, Belt; Melody Brown, Attorney, 817 Central Avenue West; Mark Frisbie, 616 7th Avenue South; Leon Tirums, Cascade; Tom Daubert, Helena; Chris Pettibone, 1714 Colorado; Brandon Peressini, 1513 Balsam Court; and Beth Regennitter, 417 27th Street NW.

The general comments of the opponents were:

- Medical marijuana is known to help over 1,000 ailments.
- Existing zoning requirements are already in place for businesses. Prohibiting patients from being able to grow medicine or to become caregivers puts an unnecessary burden on them.
- Allow the legitimate use of this business to provide revenue to the city and county.
- More regulation should be placed in the Medical Marijuana Act itself, rather than the location of the providers.
- Applications should be considered on the merits.
- City codes already address parking and fire codes.
- Moratorium isn't necessary while staff performs research. A temporary permit should be issued instead.
- The moratorium denies patients access to their medicine.
- The state has already granted a property interest in this particular business. The City should be careful in denying access to that property interest.
- Illegal use of green cards falls in the hands of law enforcement.
- Two applications for business licenses do not cause blight.
- There needs to be a clearly defined separation from church and state and personal views when it comes to dealing with the law and how it applies to the citizenry.
- No fires, crime waves, or blighting effects have occurred since the Act was passed five years ago. The legal grounds for an emergency ordinance have not been shown. The use of § 76-2-306, MCA, for

the moratorium is misuse of the law.

• Zoning can only address a handful of the concerns addressed. Most of the concerns require legislative action.

There being no one else to address the Commission, Mayor Winters closed the public hearing.

Commissioner Bronson moved, seconded by Commissioner Jones, that the City Commission adopt Ordinance 3049 with the following technical amendments that he proposed and distributed to the Commission prior to the meeting:

<u>Section 3, 1. 1</u>: Delete words <u>City of Great Falls</u> and substitute the words <u>City Commission</u>;

<u>Section 4, ll. 1, 3</u>: Delete words <u>City of Great Falls</u> and substitute the words <u>City Commission</u>; delete words <u>City of</u> and add the word <u>Advisory</u>; and, delete the word <u>Planning</u>; and,

Section 7, 1. 5: Delete word had and insert word have.

Mayor Winters asked if there was any discussion amongst the Commissioners.

Commissioner Bronson commented that, with respect to the motion and comments made, state law grants caregivers and patients a little zone of opportunity where marijuana use is permitted. The laws also recognize to a large degree marijuana use is still considered a crime within the State of Montana. Regardless of how the State feels, the federal government feels very strongly that marijuana use is a crime. With regard to the comments about property rights and vested interest, there is no such thing as an absolute property right under our laws. Everything is ultimately conditioned to some degree. State law may grant certain rights to do certain things, but local governments are often left with the task to make the decision where to conduct that legal business. Local governments have the right to condition where that may be, hours of operation, and other terms of how to conduct the business. The legislature is not going to step into that territory. It leaves that up to local governments to craft a solution to fit the community. All lawful businesses operating in this community are subject to zoning ordinances to a certain degree.

A few years ago this community adopted a comprehensive Land Development Code. At that time, no one had any idea that five years down the road there would be the possibility of businesses involved in the dissemination of medical marijuana. It is appropriate to allow a reasonable amount of time to conduct a careful study and make decisions as to what would be the most appropriate way to handle the allowance of this type of business. If the Commission passes this ordinance, Commissioner Bronson encouraged those that had something to offer to the process to work with the Planning Advisory Board and Planning and Community Development Department to do this in a way the community will find acceptable.

Commissioner Burow commented that he doesn't want people setting up a business today, and be in violation tomorrow. Staff needs adequate time to gather information. During this time, medication is not being prohibited.

Commissioner Jolley commented that she does believe the ordinance prohibits patients from getting medical marijuana from their caregivers. She believes staff should have performed the safety inspections.

Mayor Winters commented that he heard the term "fear" used several times this evening. It is reasonable to allow staff an adequate timeframe to study what should be done in the best interest of everyone.

Motion carried 4-1 (Commissioner Jolley dissenting).

OLD BUSINESS

4. <u>MEMORANDUM OF UNDERSTANDING, GREAT FALLS</u> <u>BASEBALL CLUB.</u>

Park and Recreation Director Marty Basta reported that the Great Falls Baseball Club Inc. ("GFBC") has made requests to the City Commission over the past couple of years to assist in financing the completion of the Centene stadium improvements. The stadium was built in the 1940's and is owned by the City. It has been leased to the GFBC in connection with a minor league baseball franchise since 1950. In October of 2002, major stadium renovations were awarded to bring the stadium up to current minor league baseball standards. The GFBC has provided significant economic contribution to the City and has provided great family entertainment value. The final phase of the stadium renovation has been estimated to cost \$1.46 million. Staff was directed to seek funding options for the stadium improvements in conjunction with the GFBC. GFBC is requesting funding from the City in the amount of \$345,772. The remainder of the \$1.4 million project to complete renovations to the City's baseball stadium would be paid directly by the GFBC or with grant funds.

At the January 11, 2010, Park and Recreation Advisory Board meeting, a request was made by the GFBC to fund 50% or \$172,886 of the City's share of the stadium renovation project from the Park Trust Fund. The Park Trust Fund provides for capital improvements to parks and derives its revenues from park land leases, the sale of park land and cash in lieu of park land as outlined in § 76-3-621, MCA. The stadium is located in Legion Park. The Park and Recreation Board unanimously approved the request.

Memorandum of Understanding, Great Falls Baseball Club. Approved as amended. The \$172,886 balance of the City's share of the \$1.46 million project will be borrowed from the Central Garage Equipment Replacement Fund over eight years at an interest rate of 3.25%. This interest rate is greater than interest earnings being realized by the Central Garage Fund at this time. The loan would be paid back to the Central Garage Fund utilizing the annual stadium lease payment paid by the GFBC of \$8,800 and the Pasta Montana annual lease payment of \$18,000. The stadium lease payments are currently going into the General Fund while the Pasta Montana lease payments are going into the Park Trust Fund. As a condition of the MOU, the City's funds will not be released until the GFBC has raised the balance of the funds for the project and provided proof of same to the City's satisfaction. The City will endeavor to partner with the GFBC to use the stadium for outdoor events and concerts which would generate additional revenues.

Commissioner Jones moved, seconded by Commissioner Bronson, that the City Commission approve the Memorandum of Understanding with the Great Falls Baseball Club.

Mayor Winters asked if there were any inquiries from the public.

Ron Gessaman, 1006 36th Avenue NE, commented that the agenda report states that a 50 year lease was entered into on April 6, 1999, at an initial cost to the GFBC of \$58,000. The lease amount is scheduled to increase 10% every 5 years for the life of the agreement. Mr. Gessaman inquired why GFBC's current lease payment is only \$8,800. Additionally, he suggested a time limit be set forth in the MOU for GFBC to raise \$1,150,000.

City Manager Gregory T. Doyon explained that when the MOU was being drafted, the expectation was that it wouldn't take GFBC too long to raise the funds, but a timeframe was a good suggestion.

Vinney Purpura, President of the Great Falls Baseball Club, residing at 127 Hawk Drive, commented that it is the GFBC's intention to raise the additional funds needed by a private placement of securities and to do so immediately. Following all of the legal requirements, his belief is that the funds will be secured within 90 days. Mr. Purpura added that if he has, in fact, guarantees from those investors, those investors would be willing to commit to the GFBC immediately a loan of funds to allow construction to begin as quickly as possible. If the MOU is approved, the GFBC is prepared to meet with architects and potential builders and have something in place by the end of February.

Commissioner Burow requested clarification of the time limit when the funds would be available, and was informed by Mr. Purpura within the next 90 days.

Mr. Doyon suggested that 120 day language be added to the MOU. If the GFBC funding isn't completed within that timeframe, it will come back

before the Commission.

Commissioner Jones moved, seconded by Commissioner Bronson, that the City Commission approve the Memorandum of Understanding with the Great Falls Baseball Club, with the amendment to the last sentence in paragraph 4 by inserting the words "within 120 days."

Brett Doney, Great Falls Development Authority, residing at 3048 Delmar Drive, applauded the City, GFBC, and Park Trustees.

Amended Motion carried 5-0.

Commissioner Burow inquired and Mr. Doyon responded that he would follow up Mr. Gessaman's question why the GFBC current lease payment is \$8,800 instead of \$9,600 and will report back to the Commission.

NEW BUSINESS

5. <u>MEMORANDUM OF UNDERSTANDING, MONTANA</u> <u>HIGHWAY PATROL.</u>

Police Chief Cloyd Grove reported for years there has been an informal agreement in place that certain portions of roadway will be investigated by either the MHP or the GFPD regardless of whether it is included within the City limits of Great Falls. This practice has been followed in order to provide a timely response to the citizens. Because of the nature of some roadways, completely surrounded by City limits yet a portion of the roadway is out of the City limits, it is only practical to have the Great Falls Police Department take enforcement responsibilities. Enforcement of these areas will provide a consistent and timely response to any incident at that location. By formalizing this long standing agreement it will clarify for both agencies and the Dispatch Center any issues that may arise in the future regarding calls for service and enforcement responsibilities.

Commissioner Bronson moved, seconded by Commissioner Jones, that the City Commission approve the Memorandum of Understanding between the Great Falls Police Department and Montana Highway Patrol and authorize the City Manager and Police Chief to sign the Memorandum of Understanding.

Mayor Winters asked if there was any discussion amongst the Commissioners or inquiries from the public. Hearing none, Mayor Winters called for the vote.

Motion carried 5-0.

Memorandum of Understanding, Montana Highway Patrol. Approved. Six New 2010 Police Pursuit Vehicles. Bid awarded to City Motors of Great Falls.

6. BID AWARD, SIX NEW 2010 POLICE PURSUIT VEHICLES.

Police Chief Cloyd Grove reported that every year some of the patrol fleet is replaced. The replaced vehicles are then placed in a secondary line of the fleet. This year, two bids were received. City Motors of Great Falls was the low bidder.

Public Works Director Jim Rearden added that the bids came in about \$5,000 less than the comparable bids from last year.

Commissioner Jones moved, seconded by Commissioner Bronson, that the City Commission approve the bid award for six new 2010 police pursuit vehicles to City Motors of Great Falls for \$130,385.

Mayor Winters asked if there was any discussion amongst the Commissioners or inquiries from the public. Hearing none, Mayor Winters called for the vote.

Motion carried 5-0.

Consecutive System Agreement. Approved.

7. <u>CONSECUTIVE SYSTEM AGREEMENT OFFERED TO</u> <u>CONSECUTIVE WATER SYSTEMS.</u>

Public Works Director Jim Rearden reported that under federal and state law mobile home parks of a certain size, 15 service connections or larger, are considered public water systems. Along with that designation come certain sampling and reporting requirements. Under a recently enacted state administrative rule, mobile home parks are excluded from some of these requirements if the mobile home park purchases its water from a larger utility. To be eligible for these exclusions, the mobile home park or consecutive system, as they are referred to in state law, must have a written agreement with its water provider. The City has been contacted by three different mobile home park owners to date to enact this agreement. The proposed consecutive system agreement requires the City to include the population of the consecutive system when determining sampling and reporting requirements, and also to provide the system owner with public notices and a Consumer Confidence Report. The City already does these things and, therefore, there is not additional burden or expense to the City as a result of this agreement. The agreement in no way makes the City responsible for the mobile home parks' internal systems. It simply removes duplication requirements for some of the City's users.

Commissioner Burow moved, seconded by Commissioner Jolley, that the City Commission approve the Consecutive System Agreement and allow it to be offered to Consecutive Water Systems for their consideration. Mayor Winters asked if there was any discussion amongst the Commissioners or inquiries from the public. Hearing none, Mayor Winters called for the vote.

Motion carried 5-0.

With the exception of Agenda Item 9 to address separately, Commissioner Jolley moved, seconded by Commissioner Burow, that the City Commission approve the Consent Agenda as presented.

With regard to Item 9, Commissioner Jolley inquired if the payment for December energy supply expense to Southern in the amount of \$138,832.01 was a partial payment. Fiscal Services Director Coleen Balzarini responded that the initial payment of \$650,000 is usually made on the 10th of each month, and this payment is to settle up the difference.

Commissioner Jolley inquired about the cash on deposit payment. Ms. Balzarini responded that the City still has to come up to the full amount of one month's deposit. Now that the City is at the full blended rate, a discussion will need to take place about how the City is to come up to the full deposit amount. Commissioner Jolley inquired who would be discussing that matter. Ms. Balzarini responded that she believes it is already in the rate rider, but will call Mr. Gregori and report back to the Commission.

Commissioner Jolley commented that all consent agenda items could be voted on.

Mayor Winters asked if there were any inquiries from the public.

Ron Gessaman, 1006 36th Avenue NE, inquired why the \$6,000 bond counsel payment wasn't listed on Item 9. Mr. Gessaman also commented that the transition period ended one year earlier than the time period specified in Rate Rider #2.

Ms. Balzarini responded that counsel was contacted regarding monthly invoicing. Payments to bond counsel will appear monthly hereafter. She explained that the transition rate had to do with when the City's former pass-through rate crossed over with the rates charged by Southern Montana to its other members. That cross-over has now occurred. It was first anticipated that it would go through 2010. Due to increased rates, imbalance market and the economy, the cross-over period occurred sooner than anticipated.

Mr. Gessaman requested staff inform him where the cross-over provision is in Rate Rider #2.

Commissioner Jolley noted that the Minutes of February 2, 2010, were corrected and re-posted clarifying the proposed water rate increase was 5%, sewer 7.5% and no increase in storm drain rates.

With regard to Item 13, Mr. Gessaman expressed concern that the agreement appears to put off the extension of 11th Street NE another five years, and inquired whether the surety bond on the 1st Phase of that section of road has been posted. Mr. Haynes responded that he would check on the status of the surety bond. The reason for the extension is that state statute limits preliminary plats to three years. Due the economy and size of the project, staff is allowing more time to complete the project.

Motion carried 5-0.

Staff Recommendation:

Staff recommends the City Commission set a public hearing for March 2, 2010, to consider approval of leases of Wadsworth Park with the Great Falls Saddle Club, Electric City Archers and Missouri River Shooters.

Background:

As required by Title 3, Chapter 13, OCCGF, before final consideration of lease of City Property, the City Commission shall hold a public hearing to receive comment regarding such a lease.

The Great Falls Saddle Club, Electric City Archers, and Missouri River Shooters have requested the City continue their leases for Wadsworth Park. The five year leases include an annual fee of \$375 for the Great Falls Saddle Club; \$150 for Electric City Archers; and \$180 for Missouri River Shooters. All leases are for a term of five years with an automatic renewal for an additional five years at the City's sole discretion. Both the City and the Lessee have the option to terminate the lease with sixty (60) days written notice.

On December 1, 1998 the City Commission approved Resolution 8973, Wadsworth Park Master Plan. It was recommended at that time that "all existing leases continue in Wadsworth Park, renewable on a year to year basis, until the City is ready to begin actual physical implementation of the Master Plan". Currently there is no funding available for capital improvements in Wadsworth Park.

Prior to the completion of the Wadsworth Park Master Plan, the leases for use of Wadsworth Park were five (5) year leases. In 2000, those leases were all renewed on a year to year basis up to a maximum of five (5) years. In 2006, the City Commission approved two year leases with the above organizations, with an automatic two year renewal. Since there is no immediate identifiable funding source for improvements to Wadsworth Park, staff is recommending five year leases with a five year renewal option.

Concurrences:

The Park and Recreation Advisory Board recommended approval of the leases at their regular meeting on February 8, 2010.

Fiscal Impact:

The annual lease payment will go to the General Fund.

Alternatives:

The alternative would be to not approve the leases and require the groups to find other options to conduct their activities.

Staff Recommendation: Approve construction contract award.

Background:

Significant Impacts

This project will address several maintenance issues and upgrades at the Wastewater Treatment Plant that had been recommended by the master plan and further defined by a study done by NCI Engineering (NCI).

Workload Impacts

NCI completed the project design and will perform construction inspection and contract administration duties. City Engineering Staff and Veolia staff will assist with project administration duties

Purpose / Project Work Scope

This construction project comprises several different elements. 1) Areas in the Dissolved Air Floatation Thickener (DAFT) building have suffered extreme rusting and corrosion due to the caustic nature of the environment with the wastewater and the gases that are produced. Coatings in these areas have exceeded their useful design life and require replacement. These areas will be sandblasted and recoated to limit further corrosion and extend the life of the equipment and metal structures. 2) An electrical control panel located in the DAFT

building has also experienced corrosion. This control panel runs all the motorized equipment used in the DAFT building. The panel will be replaced and a ventilated enclosure constructed around it to minimize corrosion in the future. 3) A gravity thickened sludge line that ties into the building will also be replaced with this project. This piping is glass lined to better withstand corrosion, but the glass has deteriorated and has outlived its useful life. 4) The backflow prevention system at the Wastewater Plant will also be replaced. This system prevents process water from the plant from contaminating the potable water source. The existing system has become obsolete and requires an upgrade to meet Department of Environmental Quality (DEQ) regulations. The new design has been approved by the DEQ.

Evaluation and Selection Process

Four bids were received and opened for this project on February 3, 2010. The bids ranged from \$366,615.00 to \$538,225.00. The engineer's estimate was \$525,000.00. Dick Anderson Construction, Inc. submitted the low bid and executed all the necessary bid documents

Conclusion

City staff, along with the concurrence of our consultant NCI, recommends awarding the construction contract to Dick Anderson Construction, Inc. in the amount of \$366,615.00.

Fiscal Impact

The attached bid tabulation summarizes bids that were received. This project will be funded through capital sewer funds.

Alternatives:

The City Commission could vote to deny award of the construction contract.

"I move that the City Commission (approve/deny) the Amended Plat of Lot 1A, Block 418, Great Falls Original Townsite and the accompanying Findings of Fact, subject to applicant fulfilling stipulated conditions."

2. Mayor calls for a second, discussion, inquires from the public, and calls the vote.

Planning Board Recommendation: The Planning Board, during a meeting held January 26, 2010, passed a motion recommending the City Commission approve the Amended Plat of Lot 1A, Block 418, Great Falls Original Townsite and the accompanying Findings of Fact, subject to fulfillment of the following conditions:

- 1) correction of any errors or omissions on the Amended Plat that may be noted by staff including perpetuation of required utility easements; and
- 2) preparation of a certificate of title by a title company to be filed with the Amended Plat.

Background: The Planning and Community Development Office is in receipt of an application from Three W's Inc. to subdivide Lot 1A, Block 418, Original Townsite. Lot 1A consists of 5.854 acres, located along the west side of 3rd Street South between 2nd Avenue South and 5th Avenue South. The proposed Amended Plat divides the existing Lot 1A into a northerly 2.83 acre parcel and a southerly 3.024 acre parcel. The Applicant intends to sell the northerly parcel to Northwest Fencing which currently leases and occupies the site. The Applicant is negotiating to sell the southerly parcel to another party. Lot 1A and the existing buildings located thereon have been used for commercial sales, warehousing and salvage/recycling facilities for many years.

For additional information, please refer to the attached Vicinity/Zoning Map, aerial photo and a reduced copy of the Amended Plat.

City water mains exist in the abutting portions of 2nd Avenue South, 5th Avenue South and 3rd Street South. City sanitary sewer mains are located within public utility easements crossing Lot 1A along the westerly projections of 3rd, 4th and 5th Alleys South. A City storm sewer crosses Lot 1A along the westerly projection of 4th Avenue South.

The area within the Amended Plat is zoned M-2 Mixed-use transitional district. Current industrial uses and warehouses in M-2 districts are allowed to expand or to be re-established if damaged, provided development and appearance standards under the purview of the Design Review Board are met. Therefore, any new building construction or additions or substantial modifications to the exterior of the existing buildings within the Amended Plat will be subject to review and approval by the Design Review Board.

As mentioned earlier in the report, a portion of subject Lot 1A proposed to be subdivided, was occupied for many years by salvage/recycling businesses (Carl Weissman & Sons Inc. and Steel Etc.) while the remainder was used and continues to be used for storage by Northwest Fencing. The salvage/recycling operation included crushing of vehicles and machinery and recycling of batteries. Regarding the potential soil contamination of the site, staff recently contacted the Montana Department of Environmental Quality (DEQ) who has jurisdiction on this issue, seeking additional information. DEO provided to staff a copy of a Phase II Environmental Site Assessment (ESA) Report dated June, 2005 and covering subject Lot 1A, which was prepared by an engineering consultant retained by Three W's Inc. The purpose of the Report was to evaluate the potential for hazardous substances and/or petroleum products to exist in the scrape and storage vard on subject Lot 1A. Twenty two test pits were excavated and seventeen samples collected and analyzed. The investigation found the presence of hazardous substances and/or petroleum hydrocarbons in the debris laver covering subject Lot 1A. The Report recommended removal and proper disposal of the contaminated debris zone material and an investigation of the potential ground water impacts if impacted soil is discovered within 5 feet of groundwater during the removal activities. DEQ understands some surface soil was removed from the site in 2007 and disposed. However, DEQ believes further investigation of the site needs to take place which will involve further communications as well as follow-up actions. DEQ also indicated Northwest Fencing, the purchaser of the proposed northerly 2.83 acre parcel, is cognizant of the potential soil contamination on the site.

Concurrences: Public Works and Planning and Community Development staffs have reviewed and concur in approving the Amended Plat of Lot 1A, Block 418, Original Townsite.

Fiscal Impact: The City should not experience any additional fiscal impact as a result of approving subject Amended Plat.

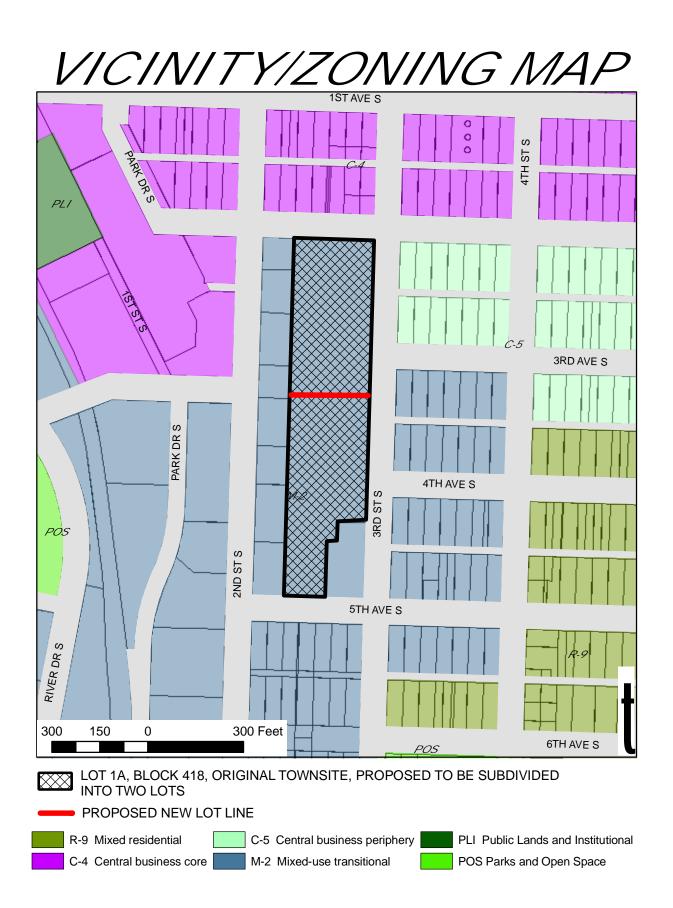
Alternatives: If there are justifiable reasons to do so, the City Commission could deny the Amended Plat to the extent allowed in City Code and State Statute.

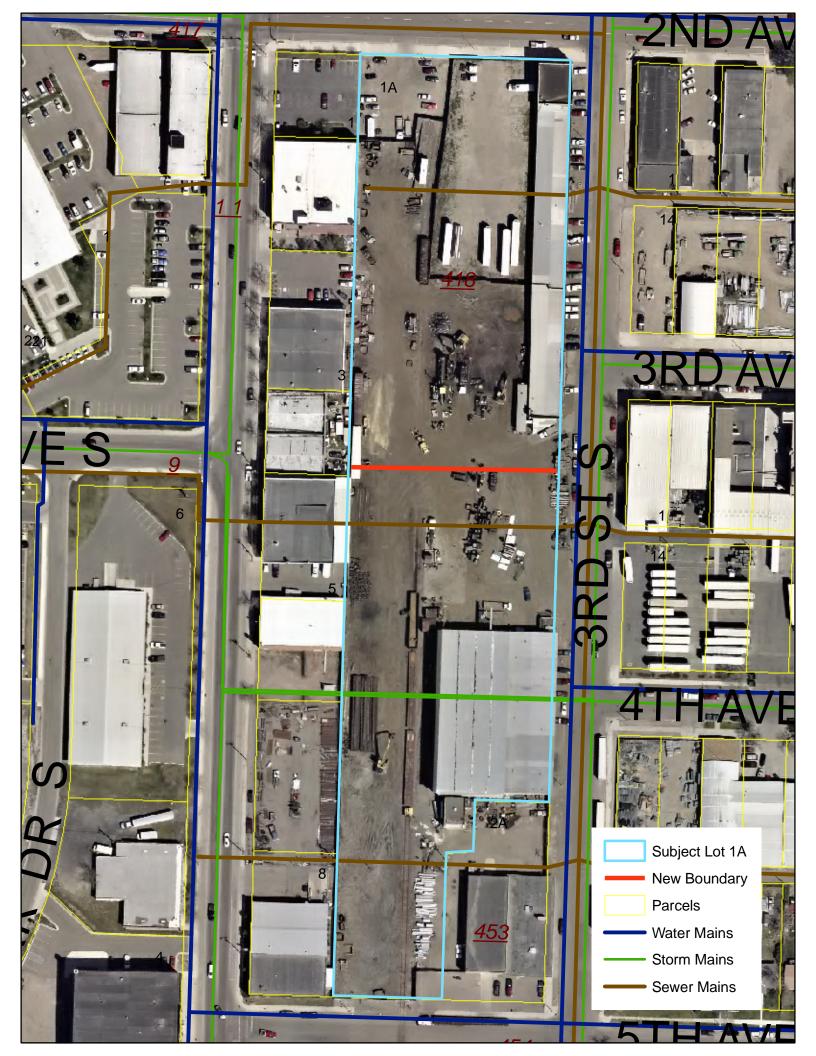

THE AMENDED PLAT OF LOT 1A OF THE AMENDED PLAT

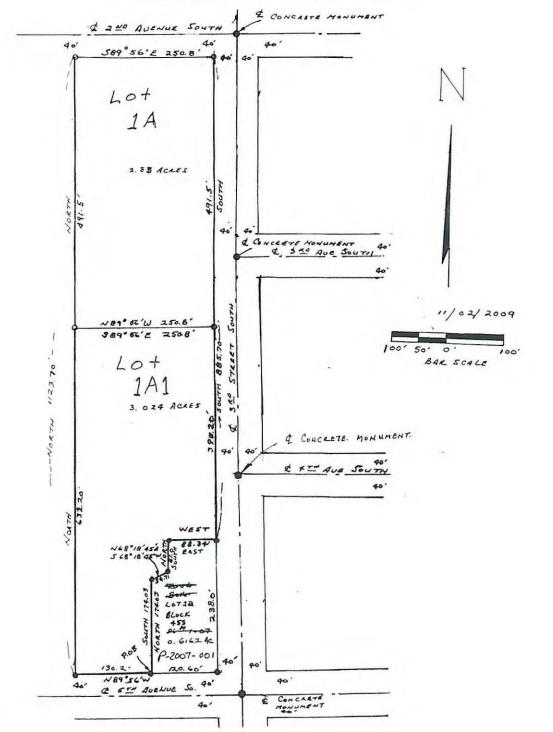

FINDINGS OF FACT AMENDED PLAT OF LOT 1A, BLOCK 418, ORIGINAL TOWNSITE, CITY OF GREAT FALLS, SECTION 12, T2ON, R3E CASCADE COUNTY, MONTANA (PREPARED IN RESPONSE TO 76-3-608(3)MCA)

I. PRIMARY REVIEW CRITERIA

Effect on Agricultural

The subdivision site is surrounded by urban development and has not been used for agricultural purposes. The subdivision site will not interfere with any irrigation system or present any interference with agricultural operations.

Effect on Local Services

The subdivision is within the City Limits of Great Falls and is served by the Great Falls Police and Fire Departments. Response distance for emergency fire vehicles is approximately a quarter of a mile. City water mains exist in the three rights-of-way abutting the Amended Plat: 2^{nd} Avenue South, 3^{rd} Street South, and 5^{th} Avenue South. City sanitary sewer mains are located within public utility easements crossing the Amended Plat at three locations. City storm sewer crosses the Amended Plat along the westerly projection of 4^{th} Avenue South.

Effect on the Natural Environment

Although it has been determined the soil within the Amended Plat have been contaminated by past operations conducted on the site, the subdivision itself is not expected to adversely affect soils or the water quality or quantity of surface or ground waters. Subject property is presently zoned "M-2" Mixed-use transitional district and used for warehousing and by a steel recycling and commercial sales operation.

Effect on Wildlife and Wildlife Habitat

The subdivision is surrounded by urban development. The subdivision is not in an area of significant wildlife habitat and will not result in closure of public access to hunting or fishing areas, nor to public lands.

Effect on Public Health and Safety

Subdivision of the involved property into two lots in and of itself will not effect public health and safety.

II. REQUIREMENTS OF MONTANA SUBDIVISION AND PLATTING ACT, UNIFORM STANDARDS FOR MONUMENTATION, AND LOCAL SUBDIVISION REGULATIONS

The subdivision meets the requirements of the Montana Subdivision and Platting Act and the surveying requirements specified in the Uniform Standards for Monumentation, and conforms to the design standards specified in the local subdivision regulations. The subdivider and the local government have complied with the subdivision review and approval procedures set forth in the local subdivision regulations.

III. EASEMENT FOR UTILITIES

Utilities are accommodated in the existing public street rights-of-way abutting the Amended Plat and in easements within the Amended Plat.

IV. LEGAL AND PHYSICAL ACCESS

Legal and physical access to the subdivision is provided by the abutting 2nd Avenue South to the north, 3rd Street South to the east and 5th Avenue South to the south, which are fully improved City maintained rights-of-way.
