# CITY OF GREAT FALLS COMMISSION AGENDA REPORT

**Item:** Six New 2013 Police Pursuit Vehicles

### **Suggested Motion:**

### 1. Commissioner moves:

"I move that the City Commission (approve/reject) the bid award for six new 2013 Chevrolet Impala police pursuit vehicles to City Motors of Great Falls for \$130,156."

2. Mayor calls for a second, discussion, public comment, and calls for the vote.

**Staff Recommendation:** Staff recommends that the City Commission approve the bid award for six new 2013 Chevrolet Impala police pursuit vehicles to City Motors of Great Falls for \$130,156.

### **Background:**

### **Workload Impacts**

The purchase of six new police pursuit vehicles is made each year. These vehicles are kept in police pursuit for four years, which places the odometer at 90,000 - 100,000 at the end of the four years.

#### Purpose

These units will be used by the Police Department.

### **Evaluation and Selection Process**

The specifications were advertised two times in the Great Falls Tribune, placed on the City of Great Falls website, and mailed to six prospective bidders. The bids were opened on October 17, 2012 with three bidders responding, one with an alternate bid. The six police pursuit vehicles being replaced will be transferred to other departments to be used as staff sedans or sold at a later date.

### Conclusion

The bid by City Motors of Great Falls meets specifications for the police pursuit vehicles.

**Fiscal Impact:** The purchase price for seven new police pursuit vehicles during FY 2012 was \$174,248. The total bid price difference from last year is a decrease of \$44,092. FY 2012 included one additional vehicle to replace one that was totaled in an accident. The difference in bid price per vehicle from last year is a decrease of \$3,199.90 or -12.85% less. Funds for this scheduled purchase from the ERS (Equipment Revolving Schedule) were provided in the FY 2013 Central Garage Budget.

**Alternatives:** Reject the bids for the purchase of six new 2013 police pursuit vehicles.
