Item: Purchase of Liquid Aluminum Sulfate

Action Requested: Approval of Bid

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission accept the low bid from Thatcher Company of Montana and authorize staff to purchase liquid aluminum sulfate in the amount of \$364.49 per dry ton for FY 2012/13."

2. Mayor calls for a second, discussion, inquiries from the public, and calls the vote.

Staff Recommendation: Staff recommends that the City Commission accept the low bid from Thatcher Company of Montana in the amount of \$364.49 per dry ton for liquid aluminum sulfate for FY 2012/13.

Background: Liquid aluminum sulfate is used in the water treatment process to coagulate suspended particles in the raw water stream to allow their removal. Specifications and bid materials were prepared for the purchase of liquid aluminum sulfate for the Water Treatment Plant for the upcoming fiscal year. Notices were sent out to all prospective bidders and publicly advertised. The bid from Thatcher Company of Montana, was acceptable as submitted.

Bids were accepted on May 16, 2012 for FY 2012/13 Water Treatment Plant chemical needs. Thatcher Company of Montana, with headquarters in Salt Lake City Utah, provided the lowest acceptable bid for liquid aluminum sulfate at \$364.49 per dry ton. This Commission action would award a contract for FY 2012/13.

Concurrences: not applicable

Fiscal Impact: This price reflects a 13.6% increase from the FY 2011/12 contract price. The new contract would allow for the purchase of a maximum of 800 dry tons for a total cost of \$291,592.
