Action Requested: Adoption of Resolution 10021

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission (adopt/deny) Resolution 10021."

2. Mayor calls for a second, discussion, inquiries from the public, and calls for the vote.

Staff Recommendation: Staff recommends adoption of Resolution 10021, authorizing the issuance and fixing the terms of a \$14,168,000 Series 2013 Bond.

Background: At the March 6, 2012 City Commission Work Session, as part of the Water, Sewer, and Storm Drain rate increase presentation the Public Works Department discussed the many wastewater upgrades needed at the Wastewater Treatment Plant due to the Montana Pollutant Discharge Elimination System (MPDES) permit. The Public Works Department and contracted engineers from HDR Engineering and Morrison-Maierle Engineering went into great detail about what construction would be required to meet the permit requirements. Public Works and HDR Engineering and Morrison-Maierle Engineering also did an additional presentation on April 10, 2012 for the public. The cost of these upgrades is estimated to be close to \$18.7 million.

As part of these upgrades, the City Commission approved an amended professional service contract with HDR Engineering, Inc. on March 20, 2012 for design work and to conduct the bidding process and construction inspection services on upgrades at the Wastewater Treatment Plant for a cost not to exceed \$3,491,864. Series 2012 Bonds for \$3,800,000 were issued to cover

the expenses under this contract plus additional expenses for issuance costs, fees, and reserve requirements.

At the March 5, 2013 City Commission Work Session, as part of the Water, Sewer, and Storm Drain rate increase presentation the Public Works Department discussed the many wastewater upgrades needed at the Wastewater Treatment Plant due to the Montana Pollutant Discharge Elimination System (MPDES) permit. The Public Works Department and contracted engineers from HDR Engineering and Morrison-Maierle Engineering went into great detail about what construction would be required to meet the permit requirements.

At the May 7, 2013 City Commission Meeting, a contract in the amount of \$14,346,582 was awarded to Swank Enterprises for the Wastewater Treatment Plant Disinfection and Ammonia Removal Improvements. Resolution 10021 authorizes the issuance of bonds to cover the expenses under this contract plus additional expenses for issuance costs, fees, and reserve requirements.

DNRC has since submitted a letter of approval for a loan to the City of Great Falls in the amount of \$14,168,000 at 3.00% per annum for 20 years. All issuance fees and costs will be paid out of this financing. Pending completion of the financing process, cash balances in the Wastewater fund will provide sufficient cash to pay upfront expenses. Staff anticipates the bond closing on/or before June 26, 2013. Existing city funds of \$1,692,982 will also be used for this project.

Dorsey & Whitney, LLC will serve as bond counsel. In this capacity, they prepare necessary documents requiring action by the City Commission and staff, and the DNRC. They will also provide assurance that the procedures used to issue the bonds are in compliance with rules and regulations regarding the issuance of tax exempt revenue bonds, and also in compliance with existing bond ordinances of the outstanding Wastewater System Revenue Bonds of the City.

Fiscal Impact: The Wastewater utility rates, implemented in May 2013, are capable of supporting this debt issuance. Total yearly debt service payments (principal and interest) will be approximately \$911,700.

Alternatives: The City Commission may deny passage of the resolution and the issuance of debt.

RESOLUTION NO. 10021

RESOLUTION RELATING TO \$14,168,000 SANITARY SEWERAGE SYSTEM REVENUE BONDS (DNRC WATER POLLUTION CONTROL STATE REVOLVING LOAN PROGRAM), CONSISTING OF \$7,084,000 SERIES 2013A BOND AND \$7,084,000 SERIES 2013B BOND; AUTHORIZING THE ISSUANCE AND FIXING THE TERMS AND CONDITIONS THEREOF

WHEREAS, pursuant to the Montana Water Pollution Control State Revolving Fund Act, Montana Code Annotated, Title 75, Chapter 5, Part 11, as amended (the "State Act"), the State of Montana (the "State") has established a revolving loan program (the "Program") to be administered by the Department of Natural Resources and Conservation of the State of Montana, an agency of the State (the "DNRC"), and by the Department of Environmental Quality of the State of Montana, an agency of the State (the "DEQ"), and has provided that a water pollution control state revolving fund (the "Revolving Fund") be created within the state treasury and all federal, state and other funds for use in the Program be deposited into the Revolving Fund, including, but not limited to, all federal grants for capitalization of a state water pollution control revolving fund under the Federal Water Pollution Control Act (the "Clean Water Act"), all repayments of assistance awarded from the Revolving Fund, interest on investments made on money in the Revolving Fund and payments of principal of and interest on loans made from the Revolving Fund; and

WHEREAS, the State Act provides that funds from the Program shall be disbursed and administered for the purposes set forth in the Clean Water Act and according to rules adopted by the DEQ and the DNRC; and

WHEREAS, the City of Great Falls, Cascade County, Montana (the "Borrower") has applied to the DNRC for the 2013 Loans (as hereinafter defined) from the Revolving Fund to enable the Borrower to finance, refinance or reimburse itself for the costs of the 2013 Project (as hereinafter defined), which will carry out the purposes of the Clean Water Act; and

WHEREAS, the Borrower is authorized under applicable laws, ordinances and regulations to adopt this Supplemental Resolution and to issue the Series 2013 Bonds (as hereinafter defined) to evidence the 2013A Loan and 2013B Loan (each as hereinafter defined) for the purposes set forth herein; and

WHEREAS, the DNRC will fund the 2013A Loan with Recycled Money (as hereinafter defined), and will fund the 2013B Loan with either Recycled Money or with proceeds of the State's General Obligation Bonds (Water Pollution Control State Revolving Fund Program) (the "State Bonds") and funds provided by the United States Environmental Protection Agency.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, AS FOLLOWS:

Article I DEFINITIONS, RULES OF CONSTRUCTION AND APPENDICES

Section 1.1 <u>Definitions</u>. Unless a different meaning clearly appears from the context, terms used with initial capital letters but undefined in this Supplemental Resolution shall have the meanings given them in the Original Resolution, the Indenture, or as follows:

"Accountant" or "Accountants" means an independent certified public accountant or a firm of independent certified public accountants satisfactory to the DNRC.

"Act" means Montana Code Annotated, Title 7, Chapter 7, Parts 44 and 45, as heretofore and hereafter amended or supplemented.

"Additional Bonds" means any Bonds issued pursuant to Section 6.01 of the Original Resolution.

"Administrative Expense Surcharge" means a surcharge equal to seventy-five hundredths of one percent (0.75%) per annum on the outstanding principal amount of the 2013 Loans from the date of each advance thereof, payable by the Borrower on a Payment Date.

"Authorized DNRC Officer" means the Director or Deputy Director of the DNRC, and, when used with reference to an act or document, also means any other individual authorized by resolution of the Department of Natural Resources and Conservation to perform such act or sign such document. If authorized by the Department of Natural Resources and Conservation, an Authorized DNRC Officer may delegate all or a portion of his authority as an Authorized DNRC Officer to another individual, and such individual shall be deemed an Authorized DNRC Officer for purposes of exercising such authority.

"Bond Counsel" means any Counsel acceptable to the DNRC which is nationally recognized as bond counsel. Counsel is nationally recognized as bond counsel if it has rendered a legal opinion as to the validity and enforceability of state or municipal bonds and as to the exclusion of interest thereon from gross income for federal income tax purposes (short-term issues excluded) during the two-year period preceding the date of determination.

"Bonds" means the Series 2002B Bond, Series 2005 Bonds, Series 2009B Bond, Series 2012 Bond, Series 2013 Bonds and any Additional Bonds.

"Borrower" means the City of Great Falls, Montana and its permitted successors or assigns hereunder.

"Business Day" means any day which is not a Saturday or Sunday, a legal holiday in the State or a day on which banks in Montana are authorized or required by law to close.

"City" means the City and its permitted successors or assigns hereunder.

"Clean Water Act" means the Federal Water Pollution Control Act, 33 U.S.C. §§ 1251-1387, as amended, and all regulations, rules and interpretations issued by the EPA thereunder.

"Closing" means the date of delivery of the Series 2013 Bonds to the DNRC.

"Collateral Documents" means any security agreement, guaranty or other document or agreement delivered to the DNRC securing the obligations of the Borrower under this Supplemental Resolution and the Series 2013 Bonds. If no Collateral Documents secure such obligations, any reference to Collateral Documents in this Supplemental Resolution shall be without effect.

"Code" means the Internal Revenue Code of 1986, as amended.

"Commission" means the City Commission of the City of Great Falls, Montana.

"Committed Amounts" means the amount of the 2013A Committed Amount and the 2013B Committed Amount.

"Construction Account" means the account created in the Sanitary Sewerage System Fund pursuant to Section 7.02 of the Original Resolution.

"Consultant" means a nationally recognized consultant or firm of consultants, or an independent engineer or firm of independent engineers, or an Accountant, which in any case is qualified and has skill and experience in the preparation of financial feasibility studies or projections for facilities similar to the System or the 2013 Project, selected by the Borrower and satisfactory to the DNRC.

"Counsel" means an attorney duly admitted to practice law before the highest court of any state and satisfactory to the DNRC.

"Debt" means, without duplication, (1) indebtedness of the Borrower for borrowed money or for the deferred purchase price of property or services; (2) the obligation of the Borrower as lessee under leases which should be recorded as capital leases under generally accepted accounting principles; and (3) obligations of the Borrower under direct or indirect guarantees in respect of, and obligations (contingent or otherwise) to purchase or otherwise acquire, or otherwise to assure a creditor against loss in respect of, indebtedness or obligations of others of the kinds referred to in clause (1) or (2) above.

"Debt Service Account" means the account created in the Sanitary Sewerage System Fund pursuant to Section 7.04 of the Original Resolution.

"DEQ" means the Department of Environmental Quality of the State of Montana, an agency of the State, or any successor to its powers, duties and obligations under the State Act or the EPA Agreements.

"DNRC" means the Department of Natural Resources and Conservation of the State of Montana, an agency of the State, and any successor to its powers, duties and obligations under the State Act.

"EPA" means the Environmental Protection Agency, an agency of the United States of America, and any successor to its functions under the Clean Water Act.

"EPA Agreements" means all capitalization grant agreements and other written agreements between the DEQ, the DNRC and the EPA concerning the Program.

"EPA Capitalization Grant" means a grant of funds to the State by the EPA under Title VI of the Clean Water Act and any grant made available by the EPA for deposit in the Revolving Fund pursuant to Section 205(m) of the Clean Water Act.

"Estimated Completion Date" means December 31, 2014, the date by which it is estimated by the Borrower that the 2013 Project will be substantially completed.

"Fund" means the Sanitary Sewerage System Fund established pursuant to Section 7.01 of the Original Resolution.

"Governmental Unit" means governmental unit as such term is used in Section 145(a) of the Code.

"Indenture" means the Indenture of Trust, dated as of May 1, 1998, between the Board of Examiners of the State and the Trustee, as such may be supplemented or amended from time to time in accordance with the provisions thereof, pursuant to which, among other things, the State Bonds are to be or have been issued.

"Loan Loss Reserve Surcharge" means a surcharge equal to twenty-five hundredths of one percent (0.25%) per annum on the outstanding principal amount of the 2013 Loans from the date of each advance thereof, payable by the Borrower on a Payment Date.

"Loan Repayments" means periodic installments of principal and interest by Borrower in repayment of the 2013 Loans, at the rates and times specified in Article V.

"Operating Account" means the account created in the Sanitary Sewerage System Fund pursuant to Section 7.03 of the Original Resolution.

"Original Resolution" means Resolution No. 9227, adopted by this Commission on May 7, 2002, as amended and supplemented by the Series 2002B Bond Resolution, the Series 2005 Bond Resolution, the Series 2009 Bond Resolution, the Series 2012 Bond Resolution and Resolution 9999, adopted by this Commission on November 20, 2012.

"Payment Date" means, with respect to the Series 2013 Bonds, each January 1 and July 1 during the term of the Series 2013 Bonds on which a payment of interest or principal and interest is due, as determined under the Resolution. The term "Payment Date" as used in this Supplemental Resolution in respect of the Series 2013 Bonds has the same meaning as "Stated Maturity" in the Original Resolution.

"Program" means the Water Pollution Control State Revolving Loan Program established by the State Act.

"Project" means an improvement, betterment, reconstruction or extension of the System, including the 2013 Project.

"Public Entity" means a State agency, city, town, municipality, irrigation district, county water and sewer district, a soil conservation district or other public body established by State law or an Indian tribe that has a federally recognized governing body carrying out substantial governmental duties and powers over any area.

"Recycled Money" means payments and prepayments of principal of loans made under the Program, and any other amounts transferred to the Principal Subaccount in the Revenue Subaccount in the State Allocation Account (as such terms are defined in the Indenture).

"Regulations" means the Treasury Department, Income Tax Regulations, as amended or any successor regulation thereto, promulgated under the Code or otherwise applicable to the Series 2013 Bonds.

"Repair and Replacement Account" means the Account created in the Sanitary Sewerage System Fund pursuant to Section 7.07 of the Original Resolution.

"Reserve Account" means the account created in the Sanitary Sewerage System Fund pursuant to Section 7.05 of the Original Resolution.

"Reserve Requirement" has the meaning given in the Original Resolution.

"Resolution" means the Original Resolution, as amended and supplemented by this Supplemental Resolution and other supplemental resolutions adopted pursuant to Article IX of the Original Resolution.

"Sanitary Sewerage System Fund" means the fund created by Section 7.01 of the Original Resolution.

"Series 2002B Bond" means the City's First Amended and Restated Sanitary Sewerage System Revenue Bond (DNRC Revolving Loan Program), Series 2002B, issued in the maximum authorized principal amount of \$5,590,000 pursuant to the Original Resolution, as then in effect.

"Series 2002B Bond Resolution" means Resolution No. 9228, adopted by the City Commission of the City on May 7, 2002.

"Series 2005 Bonds" means the City's Sanitary Sewerage System Revenue Bonds, Series 2005, issued in the original principal amount of \$5,005,000 pursuant to the Original Resolution, as then in effect.

"Series 2005 Bond Resolution" means Resolution No. 9454, adopted by the City Commission of the City on January 18, 2005.

"Series 2009 Bond Resolution" means Resolution No. 9863, adopted by the City Commission of the City on September 1, 2009.

"Series 2009B Bond" means the City's Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2009B, issued in the

maximum authorized principal amount of \$359,300 pursuant to the Original Resolution, as then in effect.

"Series 2012 Bond Resolution" means Resolution No. 9986, adopted by the City Commission of the City on July 17, 2012.

"Series 2012 Bond" means the City's Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2012, issued in the maximum authorized principal amount of \$3,800,000 pursuant to the Original Resolution, as then in effect.

"Series 2013 Bonds" means the Series 2013A Bond and the Series 2013B Bond.

"Series 2013A Bond" means the City's \$7,084,000 Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2013A, issued to the DNRC to evidence the Series 2013A Loan.

"Series 2013B Bond" means the City's \$7,084,000 Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2013B, issued to the DNRC to evidence the Series 2013B Loan.

"State" means the State of Montana.

"State Act" means Montana Code Annotated, Title 75, Part 5, Chapter 11, as amended from time to time.

"State Bonds" means the State's General Obligation Bonds (Water Pollution Control State Revolving Fund Program), issued or to be issued pursuant to the Indenture.

"Supplemental Resolution" means this Resolution No. 10021 of the Borrower adopted pursuant to Article IX of the Original Resolution.

"Surplus Account" means the account in the Sanitary Sewerage System Fund pursuant to Section 7.08 of the Original Resolution.

"System" means the sanitary sewerage system of the Borrower and all extensions, improvements and betterments thereof heretofore or hereafter constructed and acquired.

"Trustee" means U.S. Bank National Association, in Seattle, Washington, or any successor trustee under the Indenture.

"2013 Loans" means the 2013A Loan and the 2013B Loan.

"2013A Committed Amount" means the amount of the 2013A Loan committed to be lent by the DNRC to the Borrower pursuant to Section 4.1 of this Supplemental Resolution, as such amount may be reduced pursuant to Sections 3.2 and 3.4 of this Supplemental Resolution.

- "2013B Committed Amount" means the amount of the 2013B Loan committed to be lent by the DNRC to the Borrower pursuant to Section 4.1 of this Supplemental Resolution, as such amount may be reduced pursuant to Sections 3.2 and 3.4 of this Supplemental Resolution.
- "2013A Loan" means the loan made to the Borrower by the DNRC pursuant to the Program in the maximum amount of the 2013A Committed Amount to provide funds to pay all or a portion of the costs of the 2013 Project, to fund a deposit to the Reserve Account and to pay costs associated with the sale and issuance of the Series 2013A Bond.
- "2013B Loan" means the loan made to the Borrower by the DNRC pursuant to the Program in the maximum amount of the 2013B Committed Amount to provide funds to pay all or a portion of the costs of the 2013 Project, to fund a deposit to the Reserve Account and to pay costs associated with the sale and issuance of the Series 2013B Bond.
- "2013B First Advance" means the first advance of funds of the 2013B Loan by the DNRC to the Borrower.
- "2013 Project" means the designing and engineering of the facilities, improvements and activities financed, refinanced or the cost of which is being reimbursed to the Borrower with proceeds of the 2013 Loans, described in Appendix A hereto.
- "Undisbursed Committed Amount" means any undisbursed Committed Amount which is not required to pay costs of the 2013 Project upon completion thereof as provided in Section 3.4(b) of this Supplemental Resolution.
- Section 1.2 <u>Other Rules of Construction</u>. For all purposes of this Supplemental Resolution, except where the context clearly indicates otherwise:
 - (a) All accounting terms not otherwise defined herein have the meanings assigned to them in accordance with generally accepted government accounting standards.
 - (b) Terms in the singular include the plural and vice versa.
 - (c) All references to time shall refer to Helena, Montana time, unless otherwise provided herein.
 - (d) All references to mail shall refer to first-class mail postage prepaid.
 - (e) Words of the masculine gender shall be deemed and construed to include correlative words of the feminine and neuter genders.
 - (f) "Or" is not exclusive, but is intended to permit or encompass one, more or all of the alternatives conjoined.
- Section 1.3 <u>Appendices</u>. Attached to this Supplemental Resolution and hereby made a part hereof are the following Appendices:

Appendix A: a description of the 2013 Project;

Appendix B-1: the form of the Series 2013A Bond;

Appendix B-2: the form of the Series 2013B Bond; and

<u>Appendix C</u>: additional agreements and representations of the Borrower.

Article II AUTHORIZATION, FINDINGS, REPRESENTATIONS AND COVENANTS

Section 2.1 <u>Authorization and Findings</u>.

- (a) <u>Authorization</u>. Under the provisions of the Act, the Borrower is authorized to issue and sell its revenue bonds payable during a term not exceeding forty years from their date of issue, to provide funds for the reconstruction, improvement, betterment and extension of the System or to refund its revenue bonds issued for such purpose; provided that the bonds and the interest thereon are to be payable solely out of the net income and revenues to be derived from rates, fees and charges for the services, facilities and commodities furnished by the undertaking, and are not to create any obligation for the payment of which taxes may be levied except to pay for services provided by the undertaking to the Borrower.
- (b) <u>The System</u>. The Borrower, pursuant to the Act and other laws of the State, has established and presently owns and operates the System.
- (c) <u>The 2013 Project</u>. After investigation of the facts and as authorized by the Act, this Commission has determined it to be necessary and desirable and in the best interests of the Borrower to acquire and construct the 2013 Project.
- (d) <u>Outstanding Bonds</u>. Pursuant to the Act and the Resolution, the Borrower has issued, and has outstanding, Series 2002B Bond, Series 2005 Bonds, Series 2009B Bond and Series 2012 Bond. The Series 2002B Bond, Series 2005 Bonds, Series 2009B Bond and Series 2012 Bond are payable from Net Revenues of the System, and no other bonds or indebtedness are outstanding that are payable from or secured by revenues of the System.
- (e) Additional Bonds. The Borrower reserved the right under Section 6.01 of the Original Resolution to issue Additional Bonds to finance the cost or estimated cost of providing any improvement, extension or rehabilitation of the System; provided that if the Additional Bonds are issued to finance a project, a certificate is to be signed by an Independent Consultant stating that on the date of issuance of such Additional Bonds Net Revenues of the System meet the requirements set forth in Section 6.01 of the Original Resolution. Based on a certificate executed or to be executed by an Independent Consultant, it is hereby determined that the Borrower is authorized to issue the Series 2013A Bond in the maximum principal amount of \$7,084,000 and the Series 2013B Bond in the maximum principal amount of \$7,084,000 pursuant to Section 6.01 of the Original Resolution, with the Series 2013 Bonds payable from and secured by the

Net Revenues on a parity with the Outstanding Series 2002B Bond, Series 2005 Bonds, Series 2009B Bond and Series 2012 Bond.

Section 2.2 <u>Representations</u>. The Borrower represents as follows:

- (a) <u>Organization and Authority</u>. The Borrower:
- (i) is duly organized and validly existing as a municipal corporation of the State;
- (ii) has all requisite power and authority and all necessary licenses and permits required as of the date hereof to own and operate the System and to carry on its current activities with respect to the System, to adopt this Supplemental Resolution and to enter into the Collateral Documents and to issue the Series 2013 Bonds and to carry out and consummate all transactions contemplated by this Supplemental Resolution, the Series 2013 Bonds and the Collateral Documents;
 - (iii) is a Governmental Unit and a Public Entity; and
- (iv) has taken all proper action to authorize the execution, delivery and performance of its obligations under this Supplemental Resolution, the Series 2013 Bonds and the Collateral Documents and the incurrence of the Debt evidenced by the Series 2013 Bonds in the maximum amount of the Committed Amount.
- (b) <u>Litigation</u>. There is no litigation or proceeding pending, or to the knowledge of the Borrower threatened, against or affecting the Borrower in any court or before or by any governmental authority or arbitration board or tribunal that, if adversely determined, would materially and adversely affect the existence, corporate or otherwise, of the Borrower, or the ability of the Borrower to make all payments and otherwise perform its obligations under the Resolution, the Series 2013 Bonds and the Collateral Documents, or the financial condition of the Borrower, or the transactions contemplated by the Resolution, the Series 2013 Bonds and the Collateral Documents or the validity and enforceability of the Resolution, the Series 2013 Bonds and the Collateral Documents. No referendum petition has been filed with respect to any resolution or other action of the Borrower relating to the 2013 Project, the Series 2013 Bonds or any Collateral Documents and the period for filing any such petition will have expired before issuance of the Series 2013 Bonds.
- (c) <u>Borrowing Legal and Authorized</u>. The adoption of this Supplemental Resolution, the execution and delivery of the Series 2013 Bonds and the Collateral Documents and the consummation of the transactions provided for in this Supplemental Resolution, the Series 2013 Bonds and the Collateral Documents and compliance by the Borrower with the provisions of the Resolution, the Series 2013 Bonds and the Collateral Documents:
 - (i) are within the powers of the Borrower and have been duly authorized by all necessary action on the part of the Borrower; and

- (ii) do not and will not result in any breach of any of the terms, conditions or provisions of, or constitute a default under, or result in the creation or imposition of any lien, charge or encumbrance upon any property or assets of the Borrower pursuant to any ordinance, resolution, indenture, loan agreement or other agreement or instrument (other than the Resolution and any Collateral Documents) to which the Borrower is a party or by which the Borrower or its property may be bound, nor will such action result in any violation of the provisions of any laws, ordinances, governmental rules or regulations or court or other governmental orders to which the Borrower, its properties or operations are subject.
- (d) <u>No Defaults</u>. No event has occurred and no condition exists that, upon execution and delivery of the Series 2013 Bonds and the Collateral Documents, would constitute a default under the Resolution or the Collateral Documents. The Borrower is not in violation of any term of any agreement, bond resolution, trust indenture, charter or other instrument to which it is a party or by which it or its property may be bound which violation would materially and adversely affect the transactions contemplated hereby or the compliance by the Borrower with the terms hereof or of the Series 2013 Bonds and the Collateral Documents.
- (e) Governmental Consent. The Borrower has obtained or made all permits, findings and approvals required to the date of adoption of this Supplemental Resolution by any governmental body or officer for the making and performance by the Borrower of its obligations under this Supplemental Resolution, the Series 2013 Bonds and the Collateral Documents (including any necessary sewer rate increase) or for the 2013 Project, the financing or refinancing thereof or the reimbursement of the Borrower for the costs thereof. No consent, approval or authorization of, or filing, registration or qualification with, any governmental authority (other than those, if any, already obtained) is required on the part of the Borrower as a condition to adopting this Supplemental Resolution, issuing the Series 2013 Bonds or entering into the Collateral Documents and the performance of the Borrower's obligations hereunder and thereunder.
- (f) <u>Binding Obligation</u>. The Resolution, the Series 2013 Bonds and any Collateral Document to which the Borrower is a party are the valid and binding special, limited obligations and agreements of the Borrower, enforceable against the Borrower in accordance with their terms, except to the extent that the enforceability thereof may be limited by laws relating to bankruptcy, moratorium, reorganization, insolvency or similar laws affecting creditors' rights and general principles of equity.
- (g) <u>The 2013 Project</u>. The 2013 Project consists and will consist of the facilities, improvements and activities described in Appendix A, as such Appendix A may be amended from time to time in accordance with the provisions of Article III of this Supplemental Resolution.
- (h) <u>Full Disclosure</u>. There is no fact that the Borrower has not specifically disclosed in writing to the DNRC that materially and adversely affects or (so far as the

Borrower can now foresee), except for pending or proposed legislation or regulations that are a matter of general public information, that will materially and adversely affect the properties, operations and finances of the System, the Borrower's status as a Public Entity and Governmental Unit, its ability to own and operate the System in the manner it is currently operated or the Borrower's ability to perform its obligations under the Resolution, the Series 2013 Bonds and the Collateral Documents and to pledge any revenues or other property pledged to the payment of the Series 2013 Bonds.

(i) Compliance With Law. The Borrower:

- (1) is in compliance with all laws, ordinances, governmental rules and regulations and court or other governmental orders, judgments and decrees to which it is subject and which are material to the properties, operations and finances of the System or its status as a Public Entity and Governmental Unit; and
- (2) has obtained all licenses, permits, franchises or other governmental authorizations necessary to the ownership of the System and the operation thereof and agrees to obtain all such licenses, permits, franchises or other governmental authorizations as may be required in the future for the System and the operation thereof, which failure to obtain might materially and adversely affect the ability of the Borrower to conduct the operation of the System as presently conducted or the condition (financial or otherwise) of the System or the Borrower's ability to perform its obligations under the Resolution, the Series 2013 Bonds and the Collateral Documents.

Section 2.3 Covenants.

(a) Insurance. In addition to the requirements of Article VIII of the Original Resolution, the Borrower at all times shall keep and maintain with respect to the System property and casualty insurance and liability insurance with financially sound and reputable insurers, or self-insurance as authorized by State law, against such risks and in such amounts, and with such deductible provisions, as are customary in the State in the case of entities of the same size and type as the Borrower and similarly situated and shall carry and maintain, or cause to be carried and maintained, and pay or cause to be paid timely the premiums for all such insurance. Nothing herein shall be construed to prohibit or preclude the Borrower from self-insuring or participating in a self-insurance program in compliance with the provisions of Montana law. All such insurance policies shall name the DNRC as an additional insured to the extent permitted under the policy or program of insurance of the Borrower. Each policy must provide that it cannot be cancelled by the insurer without giving the Borrower and the DNRC 30 days' prior written notice. The Borrower shall give the DNRC prompt notice of each insurance policy it obtains or maintains to comply with this Section 2.3(a) and of each renewal, replacement, change in coverage or deductible under or amount of or cancellation of each such insurance policy and the amount and coverage and deductibles and carrier of each new or replacement policy. Such notice shall specifically note any adverse change as being an adverse change. The Borrower shall deliver to the DNRC at Closing a certificate providing the information required by this Section 2.3(a).

- (b) <u>Right of Inspection and Notice of Change of Location</u>. The DNRC, the DEQ and the EPA and their designated agents shall have the right at all reasonable times during normal business hours and upon reasonable notice to enter into and upon the property of the Borrower for the purpose of inspecting the System or any or all books and records of the Borrower relating to the System.
- (c) <u>Further Assurance</u>. The Borrower shall execute and deliver to the DNRC all such documents and instruments and do all such other acts and things as may be necessary or required by the DNRC to enable the DNRC to exercise and enforce its rights under the Resolution, the Series 2013 Bonds and the Collateral Documents and to realize thereon, and record and file and re-record and refile all such documents and instruments, at such time or times, in such manner and at such place or places, all as may be necessary or required by the DNRC to validate, preserve and protect the position of the DNRC under the Resolution, the Series 2013 Bonds and the Collateral Documents.

(d) Maintenance of Security, if Any; Recordation of Interest.

- (i) The Borrower shall, at its expense, take all necessary action to maintain and preserve the lien and security interest of the Resolution and the Collateral Documents so long as any amount is owing under the Resolution or the Series 2013 Bonds;
- (ii) The Borrower shall forthwith, after the execution and delivery of the Series 2013 Bonds and thereafter from time to time, cause the Resolution and any Collateral Documents granting a security interest in revenues or real or personal property and any financing statements or other notices or documents relating thereto to be filed, registered and recorded in such manner and in such places as may be required by law in order to perfect and protect fully the lien and security interest hereof and thereof and the security interest in them granted by the Resolution and, from time to time, shall perform or cause to be performed any other act required by law, including executing or causing to be executed any and all required continuation statements and shall execute or cause to be executed any further instruments that may be requested by the DNRC for such perfection and protection; and
- (iii) Except to the extent it is exempt therefrom, the Borrower shall pay or cause to be paid all filing, registration and recording fees incident to such filing, registration and recording, and all expenses incident to the preparation, execution and acknowledgment of the documents described in subparagraph (ii), and all federal or state fees and other similar fees, duties, imposts, assessments and charges arising out of or in connection with the execution and delivery of the Series 2013 Bonds and the Collateral Documents and the documents described in subparagraph (ii).

- (e) <u>Additional Agreements</u>. The Borrower covenants to comply with all representations, covenants, conditions and agreements, if any, set forth in Appendix C hereto.
- (f) <u>Financial Information</u>. This Section 2.3(f) supplements, and is not intended to limit, the requirements in Section 8.06 of the Original Resolution. The Borrower agrees that for each Fiscal Year it shall furnish to the DNRC and the DEQ, promptly when available, in addition to those matters specified in Section 8.06 of the Original Resolution:
 - (1) the preliminary budget for the System, with items for the 2013 Project shown separately; and
 - (2) when adopted, the final budget for the System, with items for the 2013 Project shown separately.
- (g) <u>Project Accounts</u>. The Borrower shall maintain Project accounts in accordance with generally accepted government accounting standards, and as separate accounts, as required by Section 602(b)(9) of the Clean Water Act.
- (h) <u>Records</u>. After reasonable notice from the EPA or the DNRC, the Borrower shall make available to the EPA or the DNRC such records as the EPA or the DNRC reasonably requires to review and determine compliance with Title VI of the Clean Water Act, as provided in Section 606(e) of the Clean Water Act.
- (i) <u>Compliance with Clean Water Act</u>. The Borrower has complied and shall comply with all conditions and requirements of the Clean Water Act pertaining to the 2013 Loans and the 2013 Project.
- (j) <u>Compliance with DEQ Requirements</u>. The Borrower shall comply with plan, specification and other requirements for public Sanitary Sewerage Systems established by the DEQ, as required by Section 75-5-1113(1)(g) of the State Act.
- (k) <u>Program Covenant</u>. The Borrower agrees that neither it nor any "related person" to the Borrower (within the meaning of Section 147(a)(2) of the Code) shall, whether pursuant to a formal or informal arrangement, acquire bonds issued by the State under the Indenture in an amount related to the amount of the Series 2013 Bonds.

Section 2.4 Covenants Relating to the Tax-Exempt Status of the State Bonds.

(a) The Borrower covenants and agrees that it will not use or permit to be used any of the proceeds of the Series 2013 Bonds or any other funds of the Borrower in respect of the 2013 Project or the Series 2013 Bonds, directly or indirectly, in a manner that would cause, or take any other action that would cause, any State Bond to be an "arbitrage bond" within the meaning of Section 148 of the Code or would otherwise cause the interest on the State Bonds to be included in gross income for purposes of federal income taxation.

- (b) The Borrower agrees that it will not enter into, or allow any "related person" (as defined in Section 147(a)(2) of the Code) to enter into, any arrangement, formal or informal, for the purchase of the State Bonds or any other obligations of the DNRC in an amount related to the amount of the 2013 Loans or the portion of the 2013 Loans derived directly or indirectly from proceeds of the State Bonds or that would otherwise cause any State Bond to be an "arbitrage bond" within the meaning of Section 148 of the Code.
- (c) The Borrower shall not use or permit the use of the 2013 Project directly or indirectly in any trade or business carried on by any Person who is not a Governmental Unit. For the purpose of this subparagraph, use as a member of the general public (within the meaning of the Regulations) shall not be taken into account and any activity carried on by a Person other than a natural person shall be treated as a trade or business.
- (d) Any portion of the 2013 Project being refinanced or the cost of which is being reimbursed was acquired by and is now and shall, during the term of the 2013 Loans, be owned by the Borrower and not by any other Person. Any portion of the 2013 Project being financed shall be acquired by and shall, during the term of the 2013 Loans, be owned by the Borrower and not by any other Person. Notwithstanding the previous two sentences, the Borrower may transfer the 2013 Project or a portion thereof to another Governmental Unit which is also a Public Entity if such transfer is otherwise permitted under the Resolution and if such organization agrees with the DNRC to comply with Section 2.3(h), Section 2.3(i) and Section 2.4 of this Supplemental Resolution and if the DNRC receives an Opinion of Bond Counsel that such transfer will not violate the State Act or the Clean Water Act or adversely affect the exclusion of interest on the Series 2013 Bonds from gross income or purposes of federal income taxation. In addition, except as otherwise provided in the Resolution or in any Collateral Documents, the Borrower may sell or otherwise dispose of any portion of the 2013 Project which has become obsolete or outmoded or is being replaced or for other reasons is not needed by the Borrower or beneficial to the general public or necessary to carry out the purposes of the Clean Water Act.
- (e) At the Closing of the 2013 Loans the DNRC will, if necessary to obtain the Opinion of Bond Counsel described in Section 7.05(a) of the Indenture, deliver to the Borrower instructions concerning compliance by the Borrower with the arbitrage rebate requirements of Section 148 of the Code (the "Arbitrage Rebate Instructions"). The Borrower shall comply with the Arbitrage Rebate Instructions, if any, delivered to it by the DNRC at Closing, as such Instructions may be amended or replaced by the DNRC from time to time. The Arbitrage Rebate Instructions may be amended or replaced by new Arbitrage Rebate Instructions delivered by the DNRC and accompanied by an Opinion of Bond Counsel to the effect that the use of said amended or new Arbitrage Rebate Instructions will not adversely affect the excludability of interest on the State Bonds or any Additional State Bonds (except State Bonds the interest on which the State did not intend to be excluded from gross income for federal income tax purposes) from gross income of the recipients thereof for federal income tax purposes.

- (f) The Borrower agrees that during the term of the 2013 Loans it will not contract with or permit any Private Person to manage the 2013 Project or any portion thereof except according to a written management contract and upon delivery to the DNRC of an opinion of Bond Counsel to the effect that the execution and delivery of such management contract will not violate the State Act or the Clean Water Act or adversely affect the exclusion of interest on State Bonds from gross income or purposes of federal income taxation.
- (g) The Borrower may not lease the 2013 Project or any portion thereof to any Person other than a Nonexempt Person which agrees in writing with the Borrower and the State not to cause any default to occur under the Resolution; provided the Borrower may lease all or any portion of the 2013 Project to a Nonexempt Person pursuant to a lease which in the Opinion of Bond Counsel delivered to the DNRC will not cause the interest on the State Bonds to be included in gross income for purposes of federal income taxation.
- (h) The Borrower shall not change the use or nature of the 2013 Project if (i) such change will violate the Clean Water Act, or (ii) so long as the State Bonds are outstanding unless, in the Opinion of Bond Counsel delivered to the DNRC, such change will not result in the inclusion in gross income of interest on the State Bonds for federal income tax purposes.
- Section 2.5 <u>Maintenance of System; Liens</u>. The Borrower shall maintain the System, including the 2013 Project, in good condition and make all necessary renewals, replacements, additions, betterments and improvements thereto. The Borrower shall not grant or permit to exist any lien on the 2013 Project or any other property making up part of the System, other than liens securing Debt where a parity or senior lien secures the Series 2013 Bonds; provided that this Section 2.5 shall not be deemed to be violated if a mechanic's or contractor's lien is filed against any such property so long as the Borrower uses its best efforts to obtain the discharge of such lien and promptly reports to the DNRC the filing of such lien and the steps it plans to take and does take to discharge of such lien.
- Section 2.6 <u>Maintenance of Existence; Merger, Consolidation, Etc.; Disposition of Assets</u>. The Borrower shall maintain its corporate existence, except that it may consolidate with or merge into another Governmental Unit or permit one or more Governmental Units to consolidate with or merge into it or may transfer all or substantially all of its assets to another Governmental Unit and then dissolve if the surviving, resulting or transferee entity (if other than the Borrower) (i) is a Public Entity and (ii) assumes in writing all of the obligations of the Borrower under the Resolution, the Series 2013 Bonds and the Collateral Documents, and (a) such action does not result in any default in the performance or observance of any of the terms, covenants or agreements of the Borrower under the Resolution, the Series 2013 Bonds and the Collateral Documents, (b) such action does not violate the State Act or the Clean Water Act and does not adversely affect the exclusion of interest on the Series 2013 Bonds or the State Bonds from gross income for federal income tax purposes and (c) the Borrower delivers to the DNRC on the date of such action an Opinion of Bond Counsel that such action complies with this Section 2.6.

Other than pursuant to the preceding paragraph, the Borrower shall not transfer the System or any portion thereof to any other Person, except for property which is obsolete, outmoded, worn out, is being replaced or otherwise is not needed for the operation of the System, unless the provisions of (a) and (b) of the preceding paragraph are satisfied and the Borrower delivers to the DNRC an Opinion of Bond Counsel to that effect and, in addition, the DNRC consents to such transfer.

Article III USE OF PROCEEDS; THE 2013 PROJECT

- Section 3.1 <u>Use of Proceeds</u>. The Borrower shall apply the proceeds of the 2013 Loans from the DNRC solely as follows:
 - (a) The Borrower shall apply the proceeds of the 2013 Loans solely to the financing, refinancing or reimbursement of the costs of the 2013 Project as set forth in Appendix A hereto and this Section 3.1, funding a deposit to the Reserve Account, and to pay costs associated with the sale and issuance of the Series 2013 Bonds. The 2013 Loans will be disbursed in accordance with Article IV hereof and Article VII of the Indenture. If the 2013 Project has not been completed prior to Closing, the Borrower shall, as quickly as reasonably possible, complete the 2013 Project and expend proceeds of the 2013 Loans to pay the costs of completing the 2013 Project.
 - (b) No portion of the proceeds of the 2013 Loans shall be used to reimburse the Borrower for costs paid prior to the date of adoption of this Supplemental Resolution of a Project the construction or acquisition of which occurred or began earlier than March 7, 1985. In addition, if any proceeds of the 2013 Loans are to be used to reimburse the Borrower for Project costs paid prior to the date of adoption of this Supplemental Resolution, the Borrower shall have complied with Section 1.150-2 of the Regulations in respect of such costs.
 - (c) Any Debt to be refinanced with proceeds of the 2013 Loans was incurred after March 7, 1985, for a Project the construction or acquisition of which began after March 7, 1985. No proceeds of the 2013 Loans shall be used for the purpose of refinancing an obligation the interest on which is exempt from federal income tax or excludable from gross income for purposes of federal income taxation unless the DNRC has received an Opinion of Bond Counsel, satisfactory to it, to the effect that such refinancing will not adversely affect the exclusion of interest on the State Bonds from gross income for purposes of federal income taxation.
- Section 3.2 The 2013 Project. Set forth in Appendix A to this Supplemental Resolution is a description of the 2013 Project, which describes the property which has been or is to be acquired, installed, constructed or improved and the other activities, if any to be funded from the 2013 Loans (the 2013 Project may consist of more than one facility or activity) and an estimated budget relating to the 2013 Project. The 2013 Project may be changed and the description thereof in Appendix A may be amended from time to time by the Borrower but only after delivery to the DNRC of the following:

- (a) A certificate of the Borrower setting forth the amendment to Appendix A and stating the reason therefor, including statements whether the amendment would cause an increase or decrease in the cost of the 2013 Project, an increase or decrease in the amount of 2013 Loans proceeds which will be required to complete the 2013 Project and whether the change will materially accelerate or delay the construction schedule for the 2013 Project;
- (b) A written consent to such change in the 2013 Project by an Authorized DNRC Officer; and
- (c) An Opinion or Opinions of Bond Counsel stating that the 2013 Project, as constituted after such amendment, is, and was at the time the State Bonds were issued, eligible for financing under the State Act and is, and was at the time the Series 2013 Bonds were issued, eligible for financing under the Act, such amendment will not violate the State Act or the Act and such amendment will not adversely affect the exclusion of interest on the State Bonds or the Series 2013 Bonds from gross income for purposes of federal income taxation. Such an Opinion of Bond Counsel shall not be required for amendments which do not affect the type of facility to be constructed or activity to be financed.

The Borrower acknowledges and agrees that an increase in the principal amount of the 2013 Loans may be made only upon an application to the DEQ, the DNRC and the Trustee, in such form as the DEQ shall specify, which is approved by the DEQ and the DNRC, in their sole and absolute discretion, and adoption by the governing body of the Borrower of a resolution amendatory of or supplementary to the Resolution authorizing the additional loan and delivery of written certifications by officers of the Borrower to the DEQ, the DNRC and the Trustee to the effect that all representations and covenants contained in the resolution as it may be so amended or supplemented are true as of the date of closing of the additional loan and compliance with applicable tests for the incurrence of such Debt. No assurance can be given that any additional loan funds will be available under the Program at the time of any such application or thereafter. The Borrower acknowledges and agrees that neither the DEQ, the DNRC, the Trustee nor any of their agents, employees or representatives shall have any liability to the Borrower and have made no representations to the Borrower as to the sufficiency of the 2013 Loans to pay costs of the 2013 Project or as to the availability of additional funds under the Program to increase the principal amount of the 2013 Loans.

- Section 3.3 <u>2013 Project Representations and Covenants</u>. The Borrower hereby represents to and covenants with the DNRC that:
 - (a) all construction of the 2013 Project has complied and will comply with all federal and state standards, including, without limitation, EPA regulations and standards;
 - (b) all future construction of the 2013 Project will be done only pursuant to fixed price construction contracts. The Borrower shall obtain a performance and payment bond from the contractor for each construction contract in the amount of 100% of the

construction price and ensure that such bond is maintained until construction is completed to the Borrower's, the DNRC's and the DEQ's satisfaction;

- (c) all future construction will be done in accordance with plans and specifications on file with the DNRC and the DEQ, provided that changes may be made in such plans and specifications with the written consent of an Authorized DNRC Officer and the DEQ;
- (d) all laborers and mechanics employed by contractors and subcontractors on the 2013 Project have been and will be paid wages at rates not less than those prevailing on projects of a character similar in the locality as determined by the United States Secretary of Labor in accordance with subchapter IV of chapter 31 of title 40, United States Code;
- (e) the 2013 Project is a project of the type permitted to be financed under the Act, the State Act and the Program and Title IV of the Clean Water Act; and
- (f) the Borrower will undertake the 2013 Project promptly after the Closing Date and will cause the 2013 Project to be completed as promptly as practicable with all reasonable dispatch, except only as completion may be delayed by a cause or event not reasonably within the control of the Borrower; it is estimated by the Borrower that the 2013 Project will be substantially completed by the Estimated Completion Date.

Section 3.4 <u>Completion or Cancellation or Reduction of Costs of the 2013 Project.</u>

- (a) Upon completion of the 2013 Project, the Borrower shall deliver to the DNRC a certificate stating that the 2013 Project is complete and stating the amount, if any, of the Undisbursed Committed Amount. If Appendix A describes two or more separate projects as making up the 2013 Project, a separate completion certificate shall be delivered for each.
- (b) If all or any portion of the 2013 Project is cancelled or cut back or its costs are reduced or for any other reason the Borrower will not require the full Committed Amount, the Borrower shall promptly notify the DNRC in writing of such fact and the amount of the Undisbursed Committed Amount.

Article IV THE LOAN

Section 4.1 The Loan; Disbursement of Loan. The DNRC has agreed to lend to the Borrower, from time to time as the requirements of this Section 4.1 are met, an amount up to (i) \$7,084,000 (the "2013A Committed Amount") for the purposes of financing, refinancing or reimbursing the Borrower for all or a portion of the costs of the 2013 Project, to fund a deposit to the Reserve Account, and to pay costs of issuance of the Series 2013A Bond and (ii) \$7,084,000 (the "2013B Committed Amount" and, together with the 2013A Committed Amount, the "Committed Amounts") for the purposes of financing, refinancing or reimbursing the Borrower for a portion of the costs of the 2013 Project, to fund a deposit to the Reserve Account, and to pay costs of issuance of the Series 2013B Bond; provided the DNRC shall not be required to

loan any proceeds of the State Bonds to the Borrower after the Estimated Completion Date. The Committed Amount may be reduced as provided in Section 3.2 and Section 3.4 of this Supplemental Resolution and subject to the operation of Section 5.6.

- (a) The DNRC intends to disburse the 2013 Loans through the Trustee.
- (b) In consideration of the issuance of the Series 2013 Bonds by the Borrower, the DNRC shall make, or cause the Trustee to make, a disbursement of all or a portion of the 2013 Loans upon receipt of the following documents:
 - (1) an Opinion of Bond Counsel as to the validity and enforceability of the Series 2013 Bonds and the security therefor and stating in effect that interest on the Series 2013 Bonds is not includable in gross income of the owner thereof for purposes of federal income taxation, in form and substance satisfactory to the DNRC:
 - (2) the Series 2013 Bonds, fully executed and authenticated;
 - (3) a certified copy of the Original Resolution and this Supplemental Resolution;
 - (4) any other security instruments or documents required by the DNRC or DEQ as a condition to their approval of the 2013 Loans;
 - (5) if all or part of the 2013 Loans are being made to refinance a Project or reimburse the Borrower for the costs of a Project paid prior to the Closing, evidence, satisfactory to the DNRC and the Bond Counsel referred to in (1) above, (A) that the acquisition or construction of the 2013 Project was begun no earlier than March 7, 1985 or the debt was incurred no earlier than March 7, 1985, (B) of the Borrower's title to the 2013 Project, (C) of the costs of the 2013 Project and that such costs have been paid by the Borrower and (D) if such costs were paid before adoption of this Supplemental Resolution that the Borrower has complied with Section 1.150-2 of the Regulations;
 - (6) the items required by the Indenture for the portion of the 2013 Loans to be disbursed at Closing; and
 - (7) such other certificates, documents and other information as the DNRC, the DEQ or the Bond Counsel giving the opinion referred to in subparagraph (1) may require (including any necessary arbitrage rebate instructions).
- (c) In order to obtain a disbursement of a portion of the Series 2013A Bond and the Series 2013B Bond to pay costs of the 2013 Project, the Borrower shall submit to the DNRC and the Trustee a signed request for disbursement on the form prescribed by the DNRC, with all attachments required by such form. The Borrower may obtain disbursements only for costs which have been legally incurred and are due and payable. All disbursements of the 2013 Loans will be made to the Borrower only upon proof that

cost was incurred. The 2013B First Advance and subsequent disbursements of the 2013B Loan will be requested by the Borrower and, subject to the other terms and conditions of this Supplemental Resolution, made by the DNRC only after the entire principal amount of the 2013A Loan has been disbursed by the DNRC to the Borrower. The Borrower shall submit the request for the 2013B First Advance in the form required by the DNRC so that it is received by the DNRC by the date that is no later than 10 Business Days prior to the date desired by the Borrower for the making of the 2013B First Advance.

- (d) For refinancings, a disbursement schedule complying with the requirements of the Clean Water Act shall be established by the DNRC and the Borrower at Closing. If the Borrower should repay all or a portion of the debt to be refinanced from other sources or should otherwise not need any portion of the loan which was to have been used to refinance such debt, it shall inform the DNRC and the Trustee of such fact pursuant to Section 3.4(b) and a new disbursement schedule shall be drawn up by the DNRC. The DNRC shall obtain a receipt from the holder of the debt being refinanced for each disbursement made to pay or prepay a portion of such debt.
- (e) If all or a portion of the 2013 Loans are made to reimburse a Borrower for 2013 Project costs paid by it prior to Closing, the Borrower shall present at Closing the items required by Section 4.1(b) relating to such costs. The Trustee shall disburse such amounts to the Borrower pursuant to a disbursement schedule complying with the requirements of the Clean Water Act established by the DNRC and the Borrower at the Closing.
- (f) Notwithstanding anything else provided herein, the Trustee shall not be obligated to disburse the 2013 Loans any faster or to any greater extent than it has available EPA Capitalization Grants, Bond proceeds and other amounts available therefor in the Revolving Fund. The DNRC shall not be required to do "overmatching" pursuant to Section 5.04(b) of the Indenture, but may do so in its discretion. The Borrower acknowledges that if Project costs are incurred faster than the Borrower projected at Closing, there may be delays in making disbursements of the 2013A Loan or the 2013B Loan for such costs because of the schedule under which EPA makes EPA Capitalization Grant money available to the DNRC. The DNRC will use its commercially reasonable efforts to obtain an acceleration of such schedule if necessary.
- (g) Upon making each 2013A Loan and 2013B Loan disbursement, the Trustee shall note such disbursement on Schedule A to the Series 2013A Bond and to the Series 2013B Bond, respectively. A Schedule A reflecting the amount of the 2013B First Advance will first be attached to the Series 2013B Bond following receipt by the DNRC of the information required in connection with the 2013B First Advance.
- (h) The Borrower agrees that it will deposit in the Reserve Account upon receipt thereof, on the Closing Date of the 2013 Loans and the date of the 2013B First Advance and upon any disbursement date, any proceeds of the 2013 Loans borrowed for the purpose of increasing the balance in the Reserve Account to the Reserve Requirement. The Borrower further acknowledges and agrees that any portion of the 2013 Loans

representing capitalized interest shall be advanced only on Payment Dates and shall be transferred by the Trustee on the Payment Date directly to the Debt Service Account. The amount of any such transfer shall, as appropriate, be a credit against the interest payments due on the Series 2013A Bond or the Series 2013B Bond, and interest thereon shall accrue only from the date of transfer.

- (i) Compliance by the Borrower with its representations, covenants and agreements contained in the Original Resolution, this Supplemental Resolution and the Collateral Documents shall be a further condition precedent to the disbursement of the Loan in whole or in part. The DNRC and the Trustee, in their sole and absolute discretion, may make one or more disbursements, in whole or in part, notwithstanding such noncompliance, and without liability to make any subsequent disbursement of the Loan.
- Section 4.2 <u>Commencement of Loan Term</u>. The Borrower's obligations under this Supplemental Resolution and the Collateral Documents shall commence on the date hereof unless otherwise provided in this Supplemental Resolution. However, the obligation to make payments under Article V hereof shall commence only upon the first disbursement by the Trustee of the proceeds of the 2013A Loan.
- Section 4.3 <u>Termination of Loan Term.</u> The Borrower's obligations under the Resolution and the Collateral Documents in respect of the Series 2013 Bonds shall terminate upon payment in full of all amounts due under the Series 2013 Bonds and the Resolution in respect thereof; provided, however, that the covenants and obligations provided in Article VI and Section 10.4 of this Supplemental Resolution shall survive the termination of the Resolution.
- Section 4.4 <u>Loan Closing Submissions</u>. On or prior to the Closing, the Borrower will have delivered to the DNRC and the Trustee the closing submissions required by Section 7.05 of the Indenture.

Article V REPAYMENT OF 2013 Loans

Section 5.1 Repayment of 2013 Loans. The Borrower shall repay the amounts lent to it pursuant to Section 4.1 hereof, plus interest on the unpaid amounts lent at the rate of two percent (2.00%) per annum, in semiannual Loan Repayments. In addition, the Borrower shall pay an Administrative Expense Surcharge on the outstanding principal amount of each of the 2013 Loans at the rate of seventy-five hundredths of one percent (0.75%) per annum and a Loan Loss Reserve Surcharge on the outstanding principal amount of each of the 2013 Loans at the rate of twenty-five hundredths of one percent (0.25%) per annum. For purposes of this Resolution and the Program, when not used in conjunction with a reference to any surcharges, the term "interest" on the 2013 Loans shall include the Administrative Expense Surcharge and the Loan Loss Reserve Surcharge. The Borrower shall pay all Loan Repayments and the Administrative Expense Surcharge and Loan Loss Reserve Surcharge in lawful money of the United States of America to the DNRC. Interest, the Administrative Expense Surcharge, and Loan Loss Reserve Surcharge shall be calculated on the basis of a year of 360 days comprising 12 months of 30 days each.

The Loan Repayments required by this Section 5.1 and the Administrative Expense Surcharge and Loan Loss Reserve Surcharge shall be due on each January 1 and July 1 (the "Payment Dates"), as follows:

(a) <u>2013A Loan</u>. With respect to the 2013A Loan:

- (1) interest and the Administrative Expense Surcharge and Loan Loss Reserve Surcharge on the outstanding principal balance of the 2013A Loan shall be payable on each Payment Date, beginning on January 1, 2014, through and including July 1, 2033;
- (2) the principal of the 2013A Loan shall be repayable on each Payment Date, beginning on January 1, 2014, through and including July 1, 2033, and the amount of each principal payment shall be calculated on the basis of substantially level debt service at a rate of 3.00% per annum.

(b) <u>2013B Loan</u>. With respect to the 2013B Loan:

- (1) interest and the Administrative Expense Surcharge and Loan Loss Reserve Surcharge on the outstanding principal balance of the 2013B Loan shall be payable on each Payment Date, beginning on the January 1 or July 1 that is first to occur following the date of the 2013B First Advance, through and including July 1, 2033; and
- (2) the principal of the 2013B Loan shall be repayable on each Payment Date, beginning on the January 1 or July 1 that is the first to occur following the date of the 2013B First Advance, through and including the January 1 or July 1 that constitutes the 40th Payment Date under the 2013B Loan, and the amount of each principal payment shall be calculated on the basis of substantially level debt service at a rate of 3.00% per annum.

The Loan Repayments and the Administrative Expense Surcharge and the Loan Loss Reserve Surcharge on the 2013 Loans shall be due on the dates specified above and on the dates and in the amounts shown in Schedule B to each of the Series 2013A Bond and the Series 2013B Bond, as such Schedule B shall be modified from time to time as provided below. A complete Schedule B will first be attached to the Series 2013B Bond following receipt by the DNRC of the information required in connection with the 2013B First Advance. The portion of each such Loan Repayment consisting of principal and the portion consisting of interest and the amount of each Administrative Expense Surcharge and the amount of each Loan Loss Reserve Surcharge shall be set forth in Schedule B to each of the Series 2013A Bond and the Series 2013B Bond. Upon each disbursement of amounts of the 2013 Loans to the Borrower pursuant to Section 4.1 hereof, the Trustee shall enter or cause to be entered the amount advanced on Schedule A to the Series 2013A Bond or Series 2013B Bond, as applicable, under "Advances" and the total amount advanced under Section 4.1, including such disbursement, under "Total Amount Advanced."

Past-due Loan Repayments and the Administrative Expense Surcharge and the Loan Loss Reserve Surcharge shall bear interest at the rate of ten percent (10.00%) per annum, until paid.

Any payment of principal, interest and the Administrative Expense Surcharge and the Loan Loss Reserve Surcharge under this Section 5.1 shall also be credited against the same payment obligation under the Series 2013A Bond or the Series 2013B Bond.

- Section 5.2 <u>Additional Payments</u>. The Borrower shall also pay, within 30 days after receipt of a bill therefor, from any legally available funds therefor, including proceeds of the 2013 Loans, if the Borrower so chooses, all reasonable expenses of the DNRC and the Trustee in connection with the 2013 Loans, the Collateral Documents and the Series 2013 Bonds, including, but not limited to:
 - (a) the cost of reproducing this Supplemental Resolution, the Collateral Documents and the Series 2013 Bonds;
 - (b) the fees and disbursements of bond counsel and other Counsel utilized by the DNRC and the Trustee in connection with the 2013 Loans, the Resolution, the Collateral Documents and the Series 2013 Bonds and the enforcement thereof; and
 - (c) all taxes and other governmental charges in connection with the execution and delivery of the Collateral Documents or the Series 2013 Bonds, whether or not the Series 2013 Bonds are then outstanding, including all recording and filing fees relating to the Collateral Documents and the pledge of the State's right, title and interest in and to the Series 2013 Bonds, the Collateral Documents and the Resolution (and with the exceptions noted therein) and all expenses, including attorneys' fees, relating to any amendments, waivers, consents or collection or enforcement proceedings pursuant to the provisions hereof or thereof.
- Section 5.3 <u>Prepayments</u>. The Borrower may not prepay all or any part of the outstanding principal amount of the Series 2013 Bonds unless (i) it obtains the prior written consent of the DNRC thereto, and (ii) no Loan Repayment, Administrative Expense Surcharge, or Loan Loss Reserve Surcharge is then delinquent. Any prepayment permitted by the DNRC must be accompanied by payment of accrued interest and Administrative Expense Surcharge and Loan Loss Reserve Surcharge to the date of prepayment on the amount of principal prepaid. If the Series 2013 Bonds are prepaid in part pursuant to this Section 5.3, such prepayments shall be applied to principal payments in inverse order of maturity.
- Section 5.4 Obligations of Borrower Unconditional. The obligations of the Borrower to make the payments required by the Resolution and the Series 2013 Bonds and to perform its other agreements contained in the Resolution, the Series 2013 Bonds and Collateral Documents shall be absolute and unconditional, except as otherwise provided herein or in such documents. The Borrower (a) shall not suspend or discontinue any payments provided for in the Resolution and the Series 2013 Bonds, (b) shall perform all its other agreements in the Resolution, the Series 2013 Bonds and the Collateral Documents and (c) shall not terminate the Resolution, the Series 2013 Bonds or the Collateral Documents for any cause, including any acts or circumstances that may constitute failure of consideration, destruction of or damage to the 2013 Project or the System, commercial frustration of purpose, any dispute with the DNRC or the EPA, any change in the laws of the United States or of the State or any political subdivision of either or any failure of the DNRC to perform any of its agreements, whether express or implied, or any duty, liability

or obligation arising from or connected with the Resolution. Provided, however, if the 2013 Loans contemplated herein is not made and no funds are disbursed to the Borrower, the Resolution may be terminated.

Section 5.5 <u>Limited Liability</u>. All payments of principal of and interest on the 2013 Loans and other payment obligations of the Borrower hereunder and under the Series 2013 Bonds shall be special, limited obligations of the Borrower payable solely out of the Net Revenues or out of the Debt Service Account and shall not, except at the option of the Borrower and as permitted by law, be payable out of any other funds or revenues of the Borrower. The obligations of the Borrower under the Resolution and the Series 2013 Bonds shall never constitute an indebtedness of the Borrower within the meaning of any state constitutional provision or statutory or charter limitation and shall never constitute or give rise to a pecuniary liability of the Borrower or a charge against its general credit or taxing power. The taxing powers of the Borrower are not pledged to pay principal of or interest on the Series 2013 Bonds, and no funds or property of the Borrower other than the Net Revenues are pledged to pay principal of or interest on the Series 2013 Bonds.

Article VI INDEMNIFICATION OF DNRC AND DEQ

The Borrower shall, to the extent permitted by law, indemnify and save harmless the DNRC, and the DEQ and their officers, employees and agents (each an "Indemnified Party" or, collectively, the "Indemnified Parties") against and from any and all claims, damages, demands, expenses, liabilities and losses of every kind asserted by or on behalf of any Person arising out of the acts or omissions of the Borrower or its employees, officers, agents, contractors, subcontractors, or consultants in connection with or with regard or in any way relating to the condition, use, possession, conduct, management, planning, design, acquisition, construction, installation or financing of the 2013 Project. The Borrower shall also, to the extent permitted by law, indemnify and save harmless the Indemnified Parties against and from all costs, reasonable attorneys' fees, expenses and liabilities incurred in any action or proceeding brought by reason of any such claim or demand. If any proceeding is brought against an Indemnified Party by reason of such claim or demand, the Borrower shall, upon notice from an Indemnified Party, defend such proceeding on behalf of the Indemnified Party.

Article VII ASSIGNMENT

- Section 7.1 <u>Assignment by City</u>. The Borrower may not assign its rights and obligations under the Resolution or the Series 2013 Bonds.
- Section 7.2 <u>Assignment by DNRC</u>. The DNRC will pledge its rights under and interest in the Resolution, the Series 2013 Bonds and the Collateral Documents (except to the extent otherwise provided in the Indenture) as security for the payment of the State Bonds and may further assign such interests to the extent permitted by the Indenture, without the consent of the Borrower.

Section 7.3 <u>State Refunding Bonds.</u> In the event the State Bonds and Additional State Bonds are refunded by bonds which are not Additional State Bonds, all references in the Resolution to State Bonds and Additional State Bonds shall be deemed to refer to the refunding bonds and any bonds of the State on a parity with such refunding bonds (together, the "Refunding Bonds") or, in the case of a crossover refunding, to the State Bonds and Additional State Bonds and the Refunding Bonds. In the event the State Bonds are refunded by an issue of Additional State Bonds, all references in the Resolution to the State Bonds shall be deemed to refer to such Additional State Bonds or, in the case of a crossover refunding, both the State Bonds and such Additional State Bonds.

Article VIII THE SERIES 2013 BONDS

Section 8.1 Net Revenues Available. The Borrower is authorized to charge just and equitable rates, charges and rentals for all services directly or indirectly furnished by the System, and to pledge and appropriate to the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond and the Series 2013 Bonds the Net Revenues to be derived from the operation of the System, including improvements, betterments or extensions thereof hereafter constructed or acquired. The Net Revenues to be produced by such rates, charges and rentals during the term of the Series 2013 Bonds are expected to be more than sufficient to pay the principal and interest when due on the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond and the Series 2013 Bonds, and to create and maintain reasonable reserves therefor and to provide an adequate allowance for replacement and depreciation, as prescribed herein.

Section 8.2 <u>Issuance and Sale of the Series 2013 Bonds</u>. The Commission has investigated the facts necessary and hereby finds, determines and declares it to be necessary and desirable for the Borrower to issue the Series 2013 Bonds to evidence the 2013 Loans. The Series 2013 Bonds are issued to the DNRC without public sale pursuant to Montana Code Annotated, Section 7-7-4433(2)(a).

Section 8.3 Terms. The Series 2013A Bond and the Series 2013B Bond shall be in the maximum principal amount equal to the original 2013A Committed Amount and 2013B Committed Amount, respectively, shall each be issued as a single, fully registered bond numbered R-1, shall be dated as of the date of delivery to the DNRC, and shall bear interest at the rate charged by the DNRC on the 2013 Loans. The principal of and interest on the Series 2013 Bonds shall be payable on the same dates and in the same amounts on which Loan Repayments are payable. Advances of principal of the Series 2013A Bond or the Series 2013B Bond shall be deemed made when advances of the 2013A Loan or 2013B Loan, respectively, are made under Section 4.1, and such advances shall be payable in accordance with Schedule B to the Series 2013A Bond or Series 2013B Bond, as the case may be, as it may be revised by the DNRC from time to time in accordance with Section 5.1. The Series 2013 Bonds are Additional Bonds.

The Borrower may prepay the Series 2013 Bonds, in whole or in part, only upon the terms and conditions under which it can prepay the 2013 Loans under Section 5.3.

Section 8.4 Negotiability, Transfer and Registration. The Series 2013 Bonds shall be fully registered as to both principal and interest, and shall be initially registered in the name of and payable to the DNRC. While so registered, principal of and interest on the Series 2013 Bonds shall be payable to the DNRC at the Office of the Department of Natural Resources and Conservation, 1625 Eleventh Avenue, Helena, Montana 59620 or such other place as may be designated by the DNRC in writing and delivered to the Borrower. The Series 2013 Bonds shall be negotiable, subject to the provisions for registration and transfer contained in this Section. No transfer of the Series 2013 Bonds shall be valid unless and until (1) the holder, or his duly authorized attorney or legal representative, has executed the form of assignment appearing on the Series 2013 Bonds, and (2) the City Fiscal Services Director of the Borrower (or successors, the "Registrar"), as Bond Registrar, has duly noted the transfer on the Series 2013 Bonds and recorded the transfer on the registration books of the Registrar. The Registrar may, prior to noting and recording the transfer, require appropriate proof of the transferor's authority and the genuineness of the transferor's signature. The Borrower shall be entitled to deem and treat the Person in whose name the Series 2013A Bond or Series 2013B Bond is registered as the absolute owner of the Series 2013A Bond or Series 2013B Bond, respectively, for all purposes, notwithstanding any notice to the contrary, and all payments to the registered holder shall be valid and effectual to satisfy and discharge the Borrower's liability upon such bond to the extent of the sum or sums so paid.

Section 8.5 <u>Execution and Delivery</u>. The Series 2013 Bonds shall be executed on behalf of the Borrower by the manual signatures of the Mayor, City Manager, City Fiscal Services Director and City Clerk. Any or all of such signatures may be affixed at or prior to the date of delivery of the Series 2013 Bonds. The Series 2013 Bonds shall be sealed with the corporate seal of the Borrower. In the event that any of the officers who shall have signed the Series 2013 Bonds shall cease to be officers of the Borrower before the Series 2013 Bonds are issued or delivered, their signatures shall remain binding upon the Borrower. Conversely, the Series 2013 Bonds may be signed by an authorized official who did not hold such office on the date of adoption of this Supplemental Resolution. The Series 2013 Bonds shall be delivered to the DNRC, or its attorney or legal representative.

Section 8.6 Form. The Series 2013A Bond shall be prepared in substantially the form attached as Appendix B-1. The Series 2013B Bond shall be prepared in substantially the form attached as Appendix B-2.

Section 8.7 <u>Construction Account</u>. To the Construction Account shall be credited as received the portion of the proceeds of the Series 2013 Bonds and any other funds appropriated by the Borrower to the Construction Account for improvements to the System, and all income received from the investment of the Construction Account.

Article IX SECURITY FOR THE SERIES 2013 BONDS

The Series 2013 Bonds are issued as Additional Bonds under Section 6.01 of the Original Resolution and shall, with the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, and any other Additional Bonds issued under the provisions of Section 6.01 of the Original Resolution, be equally and ratably secured by the provisions of the

Resolution and payable out of the Net Revenues appropriated to the Debt Service Account of the Sanitary Sewerage System Fund, without preference or priority, all as provided in the Resolution, and secured by the Reserve Account, as further provided in Section 7.05 of the Original Resolution. Upon advancement of principal of the Series 2013 Bonds, the City Fiscal Services Director shall transfer from proceeds of the Series 2013 Bonds such amount or amounts to the Reserve Account to cause the balance therein to equal the Reserve Requirement, treating such principal amount as outstanding. Upon each advance of the Series 2013 Bonds, the deposit to the Reserve Account shall be sufficient to cause the balance in the Reserve Account to equal the Reserve Requirement in respect of the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, and the principal of the Series 2013 Bonds so advanced. The Borrower shall keep, perform and observe each and every one of its covenants and undertakings set forth in the Resolution for the benefit of the registered owners from time to time of the Series 2002B Bond, the Series 2012 Bond and the Series 2013 Bonds.

Article X TAX MATTERS

Section 10.1 <u>Use of Project</u>. The 2013 Project will be owned and operated by the Borrower and available for use by members of the general public on a substantially equal basis. The Borrower shall not enter into any lease, use or other agreement with any non-governmental person relating to the use of the 2013 Project or the System or security for the payment of the Series 2013 Bonds which might cause the Series 2013 Bonds to be considered "private activity bonds" or "private loan bonds" within the meaning of Section 141 of the Code.

Section 10.2 <u>General Covenant</u>. The Borrower covenants and agrees with the owners from time to time of the Series 2013 Bonds that it will not take or permit to be taken by any of its officers, employees or agents any action which would cause the interest on the Series 2013 Bonds to become includable in gross income for federal income tax purposes under the Code and the Regulations, and covenants to take any and all actions within its powers to ensure that the interest on the Series 2013 Bonds will not become includable in gross income for federal income tax purposes under the Code and the Regulations.

Services Director, being the officers of the Borrower charged with the responsibility for issuing the Series 2013 Bonds pursuant to the Resolution, are authorized and directed to execute and deliver to the DNRC a certificate in accordance with the provisions of Section 148 of the Code, and Section 1.148-2(b) of the Regulations, stating that on the basis of facts, estimates and circumstances in existence on the date of issue and delivery of the Series 2013 Bonds, it is reasonably expected that the proceeds of the Series 2013 Bonds will be used in a manner that would not cause the Series 2013 Bonds to be "arbitrage bonds" within the meaning of Section 148 of the Code and the Regulations.

Section 10.4 <u>Arbitrage Rebate</u>. The Borrower acknowledges that the Series 2013 Bonds are subject to the rebate requirements of Section 148(f) of the Code. The Borrower covenants and agrees to retain such records, make such determinations, file such reports and documents and pay such amounts at such times as are required under said Section 148(f) and

applicable Treasury Regulations to preserve the exclusion of interest on the Series 2013 Bonds from gross income for federal income tax purposes, unless the Series 2013 Bonds qualify for the exception from the rebate requirement under Section 148(f)(4)(B) of the Code and no "gross proceeds" of the Series 2013 Bonds (other than amounts constituting a "bona fide debt service fund") arise during or after the expenditure of the original proceeds thereof. In furtherance of the foregoing, the Fiscal Services Director is hereby authorized and directed to execute a Rebate Certificate, substantially in the form to be prepared by Bond Counsel, and the Borrower hereby covenants and agrees to observe and perform the covenants and agreements contained therein, unless amended or terminated in accordance with the provisions thereof.

Section 10.5 <u>Information Reporting</u>. The Borrower shall file with the Secretary of the Treasury, not later than August 15, 2013, a statement concerning the Series 2013 Bonds containing the information required by Section 149(e) of the Code.

Article XI CONTINUING DISCLOSURE

The Borrower understands and acknowledges that the DNRC is acquiring the Series 2013 Bonds under the Program pursuant to which the State issues from time to time State Bonds to provide funds therefor. The Borrower covenants and agrees that, upon written request of the DNRC from time to time, the Borrower will promptly provide to the DNRC all information that the DNRC reasonably determines to be necessary or appropriate to offer and sell State Bonds or to provide continuing disclosure in respect of State Bonds, whether under Rule 15c2-12 (17 C.F.R. § 240.15c2-12) promulgated by the Securities and Exchange Commission under the Securities Exchange Act of 1934, as amended, or otherwise. Such information shall include, among other things and if so requested, financial statements of the Borrower prepared in accordance with generally accepted accounting principles promulgated by the Financial Accounting Standards Board as modified in accordance with the governmental accounting standards promulgated by the Governmental Accounting Standards Board or as otherwise provided under Montana law, as in effect from time to time (such financial statements to relate to a Fiscal Year or any period therein for which they are customarily prepared by the Borrower, and, if for a Fiscal Year and so requested by the DNRC, subject to an audit report and opinion of an accountant or government auditor, as permitted or required by the laws of the State). The Borrower will also provide, with any information so furnished to the DNRC, a certificate of the Mayor, the City Clerk and the City Fiscal Services Director of the Borrower to the effect that, to the best of their knowledge, such information does not include any untrue statement of a material fact or omit to state any material fact required to be stated therein to make the statements made, in light of the circumstances under which they are made, not misleading.

Article XII REIMBURSEMENT EXPENDITURES

Section 12.1 <u>Recitals</u>. The United States Department of Treasury has promulgated final regulations governing the use of proceeds of tax-exempt bonds, all or a portion of which are to be used to reimburse the Borrower for project expenditures paid by the Borrower prior to the date of issuance of such bonds. Those regulations (Treasury Regulations, Section 1.150-2) (the

"Reimbursement Regulations") require that the Borrower adopt a statement of official intent to reimburse an original expenditure not later than 60 days after payment of the original expenditure. The Reimbursement Regulations also generally require that bonds be issued and the reimbursement allocation be made from the proceeds of such bonds within 18 months (or three years, if the reimbursement bond issue qualifies for the "small issuer" exception from the arbitrage rebate requirement) after the later of (i) the date the expenditure is paid or (ii) the date the project is placed in service or abandoned, but (unless the issue qualifies for the "small issuer" exception from the arbitrage rebate requirement) in no event more than three years after the date the expenditure is paid. The Reimbursement Regulations generally permit reimbursement of capital expenditures and costs of issuance of the bonds.

Section 12.2 <u>Official Intent Declaration</u>. The Borrower reasonably expects to reimburse the expenditures made for costs of the 2013 Project out of the proceeds of the Series 2013 Bonds in an estimated maximum aggregate principal amount of \$14,168,000 after the date of payment of all or a portion of the costs of the 2013 Project. All reimbursed expenditures shall be capital expenditures, a cost of issuance of the Series 2013 Bonds or other expenditures eligible for reimbursement under Section 1.150-2(d)(3) of the Reimbursement Regulations.

Other than (i) expenditures to be paid or reimbursed from sources other than the Series 2013 Bonds, (ii) expenditures permitted to be reimbursed under the transitional provision contained in Section 1.150-2(j)(2) of the Reimbursement Regulations, (iii) expenditures constituting preliminary expenditures within the meaning of Section 1.150-2(f)(2) of the Reimbursement Regulations, or (iv) expenditures in a "de minimus" amount (as defined in Section 1.150-2(f)(1) of the Reimbursement Regulations), no expenditures for the 2013 Project have heretofore been paid by the Borrower and no expenditures will be paid by the Borrower until after the date of this Resolution.

The Borrower reasonably expects to reimburse some or all of the expenditures made for costs of the 2013 Project out of proceeds of the Series 2013 Bonds after the date of payment of all or a portion of the costs of the 2013 Project. All reimbursed expenditures shall be capital expenditures, a cost of issuance of the Series 2013 Bonds or other expenditures eligible for reimbursement under Section 1.150-2(d)(3) of the Reimbursement Regulations.

Section 12.3 <u>Budgetary Matters</u>. As of the date hereof, [and other than \$1,692,982 in Borrower funds reserved for construction of the 2013 Project,] there are no Borrower funds reserved, allocated on a long-term basis or otherwise set aside (or reasonably expected to be reserved, allocated on a long-term basis or otherwise set aside) to provide permanent financing for the expenditures related to the 2013 Project, other than pursuant to the issuance of the Series 2013 Bonds. The statement of intent contained in this resolution, therefore, is determined to be consistent with the Borrower's budgetary and financial circumstances as they exist or are reasonably foreseeable on the date hereof.

Section 12.4 <u>Reimbursement Allocations</u>. The City Fiscal Services Director shall be responsible for making the "reimbursement allocations" described in the Reimbursement Regulations, being generally the transfer of the appropriate amount of proceeds of the Series 2013 Bonds to reimburse the source of temporary financing used by the Borrower to make prior payment of the costs of the 2013 Project. Each allocation shall be evidenced by an entry on the

official books and records of the Borrower maintained for the Series 2013 Bonds or the 2013 Project and shall specifically identify the actual original expenditure being reimbursed.

Article XIII MISCELLANEOUS

Section 13.1 <u>Notices</u>. All notices or other communications hereunder shall be sufficiently sent or given and shall be deemed sent or given when delivered or mailed by certified mail, postage prepaid, to the parties at the following addresses:

- Section 13.2 <u>Binding Effect</u>. This Supplemental Resolution shall inure to the benefit of and shall be binding upon the DNRC, the Borrower and their respective successors and assigns.
- Section 13.3 <u>Severability</u>. If any provision of this Supplemental Resolution shall be determined to be unenforceable at any time, it shall not affect any other provision of the Resolution or the enforceability of that provision at any other time.
- Section 13.4 <u>Amendments</u>. This Supplemental Resolution may not be effectively amended except in accordance with Article IX of the Original Resolution.
- Section 13.5 <u>Applicable Law</u>. This Supplemental Resolution shall be governed by and construed in accordance with the internal laws of the State.
- Section 13.6 <u>Captions; References to Sections</u>. The captions in this Supplemental Resolution are for convenience only and do not define or limit the scope or intent of any provisions or Sections of this Supplemental Resolution.

Section 13.7 No Liability of Individual Officers, Directors or Trustees. No recourse under or upon any obligation, covenant or agreement contained in this Supplemental Resolution shall be had against any director, officer or employee, as such, past, present or future, of the DNRC, the DEQ or the Trustee, either directly or through the DNRC, the DEQ or the Trustee, or against any officer, or member of the governing body or employee of the Borrower, past, present or future, as an individual so long as such individual was acting in good faith. Any and all personal liability of every nature, whether at common law or in equity, or by statute or by constitution or otherwise, of any such officer or member of the governing body or employee of the DNRC, the Trustee or the Borrower is hereby expressly waived and released by the Borrower and by the DNRC as a condition of and in consideration for the adoption of this Supplemental Resolution and the making of the 2013 Loans.

Section 13.8 Payments Due on Holidays. If the date for making any payment or the last date for performance of any act or the exercise of any right, as provided in this Supplemental Resolution or the Series 2013 Bonds, shall not be Business Day, such payments may be made or act performed or right exercised on the next succeeding Business Day with the same force and effect as if done on the nominal date provided in this Supplemental Resolution or the Series 2013 Bonds.

Section 13.9 Right of Others To Perform Borrower Covenants. In the event the Borrower shall fail to make any payment or perform any act required to be performed hereunder, then and in each such case the DNRC or the provider of any Collateral Document may (but shall not be obligated to) remedy such default for the account of the Borrower and make advances for that purpose. No such performance or advance shall operate to release the Borrower from any such default and any sums so advanced by the DNRC or the provider of any Collateral Document shall be paid immediately to the party making such advance and shall bear interest at the rate of ten percent (10.00%) per annum from the date of the advance until repaid. The DNRC and the provider of any Collateral Document shall have the right to enter the 2013 Project or the facility or facilities of which the 2013 Project is a part or any other facility which is a part of the System in order to effectuate the purposes of this Section.

Section 13.10 <u>Authentication of Transcript</u>. The officers of the Borrower are hereby authorized and directed to furnish to the DNRC and to Bond Counsel certified copies of all proceedings relating to the issuance of the Series 2013 Bonds and such other certificates and affidavits as may be required to show the right, power and authority of the Borrower to issue the Series 2013 Bonds, and all statements contained in and shown by such instruments, including any heretofore furnished, shall constitute representations of the Borrower as to the truth of the statements of fact purported to be shown thereby.

Section 13.11 <u>Effective Date</u>. This Supplemental Resolution shall take effect immediately.

APPENDIX A

DESCRIPTION OF THE 2013 PROJECT

The 2013 Project consists of designing, engineering, constructing and installing improvements to the Borrower's sanitary sewerage system, including construction of a new ultraviolet light disinfection facility; reconfiguring the existing biological treatment system into two modern bioreactors with fine bubble diffusion, mixing equipment, and analytical controls capable of reducing ammonia and total nitrogen levels to meet current permit requirements and save energy; construction of a third bioreactor; construction of a new turbo blower facility; construction of hydraulic improvements; construction of a new flow meter structure; installation of magnetic flow meters; and related improvements.

FOR VALUE RECEIVED, THE CITY OF GREAT FALLS, MONTANA (the "Borrower"), a duly organized municipal corporation and political subdivision of the State of Montana, acknowledges itself to be specially indebted and, for value received, hereby promises to pay to the Department of Natural Resources and Conservation of the State of Montana (the "DNRC"), or its registered assigns, solely from the Debt Service Account of its Sanitary Sewerage System Fund, the principal sum equal to the sum of the amounts entered on Schedule A attached hereto under "Total Amount Advanced," with interest on each such amount from the date such amount is advanced hereunder at the rate of 2.00% per annum on the unpaid balance until paid. In addition, the Borrower shall pay, solely from said source, an Administrative Expense Surcharge and a Loan Loss Reserve Surcharge on the outstanding principal amount of this Bond at the rates of seventy-five hundredths of one percent (0.75%) per annum and twentyfive hundredths of one percent (0.25%) per annum, respectively. Interest and Administrative Expense Surcharge and a Loan Loss Reserve Surcharge shall be payable in semiannual installments payable on each January 1 and July 1 (each a "Loan Repayment Date") commencing January 1, 2014. Principal shall be payable on the dates set forth in Schedule B hereto. Each installment shall be in the amount set forth opposite its due date in Schedule B attached hereto under "Total Loan Payment." The portion of each such payment consisting of principal, the portion consisting of interest and the portion consisting of Administrative Expense Surcharge and the portion consisting of Loan Loss Reserve Surcharge shall be as set forth in Schedule B hereto. Upon each disbursement of 2013A Loan amounts to the Borrower pursuant to the Resolution described below, the DNRC shall enter (or cause to be entered) the amount advanced on Schedule A under "Advances" and the total amount advanced under the Resolution (as hereinafter defined), including such disbursement, under "Total Amount Advanced." DNRC shall prepare Schedule B and any revised Schedule B, or cause Schedule B and any revised Schedule B to be prepared, as provided in Section 5.1 of the supplemental resolution authorizing this Bond. Schedule B shall be calculated and recalculated on a level debt service basis assuming an interest rate of 3.00% per annum. Past-due payments of principal and interest shall bear interest at the rate of ten percent (10.00%) per annum, until paid. Interest shall be

calculated on the basis of a 360-day year comprising 12 months of 30 days each. All payments under this Bond shall be made to the registered holder of this Bond, at its address as it appears on the Bond register, in lawful money of the United States of America.

This Bond is one of an issue of Sanitary Sewerage System Revenue Bonds of the Borrower authorized to be issued in one or more series from time to time, and constitutes a series in the maximum authorized principal amount of \$7,084,000 (the "Series 2013A Bond"), issued to finance a portion of the costs of construction of certain improvements to the Sanitary Sewerage System of the Borrower (the "System"), to fund deposits to the Reserve Account, and to pay costs of issuance of the Series 2013A Bond. The Series 2013A Bond is issued pursuant to and in full conformity with the Constitution and laws of the State of Montana thereunto enabling, including Montana Code Annotated, Title 7, Chapter 7, Part 44 and 45, as amended, and ordinances and resolutions duly adopted by the governing body of the Borrower, including Resolution No. 9227, adopted by this Commission on May 7, 2002 (the "Original Resolution"), as amended and supplemented by Resolution Nos. 9228, 9454, 9863, 9986 and 9999 adopted May 7, 2002, January 18, 2005, September 1, 2009, July 17, 2012 and November 20, 2012, respectively, as further amended and supplemented by Resolution No. 10021, adopted June 18, 2013 (as so amended and supplemented, the "Resolution"). Terms used with initial capital letters but not defined herein have the meanings given to them in the Resolution. The Series 2013A Bond is issuable only as a single, fully registered bond. The Series 2013A Bond is issued on a parity and is equally and ratably secured by the Net Revenues of the System with the Borrower's outstanding First Amended and Restated Sanitary Sewerage System Revenue Bond (DNRC Revolving Loan Program), Series 2002B (the "Series 2002B Bond"), its Sanitary Sewerage System Revenue Bonds, Series 2005 (the "Series 2005 Bonds"), its Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2009B (the "Series 2009B Bond"), its Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2012 (the "Series 2012 Bond"), and its Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2013B (the "Series 2013B Bond"). The Series 2013B Bond is issued simultaneously herewith.

Reference is made to the Resolution for a more complete statement of the terms and conditions upon which the Series 2013A Bond has been issued, the Net Revenues of the System pledged and appropriated for the payment and security thereof, the conditions upon which additional bonds may be issued under the Resolution and made payable from such Net Revenues on a parity with the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, the Series 2013A Bond and the Series 2013B Bond (collectively, the "Bonds") or otherwise, the conditions upon which the Resolution may be amended, the rights, duties and obligations of the Borrower, and the rights of the owners of the Series 2013A Bond.

The Borrower may prepay the principal of the Series 2013A Bond only if (i) it obtains the prior written consent of the DNRC thereto, and (ii) no Loan Repayment or Administrative Expense Surcharge or Loan Loss Reserve Surcharge is then delinquent. Any prepayment permitted by the DNRC must be accompanied by payment of accrued interest and Administrative Expense Surcharge and Loan Loss Reserve Surcharge to the date of prepayment

on the amount of principal prepaid. If the Series 2013A Bond is prepaid in part, such prepayments shall be applied to principal payments in inverse order of maturity.

The Bonds, including interest and any premium for the redemption thereof, are payable solely from the Net Revenues pledged for the payment thereof and do not constitute a debt of the Borrower within the meaning of any constitutional, statutory or charter limitation or provision.

The Borrower may deem and treat the person in whose name this Series 2013A Bond is registered as the absolute owner hereof, whether this Series 2013A Bond is overdue or not, for the purpose of receiving payment and for all other purposes, and the Borrower shall not be affected by any notice to the contrary. The Series 2013A Bond may be transferred as hereinafter provided.

IT IS HEREBY CERTIFIED, RECITED, COVENANTED AND AGREED that the Borrower has duly authorized and will forthwith undertake the improvements to the System hereinabove described, has fixed and established and will collect reasonable rates and charges for the services and facilities afforded by the System, and has created a special Sanitary Sewerage System Fund into which the revenues of the System as defined in the Original Resolution (the "Revenues"), including all additions thereto and replacements and improvements thereof, will be paid, and a separate and special Debt Service Account in that fund, into which will be paid each month, Net Revenues of the System then on hand (the Revenues remaining after the payment of Operating Expenses (as defined in the Original Resolution) of the System), an amount equal to not less than the sum of one-sixth of the interest due within the next six months and one-twelfth of the principal due within the next twelve months with respect to all outstanding Bonds payable from that account, and a Reserve Account in that fund into which shall be paid additional Net Revenues sufficient to establish and maintain a reserve therein equal to, as of the date of calculation, the Reserve Requirement (as defined in the Resolution); that the Debt Service Account and the Reserve Account will be used only to pay the principal of, premium, if any, and interest on the Bonds issued pursuant to the authority herein recited; that the rates and charges for the System will from time to time be made and kept sufficient to (i) produce Revenues for each Fiscal Year in an amount at least sufficient to pay the principal of and interest on all Bonds payable from the Revenues derived in such Fiscal Year, to establish and maintain the Reserve Requirement, to pay promptly the reasonable and current Operating Expenses, to pay the principal of and interest on any Subordinate Obligations and to provide reserves for the repair and replacement of the System, and (ii) Net Revenues for each Fiscal Year will be equal to at least 125% of the maximum Principal and Interest Requirements for all future Fiscal Years during which any Bonds will be Outstanding; that Additional Bonds and refunding Bonds may be issued and made payable from the Debt Service Account on a parity with the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, the Series 2013A Bond and the Series 2013B Bond upon certain conditions set forth in the Resolution, but no obligation will be otherwise incurred and made payable from the Net Revenues unless the lien thereof shall be expressly made subordinate to the lien of the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, the Series 2013A Bond and the Series 2013B Bond, and other parity Bonds on such Net Revenues and such obligations are payable only from Net Revenues available in the Subordinate Obligations Account; that all

provisions for the security of this Series 2013A Bond set forth in the Resolution will be punctually and faithfully performed as therein stipulated; that all acts, conditions and things required by the Constitution and laws of the State of Montana and the ordinances and resolutions of the Borrower to be done, to exist, to happen and to be performed in order to make this Series 2013A Bond a valid and binding special obligation of the Borrower according to its terms have been done, do exist, have happened and have been performed as so required; and that this Series 2013A Bond and the premium, if any, and interest hereon are payable solely from the Net Revenues of the System pledged and appropriated to the Debt Service Account and do not constitute a debt of the Borrower within the meaning of any constitutional, statutory or charter limitation or provision and the issuance of the Series 2013A Bond does not cause either the general or the special indebtedness of the Borrower to exceed any constitutional, statutory or charter limitation.

IN WITNESS WHEREOF, the City of Great Falls, Montana, by its governing body, has caused this Bond to be executed by the signatures of its Mayor, City Manager, City Fiscal Services Director, and City Clerk, and has caused the official seal of the Borrower to be affixed hereto, and has caused this Bond to be dated as of the 26th day of June, 2013.

REGISTRATION AND TRANSFER

This Bond shall be fully registered as to both principal and interest. FOR VALUE RECEIVED, THE CITY OF GREAT FALLS, MONTANA (the "Borrower"), a duly organized municipal corporation and political subdivision of the State of Montana, acknowledges itself to be specially indebted and, for value received, hereby promises to pay to the Department of Natural Resources and Conservation of the State of Montana (the "DNRC"), or its registered assigns, solely from the Debt Service Account of its Sanitary Sewerage System Fund, the principal sum equal to the sum of the amounts entered on Schedule A attached hereto under "Total Amount Advanced," with interest on each such amount from the date such amount is advanced hereunder at the rate of 2.00% per annum on the unpaid balance until paid. As described more particularly in the Resolution (as hereinafter defined), the 2013B First Advance will be made, if at all, following the advance of the full principal amount of the Series 2013A Bond (as such terms are defined hereinafter or in the Resolution), and upon the making of the 2013B First Advance, the DNRC shall enter the applicable amount on Schedule A hereto and attach the applicable Schedule B hereto. In addition, the Borrower shall pay, solely from said source, an Administrative Expense Surcharge and a Loan Loss Reserve Surcharge on the outstanding principal amount of this Bond at the rates of seventy-five hundredths of one percent (0.75%) per annum and twenty-five hundredths of one percent (0.25%) per annum, Interest and Administrative Expense Surcharge and a Loan Loss Reserve Surcharge shall be payable in semiannual installments payable on each January 1 and July 1 (each a "Loan Repayment Date") commencing on the date first set forth under the column "Date" on Schedule B attached hereto. Principal shall be payable on the dates set forth in Schedule B hereto. Each installment shall be in the amount set forth opposite its due date in Schedule B attached hereto under "Total Loan Payment." The portion of each such payment consisting of principal, the portion consisting of interest and the portion consisting of Administrative Expense Surcharge and the portion consisting of Loan Loss Reserve Surcharge shall be as set forth in Schedule B hereto. Upon each disbursement of 2013B Loan amounts to the Borrower pursuant to the Resolution described below, the DNRC shall enter (or cause to be entered) the amount advanced on Schedule A under "Advances" and the total amount advanced under the Resolution (as hereinafter defined), including such disbursement, under "Total Amount Advanced." The DNRC shall prepare Schedule B and any revised Schedule B, or cause Schedule B and any revised Schedule B to be prepared, as provided in Section 5.1 of the supplemental resolution authorizing this Bond. Schedule B shall be calculated and recalculated on a level debt service basis assuming an interest rate of 3.00% per annum. Past-due payments of principal and interest shall bear interest at the rate of ten percent (10.00%) per annum, until paid. Interest shall be calculated on the basis of a 360-day year comprising 12 months of 30 days each. All payments under this Bond shall be made to the registered holder of this Bond, at its address as it appears on the Bond register, in lawful money of the United States of America.

This Bond is one of an issue of Sanitary Sewerage System Revenue Bonds of the Borrower authorized to be issued in one or more series from time to time, and constitutes a series in the maximum authorized principal amount of \$7,084,000 (the "Series 2013B Bond"), issued to finance a portion of the costs of construction of certain improvements to the Sanitary Sewerage System of the Borrower (the "System"), to fund deposits to the Reserve Account, and to pay costs of issuance of the Series 2013B Bond. The Series 2013B Bond is issued pursuant to and in full conformity with the Constitution and laws of the State of Montana thereunto enabling, including Montana Code Annotated, Title 7, Chapter 7, Part 44 and 45, as amended, and ordinances and resolutions duly adopted by the governing body of the Borrower, including Resolution No. 9227, adopted by this Commission on May 7, 2002 (the "Original Resolution"), as amended and supplemented by Resolution Nos. 9228, 9454, 9863, 9986 and 9999 adopted May 7, 2002, January 18, 2005, September 1, 2009, July 17, 2012 and November 20, 2012, respectively, as further amended and supplemented by Resolution No. 10021, adopted June 18, 2013 (as so amended and supplemented, the "Resolution"). Terms used with initial capital letters but not defined herein have the meanings given to them in the Resolution. The Series 2013B Bond is issuable only as a single, fully registered bond. The Series 2013B Bond is issued on a parity and is equally and ratably secured by the Net Revenues of the System with the Borrower's outstanding First Amended and Restated Sanitary Sewerage System Revenue Bond (DNRC Revolving Loan Program), Series 2002B (the "Series 2002B Bond"), its Sanitary Sewerage System Revenue Bonds, Series 2005 (the "Series 2005 Bonds"), its Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2009B (the "Series 2009B Bond"), its Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2012 (the "Series 2012 Bond"), and its Sanitary Sewerage System Revenue Bond (DNRC Water Pollution Control State Revolving Loan Program), Series 2013A (the "Series 2013A Bond"). The Series 2013A Bond is issued simultaneously herewith.

Reference is made to the Resolution for a more complete statement of the terms and conditions upon which the Series 2013B Bond has been issued, the Net Revenues of the System pledged and appropriated for the payment and security thereof, the conditions upon which additional bonds may be issued under the Resolution and made payable from such Net Revenues on a parity with the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, the Series 2013A Bond and the Series 2013B Bond (collectively, the "Bonds") or otherwise, the conditions upon which the Resolution may be amended, the rights, duties and obligations of the Borrower, and the rights of the owners of the Series 2013B Bond.

The Borrower may prepay the principal of the Series 2013B Bond only if (i) it obtains the prior written consent of the DNRC thereto, and (ii) no Loan Repayment or Administrative Expense Surcharge or Loan Loss Reserve Surcharge is then delinquent. Any prepayment permitted by the DNRC must be accompanied by payment of accrued interest and Administrative Expense Surcharge and Loan Loss Reserve Surcharge to the date of prepayment on the amount of principal prepaid. If the Series 2013B Bond is prepaid in part, such prepayments shall be applied to principal payments in inverse order of maturity.

The Bonds, including interest and any premium for the redemption thereof, are payable solely from the Net Revenues pledged for the payment thereof and do not constitute a debt of the Borrower within the meaning of any constitutional, statutory or charter limitation or provision.

The Borrower may deem and treat the person in whose name this Series 2013B Bond is registered as the absolute owner hereof, whether this Series 2013B Bond is overdue or not, for the purpose of receiving payment and for all other purposes, and the Borrower shall not be affected by any notice to the contrary. The Series 2013B Bond may be transferred as hereinafter provided.

IT IS HEREBY CERTIFIED, RECITED, COVENANTED AND AGREED that the Borrower has duly authorized and will forthwith undertake the improvements to the System hereinabove described, has fixed and established and will collect reasonable rates and charges for the services and facilities afforded by the System, and has created a special Sanitary Sewerage System Fund into which the revenues of the System as defined in the Original Resolution (the "Revenues"), including all additions thereto and replacements and improvements thereof, will be paid, and a separate and special Debt Service Account in that fund, into which will be paid each month, Net Revenues of the System then on hand (the Revenues remaining after the payment of Operating Expenses (as defined in the Original Resolution) of the System), an amount equal to not less than the sum of one-sixth of the interest due within the next six months and one-twelfth of the principal due within the next twelve months with respect to all outstanding Bonds payable from that account, and a Reserve Account in that fund into which shall be paid additional Net Revenues sufficient to establish and maintain a reserve therein equal to, as of the date of calculation, the Reserve Requirement (as defined in the Resolution); that the Debt Service Account and the Reserve Account will be used only to pay the principal of, premium, if any, and interest on the Bonds issued pursuant to the authority herein recited; that the rates and charges for the System will from time to time be made and kept sufficient to (i) produce Revenues for each Fiscal Year in an amount at least sufficient to pay the principal of and interest on all Bonds payable from the Revenues derived in such Fiscal Year, to establish and maintain the Reserve Requirement, to pay promptly the reasonable and current Operating Expenses, to pay the principal of and interest on any Subordinate Obligations and to provide reserves for the repair and replacement of the System, and (ii) Net Revenues for each Fiscal Year will be equal to at least 125% of the maximum Principal and Interest Requirements for all future Fiscal Years during which any Bonds will be Outstanding; that Additional Bonds and refunding Bonds may be issued and made payable from the Debt Service Account on a parity with the Series 2002B Bond, the Series 2005 Bonds, the Series 2009B Bond, the Series 2012 Bond, the Series 2013A Bond and the Series 2013B Bond upon certain conditions set forth in the Resolution, but no
