Item: Purchase of Anhydrous Ammonia

Action Requested: Approval of Bid

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission accept the low bid from DPC Industries, Inc. and authorize staff to purchase anhydrous ammonia in the amount of \$1.46 per pound for FY 2013/14."

2. Mayor calls for a second, discussion, inquiries from the public, and calls the vote.

Staff Recommendation: Staff recommends that the City Commission accept the low bid from DPC Industries, Inc. in the amount of \$1.46 per pound for anhydrous ammonia for FY 2013/14.

Background: Anhydrous ammonia is used in the water treatment process to produce chloramine, which provides a disinfectant residual in the drinking water. Specifications and bid materials were prepared for the purchase of anhydrous ammonia for the Water Treatment Plant for the upcoming fiscal year. Notices were sent out to all prospective bidders and publicly advertised. The bid from DPC Industries, Inc. was acceptable as submitted.

Bids were accepted on April 17, 2013, for FY 2013/14 Water Treatment Plant chemical needs. DPC Industries Inc., with headquarters in Hudson, Colorado, provided the lowest acceptable bid for anhydrous ammonia at \$1.46 per pound. This Commission action would award a contract for FY 2013/14.

Concurrences: not applicable

Fiscal Impact: This price reflects a 1.2% decrease from the FY 2012/13 contract price. The new contract would allow for the purchase of a maximum of 17,000 pounds for a total cost of \$24,820.
