**Staff Recommendation:** It is recommended that the City Commission reappoint Cam Cherry as the Women’s Golf Association member and Lonnie Yingst as a Non-League member to the Golf Advisory Board to three-year terms through March 31, 2016.

**Background:** Cam Cherry was appointed to the Golf Advisory Board as the Women’s Association member in April of 2010. Lonnie Yingst was also appointed in April of 2010 to serve as a Non-League member. The terms of both Ms. Cherry and Mr. Yingst expired on March 31<sup>st</sup>. Both members are eligible for and interested in reappointment.

Purpose

The Golf Advisory Board is comprised of five members with representation from the City Men’s Golf Associations, City Women’s Golf Associations, Malmstrom Golf Association, and two Non-league golfers. The Board advises the City Commission regarding the operation of municipal golf courses. Members must reside within the City limits.

Evaluation and Selection Process

No advertising was done since both members are eligible for and interested in reappointment.
