**Item:** Resolution 10067, Establishing Fees for the City of Great Falls,

Mapping & Addressing Division

**Action Requested:** Conduct Public Hearing and adopt Resolution 10067.

### **Public Hearing:**

1. Mayor conducts public hearing, calling three times each for proponents and opponents.

2. Mayor closes public hearing and asks the will of the Commission.

## **Suggested Motion:**

1. Commissioner moves:

"I move the City Commission (adopt/deny) Resolution 10067."

2. Mayor calls for a second, discussion, and calls for the vote.

**Staff Recommendation:** Staff recommends adopting Resolution 10067, Establishing fees for the City of Great Falls, Mapping & Addressing Division.

**Background:** The City of Great Falls Mapping and Addressing Division (Mapping) currently provides a service to the City of Great Falls and Cascade County that includes various types of mapping requests, as well as verifying and assigning addresses for new or additional address on properties. Currently, Mapping does charge fees for City generated maps but has never formally adopted the fees. Resolution 10067 will formally adopt the fees for City generated maps. The fees will be for external customers only.

The Mapping Division currently does not charge any fees for addressing. Resolution 10067 will charge a \$20 fee for a new address or additional address on a property. This charge will be assessed on addressing changes that have been initiated by the owner of the property. An additional charge (\$10) will be assessed for the reflective address numbers prepared by City staff (again per the owner's request). County addressing is being contracted per the Address Coordinator with the City of Great Falls, so at this time only the addresses assigned within the city limits of Great Falls will be charged an addressing fee.

**Concurrences:** The proposed fee is in alignment with other departments across the state.

**Alternatives:** The Commission could choose not to adopt Resolution 10067 and not charge a fee for this service.

#### **RESOLUTION NO. 10067**

## A RESOLUTION TO ESTABLISH FEES FOR THE CITY OF GREAT FALLS MAPPING & ADDRESSING DIVISION

**WHEREAS**, § 7-6-4013, MCA, empowers municipalities to impose a fee for the provision of a service; and

**WHEREAS**, the Mapping & Addressing Division provides a service to the City of Great Falls and Cascade County that includes various types of mapping requests, as well as verifying and assigning addresses for new or additional addresses on properties; and

**WHEREAS**, said services require staff time that includes driving to the structure to record the location using a GPS unit and to process and return the applications; and

**WHEREAS**, implementing an administrative fee will recover expenses, such as depreciation on the GPS equipment, and upgrading outdated GPS software, incurred in providing these services; and

**WHEREAS,** currently the county addressing is being contracted per the Address Coordinator with the City of Great Falls, and, therefore, at this time only the addresses assigned *within* the city limits of Great Falls shall be charged a fee.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, AS FOLLOWS:

Fees for the City of Great Falls Mapping & Addressing Division are hereby established as follows:

## A. Mapping Fees for City generated maps (external customers).

8 ½ x 11 Printed Map	\$5.00 (Charge \$1.00 per copy after the first)
11 x 17 Printed Map	\$7.00 (Charge \$1.50 per copy after the first)
City Parcel Base Map	\$20.00
City Area Grid Map	\$20.00
Street Name & Address Guide Book	\$45.00
City Zoning Map (small)	\$10.00
City Zoning Map (large)	\$20.00
Fire Districts Map (large)	\$20.00
City of Great Falls Aerial	\$35.00*
City of Great Falls Shaded Relief	\$35.00*
Special Request	Price varies**

- B. Addressing Fees.
  - 1. A twenty dollar (\$20) fee for landowners to obtain a new address or an additional address on the property (per the owner's request).
  - 2. A ten dollar (\$10) fee for reflective address numbers (per the owner's request) prepared by City staff.
