Action Requested: Reject Bids

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission (reject/not reject) the bids for the 2014 traffic counters."

2. Mayor calls for a second, discussion, public comment, and calls for the vote.

Staff Recommendation: Staff recommends that the City Commission reject the bids for the 2014 traffic counters for non-compliance.

Background:

<u>Purpose</u>

These units will be used by the Traffic Division to collect traffic data which is provided to the City Planning Department and the State Department of Transportation. The data collected is used for planning future transportation projects.

Evaluation and Selection Process

The specifications were advertised two times in the Great Falls Tribune, placed on the City of Great Falls website, and mailed to five prospective bidders with two bidders responding. The bids were opened on May 21, 2014. None of the bids received contained a bid security.

Staff will be requesting quotes from the list of bidders. The total of this purchase will be under \$80,000. The purchase will then be placed on a future Consent Agenda.

Fiscal Impact: Funds for their purchase are Metropolitan Planning Funds provided by the State Department of Transportation.
