Action Requested: City Commission Adopt Resolution 10054 and Set Public Hearing Date

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission (adopt/deny) Resolution 10054 and set a Public Hearing for the creation of City Owned Special Improvement Lighting District No. 1309 for March 3, 2015."

2. Mayor calls for a second, discussion, public comment, and calls the vote.

Staff Recommendation: Staff recommends the City Commission adopt Resolution 10054 and set a public hearing for the creation of City Owned Special Improvement Lighting District No. 1309 for March 3, 2015.

Background: The City Commission adopted Resolution 9506 creating the City's Street Light Policy on July 19, 2005. This resolution established the City's policy to own and operate any new street lighting districts within the City limits, requested by property owners or developers, as allowed by MCA 7-12-4301, 7-12-4329 and 7-12-4333. These statutes authorize the City to create lighting districts and to assess the cost of installing and/or maintaining the district to the property owners within the boundaries of the district.

Staff received a signed petition from Stone Meadows Inc. and Silver Stone Enterprises, developers of Stone Meadows Addition Phase II as shown on Exhibit "A." Then on January 20, 2015, the developers presented another revised signed Petition with changes to the number of parcels within the subdivision due to a new amended plat for Stone Meadows Addition Phase II as shown on Exhibit "A1." Both petitions are requesting the installation of eight (8) 100 watt HPS Semi-cut off Street Lights, however, it was determined by final design, the actual number of lights to be installed will be nine (9) 100 watt HPS Semi-cutoff street lights mounted on 20 foot steel poles with underground wiring as shown on the map marked Exhibit "B." The signed

petitions meet all requirements as set forth in the policy for new street light districts. Property owners have 15 days after the date of the first publication of the Legal Notice or written notification as shown on Exhibit "E" and "F", respectively, to make a written protest against the proposed creation of the Special Improvement Lighting District.

Concurrences: Respresentatives from the City's Public Works, Fiscal Services, Engineering and Planning Department work with the property owners and developers throughout the review and approval process of the lighting district creation and construction.

Fiscal Impact: The special assessment for the installation costs of the improvements will be financed through the Montana Board of Investments following the Bid Opening and the monies received will be payable over a term not to exceed fifteen years.

The estimated assessment for construction, exclusive of annual interest of 3% will be \$104.02 for an average sized lot of 10,450 square feet; and as shown on Exhibit "C" of the resolution. Property owners have the right to prepay the assessment as provided by law.

The ongoing estimated annual maintenance assessment will be \$99.20 for an average sized lot of 10,450 square feet. The maintenance costs include energy, transmission, distribution and other ongoing related costs; and as shown on Exhibit "D" of the resolution.

Alternatives: The City Commission could choose to not set the public hearing and thereby deny the adoption of Resolution 10054 to Create City Owned Special Improvement Lighting District No. 1309.

RESOLUTION NO. 10054

A RESOLUTION DECLARING IT TO BE THE INTENTION OF THE CITY COMMISSION OF THE CITY OF GREAT FALLS. MONTANA, TO CREATE Α CITY OWNED **SPECIAL** IMPROVEMENT LIGHTING DISTRICT NO. 1309 IN THE CITY OF GREAT FALLS, MONTANA FOR THE PURPOSE OF FINANCING THE INSTALLATION OF, AND SECURING AND PROVIDING **ENERGY** AND **MAINTENANCE FOR** STREETLIGHTS: DESIGNATING THE NUMBER OF SAID DISTRICT; DESCRIBING **BOUNDARIES THEREOF; STATING** THE GENERAL CHARACTER OF THE IMPROVEMENTS TO \mathbf{BE} MADE; THE **ESTABLISHING** THE **ESTIMATE** OF **COST** MAINTAINING SUCH LIGHTS AND SUPPLYING ELECTRIAL CURRENT THERFOR FOR THE FIRST YEAR; THE PROPORTION OF THE COST TO BE ASSESSED AGAINST THE BENEFITED PROPERTY: AND, THE METHOD OF ASSESSMENT OF SAID **COST**

WHEREAS, the City Commission of the City of Great Falls is authorized to create special improvement districts embracing any street or streets or public highway therein or portions thereof and property adjacent thereto or property which may be declared by said City Commission to be benefited by the improvement to be made for the purpose of lighting such street or streets or public highway; and,

WHEREAS, the City Commission of the City of Great Falls is authorized to require that all or any portion of the cost of installing and maintaining such lighting system be paid by the owners of the property embraced within the boundaries of such special improvement district; and,

WHEREAS, the City Commission of the City of Great Falls is authorized to assess and collect the costs for installation and maintenance by special improvement assessment against the properties within the district.

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, that:

<u>Section 1 – Intent to Create</u>

That the public interest and convenience requires, and it is deemed necessary, to create a City Owned Special Improvement Lighting District No. 1309 for the purpose of financing the installation of, securing and providing energy and maintenance for new streetlights for lighting in said district; and the intention of said City Commission to create such a district, hereinafter more particularly described, is hereby declared.

<u>Section 2 – Special Improvement Lighting District Number</u>

The number of said Special Improvement Lighting District is hereby designated as City Owned Special Improvement Lighting District No. 1309, hereinafter called the District.

Section 3 – Defined Boundaries

The boundaries of said District are hereby declared to be as follows:

Beginning at the southwest corner of Block 3, Lot 4A of Stone Meadows Addition Phase 2; thence northerly along the west boundary of Stone Meadows Addition Phase 2 to the northwest corner of Block 2, Lot 6B; thence easterly along the north boundary of Stone Meadows Addition Phase 2 to the northeast corner of Block 5, Lot 5, thence southerly along the easterly boundary of Stone Meadows Addition Phase 2 to the southeast corner of Block 5, Lot 2; thence westerly along the south boundary of Stone Meadows Addition Phase 2 to the southwest corner of Block 3, Lot 4A and point of beginning.

The lands included in the District boundaries are shown on the attached map designated as Exhibit "B" and as listed in Exhibits "C & D." The legal descriptions of the lots, parcels and tracts of land within the District are shown on Exhibits "C & D" attached hereto.

<u>Section 4 – General Improvements</u>

The general character of the improvements to be made for the District is hereby declared to be as follows: The provision of energy and maintenance for street lighting facilities and the installation of nine (9) 100 Watt HPS Street lighting units mounted on 20 foot steel poles with underground wiring.

<u>Section 5 – Assessment Method</u>

The City Commission of the City of Great Falls hereby finds and determines that all real estate situated within the boundaries of said District will be especially benefited and affected by such improvements, and that all property included within the District is hereby declared to be the property to be assessed for the cost and expense of making said improvements.

The special assessment for the installation cost of the improvements shall be payable over a term not to exceed 15 years. The installation costs are estimated to be \$.147693 per square foot assessable area and the property owners have the right to prepay the assessment as provided by law.

The ongoing annual assessment for providing energy, maintenance and administrative costs is estimated to be \$.00943 per square foot assessable area.

The assessable area and related costs of construction for each lot or parcel of land is shown on Exhibit "C" and, the assessable area and estimated costs of maintenance for each lot or parcel of land is shown on Exhibit "D" attached hereto.

Section 6 – Publication of Legal Notice

In accordance with § 7-1-4127, MCA, the City Clerk is hereby authorized and directed to publish

notice of the adoption of Resolution 10054, the Intent to Create a City Owned Special Improvement Lighting District No. 1309 for the purpose of financing the installation, securing and providing energy and maintenance for new streetlights for lighting in said District and setting a Public Hearing for March 3, 2015.

The City Clerk is hereby further directed to mail a copy of said notice to the owners of all the lots, blocks, pieces or parcels of land included within the boundaries of proposed City Owned Special Improvement Lighting District No. 1309. Said notice is to be published and mailed on the same date.

Section 7 – Public Hearing and Protest Period

On Tuesday the 3rd of March, 2015, at the City Commission Chambers, Room 206 in the Civic Center, Great Falls, Montana, at 7:00 o'clock p.m., the Commission will conduct a public hearing on the creation of the Special Improvement Lighting District and pass upon any written protests timely filed against creation of the Special Improvement Lighting District.

Within 15 days after the date of the first publication of the notice of passage of this resolution of intention, any owner of property liable to be assessed for the cost of the improvements may make written protest to the City Clerk against the proposed work or against the extent or creation of the Special Improvement Lighting District to be assessed or both.



We, the undersigned property owners of Great Falls, respectfully request that a Special Improvement Lighting District be created in the area: Stone Meadows Phase 2 (A) & (B)

This is for the anticipated installation of: eight (8) 100 Watt HPS Semi-cut off Street Light units mounted on 20 foot steel/fiberglass poles with underground wiring, wherein the actual amount of lights, types and sizes will be determined upon final design.

The cost of the Special Improvement Lighting District is to be paid for by the property owners within the district being assessed one hundred percent (100%) of the annual costs.

Using current dollars, this will result in an **estimated** annual assessment during the first fifteen (15) years in the newly created area of \$142.42 for an average lot of 9,401 square feet for the installation and maintenance of the lights. 



Dear Property Owner:

The creation of City Owned Special Improvement Lighting District No. 1309 is being considered as petitioned by the developers of Stone Meadows Addition Phase II. This petition has started the process to install nine (9) 100 Watt HPS street lighting units on 20 foot steel poles with underground wiring.

If the City Commission adopts the proposed resolution, it would result in an **estimated** annual lighting installation assessment of \$104.02, exclusive of annual interest of 3% for a period of 15 years, and an **estimated** ongoing annual maintenance assessment of \$99.20 for your property. The total costs will be split proportionately per square foot to the 28 planned parcels contained within Stone Meadows Addition Phase II and will appear on the property tax bill beginning with the 2015/2016 assessment year.

Montana State Law requires sending individual notices of intent to each affected property owner in addition to the publication of the legal notice relating to the creation and assessment of the district. The enclosed notice is scheduled to be published in the *Great Falls Tribune* on Friday, February 6, 2015 and again on Friday, February 13, 2015.

At any time within 15 days after the date of the first publication of the notice of the resolution of intent, any owner of property liable to be assessed for said work may make written protest against the creation of the district. Such notice must be in writing, must list the property address and parcel number if known, must include signatures of all owners of the property, must indicate the resolution number being protested and may be mailed to City Clerk, PO Box 5021, Great Falls, MT 59403 or hand-delivered to the City Clerk, Civic Center Room 204, 2 Park Drive South, Great Falls, MT, who shall endorse thereon the date of its receipt.

Each protest shall be weighted in proportion to the amount of the assessment to be placed upon the lot or parcel of property. If the City Commission finds that such protests constitute a majority of the total assessments, the resolution will be denied.
