2. Mayor calls for a second, discussion, public comment, and calls the vote.

Recommendation: It is recommended that the City Commission consider an appointment to the Board of Adjustment/Appeals for the remainder of a three-year term through September 30, 2016.

Background: Dale Nelson has moved out of the City limits since being appointed and is no longer eligible to serve on the Board. Therefore, it is necessary to make an appointment to the Board to fill the vacancy.

<u>Purpose</u>

The Board of Adjustment/Appeals consists of five members appointed by the City Commission. The Board hears and decides appeals regarding zoning, housing, and building codes and ordinances; hears and decides, requests for variances from standards set forth in zoning ordinances; hears and decides all other matters referred to the Board regarding zoning, housing, and building ordinances. Members serve three-year terms and, per Municipal Code, must reside within the City limits.

The International Building Code requires the Board of Adjustment's membership to be qualified by experience and training to pass on matters pertaining to building construction. The International Mechanical Code requires the Board of Adjustment's membership to include registered design professionals with structural engineering, electrical engineering, and architectural experience. **Evaluation and Selection Process**

Advertising was done on the City website and through the local media. One application was received.
