Item: Two New 2016 Pumper Fire Trucks

Action Requested: Approve Purchase of two 2016 Peterbilt Pumper AS573 fire trucks

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission (approve/reject) the purchase of two new 2016 Peterbilt Pumper AS573 fire trucks to Pierce Manufacturing, Inc in the amount of \$796,859 and authorize the City Manager to execute the contract documents."

2. Mayor requests a second to the motion, Commission discussion, public comment, and calls for the vote.

Staff Recommendation: Staff recommends that the City Commission approve the purchase of two new 2016 Peterbilt Pumper AS573 fire trucks to Pierce Manufacturing, Inc in the amount of \$796,859.

Summary: On November 3, 2015 the City Commission authorized the participation in the Houston Galveston Area Council (H-GAC) Cooperative Purchasing Program. This purchase is being made through the H-GAC Purhasing Program. The City received \$35,579 in discounts for 100% prepayment and two units being purchased, manufactured and delivered at the same time. If units are not ordered, manufactured and delivered at the same time revised pricing will be required, which would result in an increased cost. The pricing is only valid for an H-GAC purchase on contract FS12-13, which expires November 30, 2015. Orders submitted after November 30, 2015 will be subject to increased contract pricing.

Fiscal Impact: Funds for the trucks purchase will be provided by a loan applied for and approved from the Montana Board of Investments (as previously mentioned at prior City Commission Work Sessions). The loan closing documents will be presented to the City Commission for approval in the near future.

Alternatives: The City Commission could vote to reject the purchase.

Terms:

The unit(s) would be ready for delivery from the factory within 9 to 11.5 months after contract execution.

The above pre-payment discount will be valid for 90 days.

Two (2) unit pricing is based on both units being purchased, manufactured and delivered at the same time. If units are not ordered, manufactured and delivered at the same price revised pricing will be required.

If payment discount options are not elected standard payment terms will apply: Final payment will be due 30 days after the unit leaves the factory for delivery. If payment is not made at that time a late fee will be applicable.

The proposal price is based on the unit being purchased through HGAC. This pricing is only valid for an HGAC purchase on contract FS12-13 which expires November 30, 2015. Orders submitted after November 30, 2015 will be subject to new contract pricing.

Transportation of the unit to be driven from the factory is included in the pricing. However, if we are unable to obtain necessary permits, due to the weight of the unit, and the unit must be transported on a flat bed, additional transportation charges will be the responsibility of the purchaser. We will provide pricing at that time if necessary.
