# **Suggested Motion:**

1. Commissioner moves:

"I move that the City Commission (approve/reject) the bid award for three new 2016 Kenworth T370 tandem axle dump trucks with Williamsen-Godwin boxes to Motor Power Great Falls, Inc., for \$292,001, including trade-ins."

2. Mayor requests a second to the motion, Commission discussion, and calls for the vote.

**Staff Recommendation:** Staff recommends that the City Commission approve the bid award for three new 2016 Kenworth T370 tandem axle dump trucks with Williamsen-Godwin boxes to Motor Power Great Falls, Inc., for \$292,001, including trade-ins.

**Summary:** The bid specifications for the tandem axle dump trucks were requested for the purchase of two and four trucks. The same per unit price was received for two and four trucks. The City also received a good trade in allowance for two of its current back-up dump trucks.

City Staff requested to postpone the bid award, in order to review funding availability and consider the possibility of buying three trucks. The City Commission approved the postponement at the City Commission Meeting on December 1, 2015. Four tandem axle dump trucks were due for replacement in Fiscal Year 2016. Funding for the purchase of two trucks was approved in the Fiscal Year 2016 Budget, but due to the lower bid amount there is funding available to purchase an additional truck.

# **Background:**

# Purpose

The tandem axle dump trucks will be used in the Street Division. Uses include material hauling for city street projects such as sand, gravel and paving projects.

# **Evaluation and Selection Process**

The specifications were advertised two times in the Great Falls Tribune, placed on the City of Great Falls website, and mailed to eight prospective bidders. The bids were opened on November 18, 2015, with four bidders responding, two with alternate bids.

Staff recommends accepting Motor Power's trade-in offer of \$20,000 for each of the City's 1993 Freightliner Tandem axle trucks (Units #810 and #828), for a total of \$40,000.

#### Conclusion

The bid by Motor Power Great Falls, Inc. was the low bid, including the trade-ins and meets specifications for the tandem axle dump trucks.

**Fiscal Impact:** Funds for this scheduled purchase from the ERS (Equipment Revolving Schedule) were provided in the FY 2016 Street Fund Budget.

**Alternatives:** The City Commission could reject the bids for the purchase of three new 2016 tandem axle dump trucks.
