Summary: The Park and Recereation Board has four Board members with terms expiring on December 31, 2015. One member is elegible and interested in reappointment. Three members have served two full terms and cannot be reappointed.

Background: Shirley Davis was appointed to the Board in 2013 to a three-year term. Ms. Davis is eligible for and interested in reappointment. Charlie Bruckner and Bill Ramsey were appointed in 2010 and reappointed in 2015. They are not eligible for reappointment. Russell Motschenbacher was appointed to a three-year term in 2009 and reappointed in 2013. Mr. Motschenbacher resigned in August 2015.

<u>Purpose.</u> The Park and Recreation Board consists of seven members who act in an advisory capacity to the City Commission and the City Manager on all matters related to the Park and Recreation program in the City of Great Falls. Per City Ordinance, members must reside within the City.

Evaluation and Selection Process

Advertising was done on the City's website and through the local media. Five applications were received.


