Item: One New 2016 Tandem Axle Roll-Off Truck

Action Requested: Award Bid

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission (approve/reject) the bid award for one new 2016 Kenworth T800 tandem axle roll-off truck with Galbreath Rail System to Motor Power of Great Falls for \$169,405.38."

2. Mayor requests a second to the motion, Commission discussion, public comment, and calls for the vote.

Staff Recommendation: Staff recommends that the City Commission award the bid for one new 2016 Kenworth T800 tandem axle roll-off truck with Galbreath Rail System to Motor Power of Great Falls for \$169,405.38.

Background:

Purpose

This unit will be used for commercial solid waste collection.

Evaluation and Selection Process

The specifications were advertised two times in the Great Falls Tribune, placed on the City of Great Falls website, and mailed to six prospective bidders. The bids were opened on January 6, 2016 with six bidders responding, each with alternate bids.

Conclusion

The bid by Motor Power meets specifications for the tandem axle roll-off truck. The lower bids did not meet specifications.

Fiscal Impact: As previously mentioned, funds for the purchase of the sanitation trucks will be financed through the Montana Board of Investments. The Montana Board of Investments has

agreed to loan the City of Great Falls, \$1,400,000 for the purchase of the trucks, plus the required 10% reserve amount. The total loan amount is for \$1,540,000. The loan has a variable interest rate that changes annually in February and the current interest rate is 1.25%. The term of the loan will be 6 years and will be repayable from the Sanitation Fund at approximately \$268,000 a year. After the bid award of the sanitation trucks has been approved, the City Commission will be asked to pass a resolution authorizing the participation in the Board of Investments Intercap Revolving Program for the purchase of the sanitation trucks. Early redemption of the loan is possible. The average annual interest rate of this program for the last 5 years is 1.29%. The closing date of this borrowing will be scheduled once the bid for the sanitation trucks has been awarded and the resolution for participation has been passed.

Alternatives: City Commission could vote to reject the bids for the purchase of this new 2016 tandem axle roll-off truck.
