# CITY OF GREAT FALLS COMMISSION AGENDA REPORT

**Action Requested:** Appoint one new member to the Audit Committee to fill a private citizen

member position through June 30, 2019.

## **Suggested Motion:**

1. Commissioner moves:

"I move that the City Commission appoint \_\_\_\_\_\_ to the Audit Committee to fill a private citizen position through June 30, 2019"

2. Mayor calls for a second to the motion, Commission discussion, public comment, and calls for the vote.

**Staff Recommendation:** It is recommended that the City Commission appoint one new member to the Audit Committee to fill a private citizen member position.

Staff is recommending that the Audit Committee set term appointments similar to the other City Boards and Commissions and set the terms to run concurrent with fiscal years beginning July 1 through June 30. This position would be a partial term from December 20, 2016 through June 30, 2019.

**Background:** During the May 17, 2016 City Commission meeting the City Commission approved to increase the number of members on the committee to include an additional private citizen. Advertising for this new position began in May 2016 through the local media and on the City of Great Falls website. One application was received.

#### Purpose

The Audit Committee was established by the City Commission in October of 1992 and consists of five members to include the Mayor, a Commissioner, the City Manager, the Fiscal Services Director and a private citizen.

The Audit Committee provides assurance that the financial disclosures made by management reasonably portray the City's financial condition, results of operations and plans and long-term commitments. The Committee oversees the external audit coverage, reviews accounting policies and reviews financial statements.

## **Evaluation and Selection Process**

Advertising was done through the local media and posted on the City of Great Falls website. Members of the Audit Committee should collectedly possess technical expertise in accounting, auditing, and financial reporting to fulfill its duties. One application was received.

During the Audit Committee meeting on November 30, 2016, Committee members unanimously recommended appointing Ms. Kropp to the Audit Committee for the remainder of a three year term.
