# Suggested Motion:

**Background:** Debbie Goetze was appointed to the Regional Airport Authority Board in January of 2014 for a three year term. Ms. Goetze resigned from the Board effective September 18, 2016. Advertising for the vacancy began in September through the local media and the City's website. Three applications were received. The Airport Authority and the Airport Authority Board has decided not to make recommendations on appointing new Board Members. The City Commission conducted interviews of the three applicants during a special work session on December 20, 2016.

## <u>Purpose</u>

The Regional Airport Authority consists of seven members, four appointed by the City Commission and three appointed by the Cascade County Commission. The Authority serves as the governing and policy setting body for the operation and management of the Great Falls International Airport. Its duties include employing the Airport Director, who hires staff and oversees the day-to-day operations of the Great Falls International Airport.
