Staff Recommendation: It is recommended that the City Commission reappoint one member and appoint two new members to the Advisory Commission on International Relationships for three-year terms through March 31, 2019.

Background: Charity Jacobson and Sandra Erickson were appointed to the Commission in 2013 with terms expiring March 31, 2016; Ms. Erickson is asking to be reappointed for a second three-year term. Ruslan Soldyshev, Don Sims and Dean Koffler all resigned in 2015. At this time, three applications have been received for consideration for appointments.

Kay Silk has served on the Commission for two full terms and is not eligible to be reappointed. She is willing to continue serving until all vacancies are filled and she can be replaced by a qualified successor in accordance to Resolution 10059, Appointments to Boards and Commissions Policy.

Purpose

International programs are growing for many reasons. Rapid changes in communications technology, globalization of the marketplace, and political changes in the last decade have all contributed to an increasing awareness these trends will accelerate in the future. Communities, as well as individuals, businesses, and institutions will need to learn to participate in the "global"

village," or be left behind economically or in other ways. In order for the City to take a leadership role in nurturing and coordinating some of the international efforts, the Advisory Commission on International Relationships was created by Ordinance 2788 on November 8, 2000, and amended by Ordinance 2863 on October 21, 2003. The Commission provides support, coordination, and exchange of information for international programs in the community. The Commission consists of nine to eleven members.

Evaluation and Selection Process

Advertising has been done through the local media and on the City's website. The City will continue to advertise until all positions can be filled.
