Action Requested: Appoint one member to the Business Improvement District Board of

Trustees to fill a four-year term through June 30, 2020.

Suggested Motion:

1. Commissioner moves:

"I move that the City Commission appoint______to the Business Improvement District Board of Trustees to a four-year term expiring June 30, 2020."

2. Mayor requests a second to the motion, Commission discussion, public comment, and calls for the vote.

Staff Recommendation: It is recommended that the City Commission appoint Max Grebe for a four year term through June 30, 2020.

Background: Mauri Novak has served on the Business Improvement District Board of Trustees since July 2013 and is not interested in reappointment; therefore a new member must be appointed.

The current opening was advertised through the local media and on the City's website. The application deadline was July 29, 2016. Applications were received from Max Grebe, Bill Collins and Jim McCormick. Mr. McCormick has since asked that his application be withdrawn. Applications were forwarded to the BID Board for a recommendation.

Purpose

The Business Improvement District Board of Trustees consists of seven members appointed by the City Commission. Members must be owners of property within the boundaries of the Business Improvement District or their personal representative, agent, or guardian (MCA§7-12-1121). The B.I.D. oversees the functions, operations, management and administration as necessary to carry out the purposes and objectives of the Business Improvement District.
