## **Suggested Motion:**

### 1. Commissioner moves:

"I move that the City Commission (award/not award) a contract in the amount of \$63,988.00 to Central Excavation for the 10<sup>th</sup> Alley South / 5<sup>th</sup> Street South Sanitary Sewer Reroute, and authorize the City Manager to execute the construction contract documents."

2. Mayor requests a second to the motion, Commission discussion, public comment, and calls for the vote.

**Staff Recommendation:** Approve construction contract award.

**Summary:** This project was initiated to prevent sanitary sewage overflows (SSO)'s and to provide adequate and reliable sewer flow in order to protect the health and safety of the citizens of Great Falls. The project begins at the intersection of 5<sup>th</sup> Street South and 10<sup>th</sup> Alley South, and continues at points along 10<sup>th</sup> Alley South from 5<sup>th</sup> Street South to 3<sup>rd</sup> Street South.

### **Background:**

#### Citizen Participation:

The construction activity will require temporary closure of 5<sup>th</sup> Street South from 10<sup>th</sup> Avenue South to 9<sup>th</sup> Avenue South. The construction activity will require temporary closure of 10<sup>th</sup> Alley South from 5<sup>th</sup> Street South to 3<sup>rd</sup> Street South. Access to residences and businesses adjacent to construction zones will be maintained.

#### Workload Impacts:

Design phase engineering and plans and specifications were completed by the City Engineering staff with assistance from City Street division and Utilities. City Engineering staff will provide construction phase engineering services and project inspection.

### Purpose:

The primary objective of this project is to prevent SSO's by rerouting the shallow 9-inch VCP sanitary sewer main along 10<sup>th</sup> Alley south between 5<sup>th</sup> Street South and 3<sup>rd</sup> Street South into the deeper 9-inch VCP sanitary sewer main.

### Project Work Scope:

Work to be performed under this contract includes the following:

- Rerouting sanitary sewer flows in the shallow 9-inch VCP sanitary sewer main into the deeper 9-inch VCP sanitary sewer main.
- Removing the existing manhole on the shallow 9-inch VCP sanitary sewer main and installing a new sanitary sewer manhole with drop inlet on the deeper 9-inch VCP sanitary sewer main.
- Plugging and abandoning the shallow 9-inch VCP sanitary sewer main along 10<sup>th</sup>
   Alley South between 5<sup>th</sup> Street South and 3<sup>rd</sup> Street South.
- Rerouting approximately five service laterals located on the shallow sewer main to the deeper sewer main.

#### **Evaluation and Selection Process:**

The specifications were advertised two times in the Great Falls Tribune. Four bids were received on September 21, 2016 with the bids ranging between \$63,988.00 and \$149,509.00. Central Excavation submitted the low bid.

#### Conclusion:

City staff recommends awarding the contract to Central Excavation in the amount of \$63,988.00.

### **Fiscal Impact:**

The attached bid tabulation summarizes bids that were received. City sewer funding is programmed to fund this project.

#### **Alternatives:**

The City Commission could vote to deny award of the construction contract and re-bid or cancel the project.
