Staff Recommendation: It is recommended that the City Commission reappoint Travis Neil	

Staff Recommendation: It is recommended that the City Commission reappoint Travis Neil and Jason Madill to the Business Improvement District (BID) Board of Trustees to four-year terms expiring June 30, 2020.

Background: Travis Neil was appointed to the Board on December 18, 2012 to fill the remainder of a four year term. Jason Madill was appointed January 20, 2015 to fill the remainder of a four year term. Both Mr. Neil and Mr. Madill are seeking reappointment. Mauri Novak has served on the Board since July 2013 and is not interested in reappointment.

In accordance to Resolution 10059; In the case of a member eligible for and interested in reappointment, if the member is in good standing and it is the recommendation of the board/commission, his application shall be brought before the Commission for consideration for reappointment without advertising for other citizen interest. Although the positions were not advertised the City received applications from Max Grebe, Bill Collins, and Jim McCormack. These applications were forwarded to the BID Board for consideration.

This item was presented to the City Commission on July 5, 2016. Staff Recommendation on July 5, 2016 was to reappoint Mr. Neil and Mr. Madill and appoint a new member, Max Grebe to fill the vacancy left by Mr. Novak. After discussion Commissioner Houck asked that the item be tabled until she could receive additional information from the BID Board regarding their recommendations. During the BID Board meeting on July 14, 2016 the Board reviewed

questions proposed by Commissioner Houck and again recommended reappointment of Mr. Neil and Mr. Madill. The current opening to fill Mr. Novak's position has been advertised through the local media and on the City's website. The application deadline was July 29, 2016. Applications are being forwarded to the BID Board for a recommendation.

Purpose

The Business Improvement District Board of Trustees consists of seven members appointed by the City Commission. Members must be owners of property within the boundaries of the Business Improvement District or their personal representative, agent, or guardian (MCA§7-12-1121). The B.I.D. oversees the functions, operations, management and administration as necessary to carry out the purposes and objectives of the Business Improvement District.

Concurrences: At its June 9, 2016 meeting, the Board reviewed applications and the requests for reappointment. The Board recommended the reappointment of Travis Neil and Jason Madill. During its July 14, 2016 meeting, the Board reviewed questions posed by Commissioner Houck and confirmed their recommendation. The Board also agreed to advertise for the vacancy left by Mr. Novak.

Tracy,

The Board addressed your questions this morning at our board meeting and here is what was decided -

If the other candidates were considered? Yes

Did current candidates ask to be reappointed (vs feeling obligated to be reappointed)? Yes, Jason was present and noted that he wishes to continue to serve. Travis was not present this morning, but that has been his desire in the past. If any of your constituents in the BID district have any concerns over the appointment? The board noted that there have been no complaints.

If the BID board voted unanimously? Those that were able to vote, voted unanimously (Jason abstained when the motion was made to reappoint him and Travis abstained on the motion reappointing him).

Jason and Travis have both noted that they wish to continue to serve.

The board did not make any motion or recommendation today on the one opening that remains on the board as the City has noted they need to advertise for this position. Once the advertisement period is met the Board will discuss the applicants again at that time and make a recommendation to the City Commission for this opening. In the meantime, we will sit as a 6-member board unless Travis or Jason are not reappointed. It has been noted that the BID board now has two applicants to consider, at this time (pending the advertisement period). Bill Collins of Easter Seals Goodwill and Max Grebe of L'Heureux Page Werner both have applications on file with the City. Jim McCormack with the Rescue Mission has withdrawn his application.

Does this help to answer your questions? Are there any further questions you have at this time?

Krista, is there anything more you need from me, at this time? I'm assuming the reappointment should be on the Commission's agenda for 8/2/16? How long is the advertisement period for the opening? The BID Board meets next on 8/11 – would we have met the advertisement requirement by that date so the board can discuss the opening?
