# **PUBLIC HEARINGS**

# 10. RESOLUTION 10055, TO CREATE CITY-OWNED SPECIAL IMPROVEMENT RESIDENTIAL LIGHTING DISTRICT NO. 1309, STONE MEADOWS ADDITION, PHASE II.

Fiscal Services Director Melissa Kinzler reported that staff received a signed petition from Stone Meadows Inc. and Silver Stone Enterprises, developers of Stone Meadows Addition Phase II, requesting the creation of a street lighting district. Resolution 10054, the resolution of intention to create the district, was adopted by the City Commission on February 3, 2015.

Staff mailed letters regarding the City's intention to create City Owned Special Improvement Residential Lighting District No. 1309 along with a copy of the published legal notice and

outlined the protest procedures to each person, firm or corporation, or a known agent having property located within the boundaries of the proposed district. During the 15 day protest period, no protest letters were received by the City regarding the creation of Special Improvement Lighting District No. 1309.

The estimated annual assessment for construction will be \$104.02, and the ongoing estimated annual maintenance assessment will be \$99.20 for an average sized lot.

Mayor Winters declared the public hearing open.

No one spoke in support of Resolution 10055.

Speaking in opposition to Resolution 10055 was:

**Ron Gessaman**, 1006 36<sup>th</sup> Avenue NE, disagreed that the proposed fixtures are night sky friendly.

City Manager Doyon reported that he will be reviewing the resolution that created the City's street light policy, and recommending that it be amended or repealed. He questioned whether the City needed to continue providing this service. There are options for developers through NorthWestern Energy.

There being no further comments, Mayor Winters closed the public hearing and asked the will of the Commission.

Commissioner Jones moved, seconded by Commissioner Bronson, that the City Commission adopt Resolution 10055.

Mayor Winters asked if there was any discussion amongst the Commissioners.

Commissioner Burow commented that NorthWestern Energy is in this business. He doesn't believe the City needs to be in this business any longer.

There being no further comments, Mayor Winters called for the vote.

Motion carried 3-1 (Commissioner Burow dissenting).

# 11. WEST BANK PARK URBAN RENEWAL DISTRICT TAX INCREMENT FINANCING (TIF) FUNDS FOR WEST BANK PARK.

Planning and Community Development Director Craig Raymond reported that this item is a request to approve the use of Tax Increment Financing (TIF) funds from the Westbank Urban Renewal District.

In 2007, the City of Great Falls adopted the West Bank Urban Renewal and Tax Increment Financing District Plan. The West Bank TIF District encompasses property on the west bank of the Missouri River north and south of Central Avenue West between 3<sup>rd</sup> Street NW/SW and the Missouri River. West Bank Park, a City-owned recreation and open space facility, is within the West Bank TIF District, and has a recently adopted Master Plan to guide improvements within the park.

On December 29, 2014, the Park & Recreation Department made formal application for TIF funds to augment a number of grants that have been received for West Bank Park improvements to implement elements of the Master Plan. TIF participation requests must be determined to be in compliance with and follow the recommendations of the Urban Renewal Plan, as well as be determined eligible for TIF participation in accordance with the Montana Code Annotated. Staff determined the work is eligible and appropriate, and that there is adequate funding in the TIF to fund the project.

On February 10, 2015, the Planning Advisory Board voted unanimously to recommend to the City Commission that the City authorize the projects and improvements and associated funding from the West Bank Urban Renewal TIF District.

Commissioner Bronson moved, seconded by Commissioner Jones, that the City Commission approve the use of up to \$460,000 in West Bank Urban Renewal TIF District funding for improvements to West Bank Park.

Mayor Winters asked if there was any discussion amongst the Commissioners. Hearing none, Mayor Winters asked if there were any comments from the public.

**Ron Gessaman**, 1006 36<sup>th</sup> Avenue NE, commented he was in favor of this expenditure. He hopes the proposed park restroom will be open to the public and won't be locked.

**Jana Cooper**, TD&H, 1800 River Drive North, supports the project and commented this is a great use of public funds.

There being no further comments, Mayor Winters called for the vote.

Motion carried 4-0.
