CALL TO ORDER: 4:00 p.m.

1. LITIGATION STRATEGY – NEW WORLD SOFTWARE SYSTEMS.

City Manager Greg Doyon provided a brief history of software issues with New World. The purpose of this meeting is to update the Commission on the City's efforts to resolve performance issues with New World and then Tyler Technologies that bought out New World.

City Attorney Sara Sexe reported that this meeting is to discuss litigation strategy regarding the contracts with New World Software Systems and Tyler Technologies. She recommended the City Commission enter into an executive session pursuant to Mont. Code Ann. § 2-3-203(4)(a) because the meeting involves the discussion of litigation strategy and an open meeting would have a detrimental effect on the litigation position of the City.

Commissioner Burow moved, seconded by Commissioner Jones, that the City Commission close the meeting to discuss litigation strategy in executive session.

Motion carried 5-0.
