EMS ADMINISTRATOR FORUM

CHIEF MCCAMLEY

To date the EMS system has been doing well in coping with the extreme weather that we have experienced in the last couple of months.

EMERGENCY MEDICAL DISPATCH (EMD)

RON SCOTT

DISCUSSION	EMS Medical Directors and the City Attorney have completed the revisions to the
	EMD cards. Ron Scott received printing quotes from different printing
	businesses. Because Pam Johnstone retired, the panel offered a brief overview of
	what work and coordination had been done to facilitate the implementation of

EMD. Also questions from Captain Lockerby and Chief Grove regarding the process and development of EMD were answered.

Discussion continues on the many aspects of EMD implementation. Topics were as follows; when to begin training; training duration and complexity; EMD implementation date. Also discussed were the possibility of adding more advanced EMD in the future and who would be the point of contact to answer dispatcher's questions especially when first introduced and put into operation. The committee discussed the consequences of EMD for County EMS calls.

CONCLUSIONS

Committee instructed staff to have EMD cards professionally printed; to begin training in January 2011 and to be fully implemented by February 2011. Training will begin with dispatch supervisors. A specific lesson plan shall include learning objectives and training CCCDC staff in context.

Contact Vince Kohler, County DES Coordinator and apprise him of the City's EMD implementation. He shall be coordinated with so that he can keep County EMS participates informed of the EMD process in hopes that they will also be involved in the process in the future.

Motion to print EMD cards and begin training development by Dirk Johnson and was seconded by Scott Schandelson. All were in favor, motion accepted.

LIFE SAVE RATIO CHIEF MCCAMLEY

DISCUSSION

The EMS administrator questioned, "How is the EMS System's performance being measure. In order to measure success in the EMS system the Committee must first determine a definitive life save ratio or positive response to EMS intervention? Also the committee must determine what can the system use as a definition and what shall be measured to distinguish the system's success at providing EMS/ALS service to it's' customer.

Since the definition of life saved is too convoluted the committee decided to try and measure smaller components of EMS. For example, airway management shall be measured in much the way it is through the QI process. According to the members of the committee the simple question to be answered may be, Was the patient's airway properly managed. This standard would be the system protocols with input form the Hospital Trauma Coordinator Lauri Jackson.

CONCLUSIONS

The EMS coordinator, GFES manager, and Hospital Trauma coordinator will develop parameters and compile statistics on certain EMS interventions on a quarterly basis. The system will begin with "airway management".
