# **OLD BUSINESS**

## MIVT

- May need to revisit the MIVT with changes with Benefis staff.
- GFC still prefers the radio report format, they are easy for staff to follow
- Virts and Grohs randomly review reports to ensure compliance with the radio reporting.

## **NEW BUSINESS**

- Great Falls Hospital ER Diversions
  - Dispatch will continue to notify crews of GFC Hosp of diversions.
  - Cannot take same volume as Benefis
  - o Justin has confirmed via email he will speak to crews regarding misconceptions
  - o Jones requested to be included in communication as City EMS Administrator
- City Ordinance
  - 9/5/23 an overview of EMS system in Great Falls was discussed during a Commission meeting.
  - o Will be discussed in Work Session tonight, going through changes line by line.

- The current MOU is going to expire that allows BLS ambulances in the system.
  The recommendation is to adopt
- Priority Proximity Dispatch
  - Discussion is ongoing.
  - o AVL Pings on GPS and dispatch can see units. Though AVL is not 100% accurate.
  - GFFR is looking at field ops system that could populate units they can provide and allow for the closest, appropriate unit to be dispatched.
  - Process is paused until new IT Director position is filled (still is not filled)
  - o Recommendations to Dispatch would have to be built out.
  - o Bozeman is the closest municipality that utilizes this system.
  - The overall goal is to improve response time and reduce errors.

#### Narcan

o Trucks are stocked and training is complete with crews. No reports on it.

## GFC Hospital

- Active Shooter exercise in early December.
- Expansion
  - Kendra Pucket oversees operations out of patient clinics and mentors
    Emergency Department.
