AUSTIN HALL FIRE ALARM SYSTEM

AUSTIN HALL CARPET REPLACEMENT

The hallway carpet on the upper three floors at Austin Hall is being replaced after 20 years of wear and tear.

Staff has been contacting contractors who might be interested in giving proposals for the work and anxiously waiting for the weather to break to request proposals.

FILE CABINET

The Housing Authority Office has an inoperable and discontinued 3 drawer file cabinet that we were going to throw away. A Staff member asked if they could have the cabinet. The Staff member thinks her husband might or might not be able to repair it to make it operable. Staff is asking you to determine this of no value and to allow the Housing Authority to give the file cabinet to the Staff member for their own use.
