# **Minutes**

This motion was seconded by Mandy Brumwell, and The Mansfield Center for the Performing Arts Advisory Board unanimously approved the recommendation of Shannon be sent to the City of Great Falls Commission for approval.

New City Church has been using the Mansfield Theater as their sanctuary for the last few months, and continue to do so at least through May. This ongoing rental has helped our budget dramatically.

The Tavern Association has sold alcohol during Menopause. They unfortunately lost money, after labor and supplies. They did take were willing to absorb the loss and try another concert. With that, they are still planning to come back for GFCCA: Abba-Fab and GFS: Gold Rush. Grant inquired about sale start time, and if they would be set up and open before the house doors are open. Grant informed the meeting that there will be no intermission for Gold Rush. Mandy feels without an intermission, there should not be a bar on the second floor. This will help with costs to the bar.
