## Neighborhood Council #1 Meeting Minutes 11 April 2017

Call to Order: Meeting was called to order at 7PM. The meeting was held at the Meadowlark School Library.

**New Business:** 

Jim Reardon and Kenny Jorgensen from the city public works department briefed the attendees on plans to repair Encino Drive. Mr Reardon noted the poor quality of the original development of that area. At that time the developer was allowed to do his own inspection of the work. That policy has been revised so that the city now does the inspection of construction projects. The city will accomplish some repair but the major portion of needed repairs will be done by a concrete contractor at the end of the Summer. Mr. Reardon was invited back to next month's meeting to give an update.
