Community Policing: Officer Donny Gerhart provided a report on neighborhood crimes. Residential and Commercial burglaries were up which is of concern. His report included the following statistics:

Abandon vehicles: 11; Accident - injury: 6; Accident - no injuries: 24; Assault: 6; Auto theft: 4; Burglary Commercial: 3; Burglary Residential: 5; DUI: 2; Narcotics: 4; Robbery: 1; Suspicious: 37; Theft: 139 (primarily due to Walmart); Traffic speeding: 116; Vandalism: 12; Wanted: 18. The DET Team is proactively enforcing speed around schools and 10th Avenue South. Crime has increased in the City due to increased Meth use.
