Community Collaboration is imperative to achieve community health. The City-County Health Department works closely with dozens of public organizations and private businesses to continue to move us toward our vision of “Healthy People in a Safe and Healthy Community.”

In 2017, community partnerships helped immunize more of the public through new school flu shot clinics and an increased number of business flu shot clinics. More inspections were completed at local businesses to ensure safety for all of Cascade County, and the number of children served in the Foster Child Health Program in 2017 increased by 250 children since 2016.

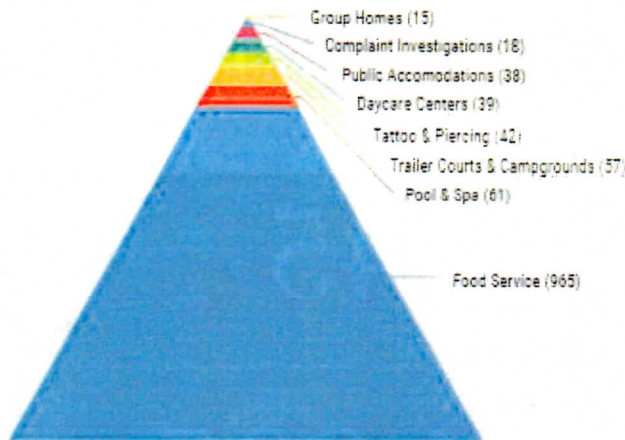
2017 CCHD's Foster Child Health Program

Served more than twice as many children as the previous year. 459 children were served during 2017.

In 2017...

- 121 families enrolled in PAT (*110 were "high need")
- 1,344 personal visits took place
- 92% of children were fully immunized

Development and Improvement Opportunities

CCHD recognized the high rate of non-compliance to have a Certified Food Protection Manager (CFPM) at establishments that are required to have one. CFPM pass rates in Cascade County were as low as 70%. Factors contributing to the non-compliance included the high cost of the class, inconsistent class schedules, and the exam questions not reflecting the class material.

To assist local establishments, CCHD determined it would conduct a Food Safety Class of its own that is accepted by the Food Code. Two CCHD Sanitarians are registered as proctors to conduct local classes that are lower in cost and demonstrate a higher pass rate among participants.

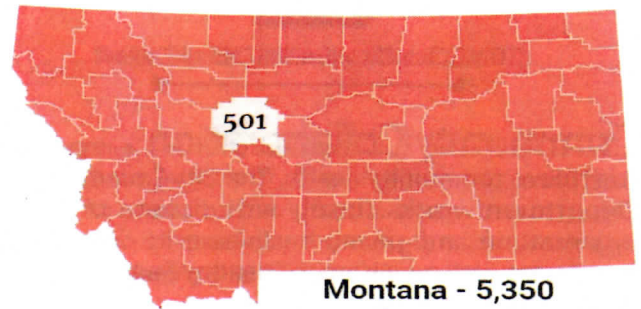
During June through November of 2017, CCHD was pleased to see the classes they proctored had a pass rate of 92%. Data collected this next year will determine if the increased CFPM's will help reduce the violations of foodborne illness risk factors.



Rise in Sexually Transmitted Diseases

For the past three years, sexually transmitted diseases (STD's) have been on the rise nationally, and Cascade County is no exception. When left untreated these infections can lead to severe medical conditions including infertility, internal organ damage, and even death. In Montana there were 5,350 STDs reported in 2017, and 501 in Cascade County.

Chlamydia is the most common reportable disease in the United States, Montana, and Cascade County, and comprises the largest portion of all STDs reported. The rates of chlamydia in Cascade County have slowly been rising over the last three years, in 2017 there were 439 cases reported.

Syphilis and gonorrhea have also been rising in Montana. During 2017, 60 cases of gonorrhea were reported in Cascade County and two cases of syphilis. The number of syphilis cases in Cascade County has not risen above two cases per year. Statewide, there has been over a 300% increase in the number of syphilis cases over the past few years.

Influenza

For the 2017 flu season, CCHD offered the high dose vaccine and made it the standard of care for individuals 65 and older. The high dose vaccine is associated with a stronger immune response and was developed for those over the age of 65.

CCHD increased the number of influenza shots given in 2017 compared to 2015 and 2016. This is believed to be a result of increased advertisement efforts, outreach to community businesses and increased use of social media for promotion and education purposes.

CCHD provided 4,235 flu shots to the community during 2017
