

**NEIGHBORHOOD COUNCIL #6 MEETING – Sunnyside School Library  
September 5, 2019**

**COUNCIL MEMBERS PRESENT:** Julie Parker, Joe Moll, Allison Tangen, Cherry Loney

Also attending were Greg Doyon, City Manager; Krista Artis, City Manager's Office; Rick Tryon; and 9 neighbors.

**OLD BUSINESS:** Minutes of the May 1, 2019 meeting were approved as written.

**NEW BUSINESS:**

**Special Event Permits:** Krista Artis provided an overview of the process for applying for/approving city events. She distributed a copy of the *Special Event and Street Closure Application* form. Andrea Huttinger, 1800 11<sup>th</sup> Ave. So., had several questions about the process, particularly related to an outside event recently held by the Crown Casino. She complained about excess noise to the point she could not hear her own television inside her home. Music began at 11 am and lasted till 10 pm. When she called GFPD, she was told the casino had a permit and GFPD could take no action. Mr. Doyon reviewed the city code. Since noise levels exceeded the allowable decibels, there likely was a code violation. He will follow up with GFPD to ensure they are aware of requirements and can exercise discretion. The code also needs to be reviewed to ensure it fits various concerts and their locations throughout the city. It may need to be tweaked. Future permits can also include stipulations in view of past problems.

**Rick Tryon, City Commission Candidate:** Rick Tryon provided an overview of his candidacy for City Commissioner, why he is running, and what he hopes to accomplish.

**NEIGHBORHOOD CONCERNS:**

Carolyn Craven, 101 14<sup>th</sup> Ave. So, mentioned the Cascade County Zoning Board will hold a public meeting on September 10 at the Family Living Center and will vote on whether to accept recommendations on approval of the cheese plant east of town. She invited those present to attend.

Andrea Huttinger. 1800 11<sup>th</sup> Ave. So., expressed concern about potential traffic flow problems with the True Brew Coffee Shop planned near her. Mr. Doyon said he would ask about plans submitted to City personnel and follow up with council members.

Cherry Loney mentioned there are discarded mattresses and furniture in the alley between 13<sup>th</sup> and 14<sup>th</sup> St. So. A neighbor complained about the same thing about a year ago. The problem was mitigated but discarded items are beginning to appear again. Mr. Doyon will call Public Works/Sanitation and ask them to investigate.

Cherry Loney reported the council had a great time doing MApril Cleanup with children/grandchildren. Neighborworks included a picture of our "team" in their newsletter.

Sue Johnson, 2212 3A Street complained about the school bus speeding on her street. The council advised her to call GFPS.

The council thanked Mr. Doyon for attending and expressed their appreciation for his help in responding to neighborhood concerns. The meeting adjourned at 8:20 pm
