Downtown Development Partnership: Linda reported that Kellie Pierce is the new Chair of the DDP, the TIF (tax increment funding) request for lighting in the alleyways with murals has been approved by the City Commission, ArtsFest was very successful, the GFDA is working on economic vitality, especially on increasing residency in the downtown district, and is exploring the idea of eliminating the one-way traffic on 5<sup>th</sup> and 6<sup>th</sup> Streets. OctoberFest is the next event coming up.

Brownfield Committee: Trevor had no report.

Downtown Safety Alliance: Sandy noted that Kellie Pierce, new Chair of the DDP, hopes to resume DSA meetings in October.

Council of Councils is scheduled for the quarterly meeting on October 25, 2022.

Strategic Planning and Outreach: Troy said that the NextDoor app is good for keeping up with what's happening within council boundaries. Troy and Sandy attended the Block Party hosted by Triumph Lutheran Brethren Church and gave out Guide to Great Falls Code pamphlets. Sandy will attend the ground breaking for the 45<sup>th</sup> NeighborWorks High School house on 9/13 and will hand out the Guide to Code pamphlets as well as give a short speech to attendees about N C 7. Crime Mapping Report: monthly statistics were reviewed by Lisa.

Representatives from the Cascade County Attorneys' Office and the Cascade County Sheriff's Department presented information on the Safety Levy which will be on the November ballot. Westandsafe.com is a website supporting the levy.
