CALL TO ORDER

OLD BUSINESS

 - Member Fred Fairhurst motioned to approve the November 2022 meeting minutes. The Council unanimously approved.

- Rodney Meyers Possible GFPS Board candidate
 - Rodney Meyers asked questions from the Neighborhood Council about how they feel the School Board is doing. Rodney Meyers then brought up how the students are deficient in math, science, and reading. Great Falls students are about even with state standards but below nationwide standards. Rodney Meyers will decide about running for the board in a couple of months. Federal government now only looks at graduation rates and not proficiency.

• Vice Chair Tim Croft reports according to crime mapping, we have had 5 incidents. 1 car theft, 1 disorderly conduct, 3 assaults, 2 criminal mischiefs. Vice Chair Croft has been in contact with the Russell Country Drug Task Force who had a busy month. They had 2 search warrants they addressed, 1 on the lower south side and 1 on the west side. On the west side they seized 8 pounds of marijuana value of 30-35 thousand.

If we use something like a bouncy house we would need to work with Parks and Works for placement. Strobles has insurance on file for bouncy house. Vendors are usually charged for the permit. Last Neighborhood Council event vendors where not charged for permit. Lanni Klasner will verify and get back to the Council about vendors being charged permits. Vice Chair Croft will check with the Little Shell Tribe on using their marquee. Fire Department will provide a truck for the event.

- Member Fred Fairhurst went through the 2022 Code Enforcement Cases for Neighborhood Council 2 to see if there is a trend. The neighborhood had 31 cases, many which were unfounded. Junk vehicles and vehicles on property seems to be dominating.
