 - The request was presented by the contractor. Clarification was presented with a dialogue between the contractor, the city planning commission members and neighborhood citizens.
 - A motion for support was requested. Motion to do so carried 4/0

PETITIONS AND COMMUNICATIONS

- A question was raised regarding the tax share and contributions of Calumet Biofuels from its past subsidized status. This was discussed and advised to refer further queries to the Council of Councils as well as to Neighborhood Council 3.
- The police activity report for December was submitted. The council will continue to look at emerging longitudinal trends.
- A question was raised over emergency traffic situations in the neighborhood.
- A question regarding parking on some streets was discussed.
- The need for a clearer set of markings, possibly a blinker, for crosswalks on 9th Street South to the Benefis facility from their parking lot across the street was discussed and referred to city traffic control.
- A concern was raised about the inability to procure a copy of the by-laws of the Water & Sewer District. This was referred to Terry Thompson as a source.
