- Summer Celebration Kathleen Gessaman has requested two boxes of popcorn be donated for the Summer Celebration by Ace Hardware. She has not heard back from them yet. Garri Mauch said the Great Falls Public Library Bookmobile, Great Falls Fire-Rescue, and EMS were confirmed for the event. She said she has not confirmed that a garbage truck will attend the event. NeighborWorks Great Falls will provide \$500 to pay for the Frosty ice cream truck. Kathy Gessaman and Eric Peterson each donated \$30 to help with expenses. Crane Chiropractic will sponsor the Bouncy House, Gary Fosse of State Farm Insurance will sponsor Joe Ryan Acoustics, and there is a request to sponsor the face painter. Eric Peterson will pick up the Bouncy House from Strobels Rentals at 11 a.m. on August 23. He will write a media release and distribute it to The Electron, KRTV and KFBB, and The Great Falls Gazette. Garri Mauch said that when the Bouncy House is picked up it will be rented under the City of Great Falls name and covered by their insurance.
