The meeting was called to order at 6:30 PM followed by the Pledge of Allegiance.

A quorum was established.

## **OLD BUSINESS:**

Minutes of September 3, 2025, were approved.

## **NEW BUSINESS:**

- Lanni Klasner gave a presentation regarding Calumet Montana and Montana Renewables
  - o Explanation of the two separate businesses and their mission
  - Information about the tax situation and monies held in escrow
  - Fielded questions regarding
    - Safety and security of the facilities
    - Traffic Issues
    - Expansion
    - Future of Westgate mall/facility
- Gretchen Yow addressed the upcoming election and several of those issues
  - o All Mail-in Ballot
  - For election: Mayor, 2 Commissioners, Retention of a judge, Ballot Issue regarding fireworks
  - Only Neighborhood Council 3 has more candidates than offices, so they will be on a ballot. All other councils have unchallenged slates of candidates, so they will be seated.
  - Deadlines were shared
  - Final election for any write-in candidates
  - New requirement on returning envelope for the birth year of the voter.
- Dan Palugi and Austin Schultz were present to address concerns and issues raised at previous meetings regarding roads and traffic. In particular:
  - Information about the KB housing project
  - Various driving blind spots. Referred to Jim Wideger
  - Crosswalk signs and protections
  - 4<sup>th</sup> and 17<sup>th</sup> Dentist congested parking.

- o 13<sup>th</sup> street parking with emphasis on winter hazards
- o Road clutter in the Sunnyside area, in particular RVs and boats.
- Citizen attendee Judi Austin raised concerns about dangerous drivers on 17<sup>th</sup> in the presence of many children
- o Request for a speed monitor. Enforcement was difficult.

## OTHER BUSINESS

- It was brought to the attention of the council and Robert Moccasin the graffiti on the alley garbage cans. The inquiry led to a discussion about the history and presence of Neighborhood Watch.
- The September police activity report was presented with comparisons over an 18-month period. The recommendation was to address this with a police representative after a full 24-month accumulation of data was completed.
- It was commented that the faculty room of Sunnyside was a more conducive environment for the meeting and that the president inquire whether that could be a permanent change.
- The next meeting will be held on November 5, 2025, at 6:30 at the Sunnyside Elementary School.
