 - o Chair Tim Croft reports that the old Jack Club sign by the K-Heart Veterinary Clinic is finally torn down.
- Homeless to Housing Hub (HHH)
 - 5:31 pm Sheila Rice from Homeless to Housing Hub gave a report on a group of agencies that is working on a project called Homeless to Housed Hub (HHH). They deal with the homeless every day and what they are

trying to do is provide homes. Average length of stay on the list is 6 months. There is a reduction of law enforcement encounters and emergency room visits when homeless have permanent housing surrounded with services they require. - West Great Falls Flood Control and Drainage District
 - o 5:40 pm Commissioner Fred Fairhurst from West Great Falls Flood Control and Drainage District reports that the Highway Dept will installed a camera that looks under the 6th ST SW bridge. The homeless have started to drift back in after the Highway Dept cleaned it out. The camera will transmit images to both the Office of the MT Highway Dept and to the Superintendent's phone. If there is movement under the bridge they will get a notification and law enforcement will be notified.
