Old Business

Minutes of previous meeting were read and approved.

The traffic problem with the suggestion of opening 20th Street and parking problem in the parking lot were discussed. Questions about the possibility of building a cafeteria with an atrium between the two school buildings, also there were questions on the possibility of a new ventilation system and the need for natural lighting in the Library and Study Hall was suggested.

It was stated to come up with a Master Plan and then take it to the School Board with the issues discussed.

Eric Aldrich was here on the Shannon Holland issue of 5 dogs and 2 cats .This matter was tabled to a later date.

Jerry McKinley waiting for answers traffic issue on 4th Ave South to 25th St. He was instructed traffic on 4th Ave S. was within constant laws for Montana. The traffic on 23rd Street is a problem. It was suggested crosswalks be implemented and larger stop signs installed as a solution to this problem. Patty Cadwell will send a copy to all council members from Jerry McKinley.

New Business

Patty C. brought up the Bylaw - Section 7A – Removal of Officer. Patty stated we have no power over council members. Joe Moll made a motion to remove Section 7A bylaw. Margaret S. 2nd motion. The motion carried by majority vote.

Gary suggested we get the planning for Mapril Cleanup started in February Meeting.

Student Input

Students complained of parking issues in the senior parking lot. People are parking in inappropriate places. Gary S. suggested to Joe L. send an email to SRO to take up parking regulations with students.

Also a student stated the ventilation system needs repair in the Library and Study Halls.

The issue discussed of cost parking area at Great Falls High School is \$ 2,500 for parking lot versus \$25,000 to build a building. There are students on the Task Force and Gary S. & Joe L. suggested the students with the complaints contact the Task Force on all parking issues.

When students were questioned about the littering and smoking issues it was stated they seem to be going away.
