### **NEW BUSINESS:**

Jeff Key, the Traffic Engineer from Robert Peccia & Associates, gave an update on the City of Great Falls Transportation Plan. Updating the transportation plan is a mandatory requirement for cities of our size (greater than 50,000 residents) to obtain federal transportation funds. The plan is required to be updated every four years. During some cycles the plan is updated by City staff, however this time it has been contracted for completion. The last year a contractor completed the update was in 2003. There are five months remaining in the schedule to complete this process. A final document will be provided and adopted prior to the upcoming Federal funding cycle. The 2<sup>nd</sup> Public Informational Meeting is scheduled for Monday, October 28<sup>th</sup> at 6:00pm. It will be held at the Missouri Room of the Mansfield Convention Center.
