## **The Planning/Community Development Department:**

• The Planning/Community Development Dept. gave a very informative update of the ongoing commercial projects within the city, as well as other business the department oversees, such as, the New Growth Policy, Transportation, Development Trends, Flood Insurance, and Historic Preservation. • Kathy Mora, Library Director, also gave a very informative presentation on the "Little Free Library" project that is being co-sponsored by Neighborhood Councils and the Park and Rec. Dept. Last fall, the library received a grant to offset the cost of this project, so there will be no cost to the city or to the residents. The boxes will be stocked with excess inventory the library has, and will be large enough to hold 15-20 books for adults and children.
