CALL TO ORDER: The meeting was called to order at 7:00 by Eric Ray with the pledge of allegiance.

ROLL CALL: Terry Albrecht, Eric Ray, Gloria Bedker, and Marcia Anderson along with 11 neighbors including Jim Adkins from CERT. Mac McFadden was absent.

NEW BUSINESS: Jim Adkins from the Community Emergency Response Team (CERT) gave a report on the history and origins of CERT. They offer a class once a year for training. Cert offers first aid at various events around the county and works with local police and fire departments. They have trained 150 to 160 people with about 50 of them being responders, 20 of those are regulars.

This year's class will be held Apr 29, 30 and May 1 at the Cascade County DES Office, 521 1st Ave NW. Registration is open to everyone over the age of 18. Over the next several months a GFPD volunteer will be assigned to our council. This person will attend all council meetings to act as a more constant channel of communication between the Council and the GFPD.
