Described Community Policing and Community Activity in Neighborhood Council 2

Described DDACTS traffic and officer policing but encouraged neighbors to be involved.

Traffic and theft are top crime happenings, but suspicious activity was talked about. Neighborhood Council has the lowest number of suspious activities calls, could be due low vandalism rates in neighborhood. Assaults aggravated or Misdemeanor could not access numbers. Most accidents happened on Central West. 3rd Street NW is in the top 20 for accidents. DUI calls are low only 3.

Narcotics calls are low.

Community questions about DUI(Mr. Melhoff) Meth Arrests and trespass (Sandy) Meth has gone down because Psedoufed can not be bought on shelves. Great Falls has policing activities through the Drug Corridors. Dispatch has a triage for crimes such as trespass. People are given a case number.

Vice Chair Manzer represented the Turf Club and described Turf Club activities and budget.

Vonnie Brown Democratic candidate for Senate District 11

Ms. Brown is a social worker. She is passionate about mental health care, education as well as Medicaid expansion. Ms. Brown differs with Senator Ed Buttrey with jobs and conservation. She volunteers for the Red Cross.

Robert "Bob" Melhoff Democratic candidate For House District 22

Bob has served on House Appropriations for 3 terms. Representative Melhoff talked about ADF, Great Falls College MSU welding. He successfully was able to appropriate funds for .He also spoke about the school funding bill. He has previously served on Neighborhood Council 2.

Jim Larson Republican Candidate for Cascade County Commissioner

Farms and ranches South of Belt. Ran against Bill Salina and lost. A county commissioner administers laws sent from State of Montana

Roads zoning, bridges, and the fairgrounds. It has been 18 years since Cascade County elected a rural commissioner. The 10 year local government study was discussed.

Eric Bailey Candidate for Justice of the Peace He has serves as deputy sheriff and coroner for 12 years. He hopes to work with 1st and 2nd time offenders. The Justice court handles both civil and criminal cases up \$12,000. Judges have to utilize common sense and the law and its process for good sentences. District courts handle treatment court. A JP needs no legal background, but Mr. Bailey recognizes the need for legal experience
